Dear Mayor and Council,

I would like to provide an update on staff's follow-up on Council's motion from May 2016 (<http://council.vancouver.ca/20160503/documents/motionb5.pdf>) regarding the Punjabi Market area (Main and 49th Ave.) and whether area planning is needed.

Staff have been gaining input from several key stakeholders to better understand current issues and opportunities pertaining to the area. Through these initial discussions, we recognize a range of issues need to be considered including economic vitality, heritage, culture, land-use, public realm and connectivity to the adjacent arterial (49th Ave.) and uses (Langara College, church site) and Cambie Corridor Phase 3 planning and engagement.

We are preparing a report to Council outlining issues, options for follow-up and resource implications. While we had intended to get this report to Council before the summer break,

our planning team has been fully committed on a number of Council priorities. Therefore, we will bring forward the report following the summer break, targeting September.
