- SUBJECT: Update: Roddan Lodge Tenant Relocation

The Roddan Lodge facility is a senior's housing complex containing 156 Single room Occupant (SRO) units (18 are double rooms), which primarily houses low income Chinese seniors.

This six storey concrete facility, located at 124 Dunlevy Avenue was constructed in 1976/1977 and is owned by the City of Vancouver Public Housing Corporation. The building needs to be redeveloped to a state of good repair and is planned for rezoning and redevelopment in 2017. As such, all tenants need to be temporarily relocated.

On Friday September 23, 2016, at 4pm City Staff are hosting an "All Tenants" meeting to discuss plans for the building and to consult about tenant relocation. All correspondence to date with the tenants has been provided in English, Mandarin and Cantonese. For the meeting, Mandarin and Cantonese speaking City staff will attend to help facilitate discussions and answer questions and the script below will be used as a guide. Community Advocates from ATIRA have been invited to attend as they have been closely involved with the tenants needs.

## Key Messages:

• Roddan Lodge needs to be replaced as it is was of sub-standard quality construction in 1977 - with a subsequent history of ongoing plumbing repairs, roof leaks and building



envelope issues. Maintenance and operational costs are increasing with building deterioration, including ongoing measures to address air quality, and energy costs associated with the poor envelope. Housing units are not up to today's standards and policy is to replace SRO units with self-contained units as opportunity arises.

- We are committed to working with all of the tenants to find housing and providing them with the necessary relocation supports.
- Tenants will be individually evaluated and provided with affordable relocation options with Rents Geared to Income with tenant paying no more than 30 per cent of their income.
- Tenant have the first right of refusal to move back into the new building at rents that will be affordable to them.
- We are actively engaging with senior government to secure more social and supportive housing and to improve and replace existing stock.
- The City is committed to ending street homelessness in Vancouver and has dedicated \$85 million from the Capital Plan to enable the creation of 2,550 new supportive and social housing units.
