Dear Mayor and Council,

Following the Living Wage discussion at Council on September 21st, I am writing to provide you with some additional information on the certifying organization, "Living Wage for Families Campaign" (LWFC) and the process by which the living wage figure is derived.

LWFC is a community organization advocating for living wage in British Columbia and is one of several similar organizations across Canada comprising the Living Wage Canada network. LWFC calculates the living wage for British Columbia and certifies employers across BC.

Living Wage Canada supports the national living-wage movement through facilitated learning and information-sharing. It has developed the Canadian Living Wage Framework which provides a consistent living wage definition and calculation methodology, along with a strategy for recognizing corporate and community leadership for organization which commit to passing a living wage policy.

LWFC was formally launched in 2008 and was sponsored and facilitated by the Canadian Centre for Policy Alternatives, an independent, non-partisan research institute concerned with issues of social

and economic justice, and First Call: BC Child and Youth Advocacy Coalition, a cross-sectoral, non-partisan coalition made up of over 80 provincial and regional organizations that advocates for the well-being of children and youth.

The living wage rate varies across Canada and is calculated regionally to reflect the cost of living in each community. LWFC determines the living wage for regions across British Columbia through an annual review process, typically conducted between February and April. The sources of information reviewed and analyzed to determine the new rate is obtained through many organizations, including Canada Mortgage and Housing Corporation, Canada Revenue Agency and Provincial Health Services Authority. A more detailed calculation guide can be found through the website links below.

In general, the calculation of the living wage rate incorporates the elements outlined below:

Stage 1: Calculating Family Expenses;

Stage 2: Calculating Government Transfers: Canada Child Tax Benefit, Universal Child Care Benefit, GST credits, BC Low Income Climate Action Tax, etc.;

Stage 3: Calculating Government Deductions and Taxes;

Stage 4: Determining the Living Wage Amount;

Stage 5: Calculating the BC Child Care Subsidy; and

Stage 6: Verifying the Calculations.
