At the November 1st, 2016 Regular City of Vancouver (COV) Council Meeting, a request was made by Councilor De Genova for information "...regarding enforcement measures used in regard to cyclists that fail to obey traffic laws, such as not stopping at stop signs, and numbers of tickets being issued. Also include info regarding jaywalking and motor vehicle infractions."

With the assistance of the Vancouver Police Department (VPD) Traffic Analyst and the VPD's Collision Investigation Unit, statistics were gathered from the entire 2015 calendar year and 2016 Year to Date (YTD): January 1st to October 31st. Included within the statistics gathered are Provincial Violation Tickets as well as COV By-Law tickets issued by VPD members.

To address the request made by Councilor De Genova, enforcement measures are presented in three categories: Cyclist Enforcement, Pedestrian Enforcement and Motor Vehicle Enforcement.

Cyclist Enforcement:

Globally, with 858 tickets issued to cyclists in 2015, enforcement patterns are relatively consistent in 2016: with 787 tickets issued YTD. The majority of tickets issued to cyclists were related to "no helmet" offences. It is worth noting that collisions involving cyclists totaled 252 in 2015 and are 241 YTD in 2016. The enforcement of helmet laws is conducted in an effort to improve safety and reduce serious head injuries for cyclists should they become involved in a collision. "Riding on the sidewalk" is also an enforcement focus, but is a distant second to "no helmet" enforcement. Cyclist enforcement related to disobeying stop signs is minimal: 5 tickets issued in 2015 and 2 YTD in 2016.

Pedestrian Enforcement:

With 402 tickets issued to pedestrians in 2015, enforcement frequency has increased somewhat with 640 tickets issued YTD in 2016. The primary driver for this increase relates to enforcement against pedestrian's who disobey traffic control signals. The focus on pedestrian compliance with traffic control signals is another attempt on the VPD's part to improve Traffic Safety and reduce fatalities involving pedestrians. In 2015 there were 387 collisions involving pedestrians, 10 of which were fatalities. YTD in 2016 there have been 279 collisions involving pedestrians, 11 of which were fatalities.

Traffic Enforcement and Patrol members engage in countless incidents of educational interaction where verbal warnings are given to pedestrians in an attempt to keep them safe.

In 2016, the VPD deployed a new enforcement team within the Traffic Section - with a mandate focused on education and enforcement of pedestrian and cyclist related offences. This team has also been the primary point of contact for handling complaints and addressing concerns raised by the public with regards to these specific types of offences.

Motor Vehicle Enforcement:

As the statistics demonstrate, the vast majority of tickets issued by the VPD relate to Motor Vehicle infractions. Collectively, the VPD issued 44,439 tickets to motorists in 2015 and 32,971 tickets YTD in 2016. The consistent focus is on offences which are deemed to be contributing factors to collisions such as 'Distracted Driving', 'Speeding', 'Disobeying Traffic Control Devices' and 'Failing to Yield to Pedestrians / other Vehicles'.

The above three categories of statistics are represented in greater detail in Appendix A (Quick Reference Overview) and Appendix B (Enforcement Statistics by Travel Mode):
