Thank you for your email regarding the 4/20 protest at Sunset Beach Park.

We share your valid concerns about using a park location for this type of activity and wish to reiterate that this is an unsanctioned, unpermitted event. 4/20 organizers are proceeding with the event despite objections from both the City and the Park Board which worked with the organizers to find an alternate location.

As with any unpermitted event or protest, the priority of the Park Board, City agencies and all partners will be the health and safety of all participants and members of the surrounding community.

Together with the Vancouver Police Department (VPD), the Park Board is communicating directly with residents adjacent to Sunset Beach Park to make them aware of the event. In addition, VPD, Vancouver Fire and Rescue, City and Park Board are assigning the appropriate resources and staff to Sunset Beach in order to mitigate the impact of the event on neighbours, local amenities and services.
