Re: Request for Access to Records under the Freedom of Information and Protection of Privacy Act (the "Act")

I am writing in response to your request of May 2, 2016 under the *Freedom of Information and Protection of Privacy Act, (the Act)*, for:

For the period of Jan. 1, 2016 to April 30, 2016, a list of all transactions and totals for the Mayor's discretionary fund, specifically a list of individual dollar values for individual expenses, the names of contractors or providers of goods and services, the details and descriptions of the individual goods and services rendered, dates of the individual transactions and corresponding transaction numbers for expenses incurred under the following categories:

Advertising, Consultant Services, Disposal of Refuse, Transportation Expenses, Events Expenses, Meeting Expenses, Office Supplies and Services, Misc. Supplies and Services, Special Events, Food Purchases and Travel and Training.

The records responsive to this request will be publicly posted on the City's website within 60 days. Therefore, we are applying section 20(1)(b) of the Act:

20 (1) The head of a public body may refuse to disclose to an applicant information

(b) that, within 60 days after the applicant's request is received, is to be published or released to the public;

On May 3, 2016, there was a Council Initiative:

- A. THAT Vancouver City Council demonstrate a commitment to openness and transparency by directing that all expenses from the Mayor's Office budget, including expenses from the Mayor's discretionary fund, and expenses from the corresponding office budget for City Councillors, be released proactively to the public on a quarterly basis through the City's online Open Data Catalogue Dataset, including copies of all contractor and supplier invoices (consistent

with appropriate privacy protection legislation), beginning with expenses for the current 2016 Budget year.
