Re: Request for Access to Records under the Freedom of Information and Protection of Privacy Act (the "Act")

The following information in regards to uneven sidewalk repair order file #7532606 for 2837 East 54th Avenue, Vancouver:

- 1. The time and date that the call was made to report the condition of the sidewalk;
- 2. Was the call was made by resident or other individual;
- 3. The date and time of repair;
- 4. Particulars of findings including copies of photos regarding the sidewalk condition.

If you request a review, please provide the Commissioner's office with: 1) the request number assigned to your request (#04-1000-20-2016-230); 2) a copy of this letter; 3) a copy of your original request for information sent to the City of Vancouver; and 4) detailed reasons or grounds on which you are seeking the review.
