Re: **Request for Access to Records under the Freedom of Information and Protection of Privacy Act (the "Act")**

I am responding to your request of July 25, 2016 for:

**The following information regarding 1123 Lakewood Drive, Vancouver:**

- 1. When was the driveway access removed and paved over to create a square curb that is impassable by a car;**
- 2. When was the large tree planted on the city boulevard in front of the original driveway access.**

Please note that for part 1 of your request, the Streets and Electrical Design Branch does not have any responsive records in their database which goes back to 2005. For part 2 of your request, the attached responsive record shows when the tree was planted.

Under section 52 of the Act you may ask the Information & Privacy Commissioner to review any matter related to the City's response to your request.
