The purpose of this memo is to inform Council that a Request for Proposals (RFP) for conceptual design of the Arbutus Greenway will be released shortly.

The goal of the Arbutus Greenway project is to deliver a world-class walking, cycling, and future streetcar facility along the Arbutus corridor. The first round of public engagement was undertaken successfully in January and February to gain input on the community's vision and values for the project, including over 3000 survey responses.

The next milestone will be to move forward with the development of conceptual design for the Corridor. The team is working towards finalizing an RFP for consultant services to develop the design and expect to post it to an open market on February 27, 2017.

The temporary pathway is open for use while the installation of pathway enhancements continues.
