Re: Request for Access to Records under the Freedom of Information and Protection of Privacy Act (the "Act")

I am writing in response to your request received on January 17, 2017 for:

Information regarding the following (from January 17, 2015 to January 17, 2017);

1. Anything relating to accidents or injuries involving cyclists and pedestrians on or near the Second Narrows Bridge.
2. Any city plans or proposals to implement further safety protocols for the Second Narrows Bridge.
3. Any complaints made to the city regarding the visibility on or near the Second Narrows Bridge.
4. Any proposed changes to increase visibility on or near the Second Narrows Bridge.

The request for records was sent to the Director of the Transportation Division, the Branch Manager of Transportation Planning, and 311; however no responsive records were located. In fact the only record located that was responsive to some of the parameters in your request is for a different time frame, a 311 call record from 2012. We are providing this record in case it is useful for you, (the name of the caller has been withheld under s. 22(1)).

Under section 52 of the Act you may ask the Information & Privacy Commissioner to review any matter related to the City's response to your request. The Act allows you 30 business days from the date you receive this notice to request a review by writing to: Office of the Information & Privacy Commissioner, info@oipc.bc.ca or by phoning 250-387-5629.

If you request a review, please provide the Commissioner's office with: 1) the request number assigned to your request (04-1000-20-2017-020); 2) a copy of this letter; 3) a copy of your original request for information sent to the City of Vancouver; and 4) detailed reasons or grounds on which you are seeking the review.

101000309627							<p>Describe details (who, what, where, when, why): Traffic safety concerns about parking lot/lane from McGill to Wall St. There is a parking lot/laneway link between McGill Street and Wall St. It also forms part of the the Portside bicycle path access to the Ironworker's Memorial/Second Narrows Bridge. I ride this stretch pretty much every morning between 8:00-8:30 AM and have had several encounters here with vehicles that seemed to be speeding through to use it as a shortcut.
