Greetings Mayor and Council

I am writing to let you know that the rezoning open house for 58 W Hastings Street (VAHA site) that was scheduled for this evening has been postponed – details and next steps are included below.

**Reasons for Postponement:**

- Vancouver Community College (VCC) has expressed concerns that the rally and march protest planned by Our Homes Can't Wait (OHCW) this evening presents a risk to students and others using the campus building (the meeting room is on the 4<sup>th</sup> floor and is one of their classrooms, and students will still be in classes).
- VCC has cancelled the room booking for this evening's open house. An alternative venue was explored but space could not be secured.
- Without a venue, tonight's open house has been postponed.

**Next steps:**

- Staff have notified interested residents
- Planning staff are preparing a poster for display at VCC this afternoon, noting that tonight's open house has been postponed and:
  - There will be more public consultation on the application - stay tuned for more information
  - Application material can be reviewed at [vancouver.ca/58whastings](http://vancouver.ca/58whastings) and comments can be provided online
