Question #1

- The maximum size of expansion of an existing DTES liquor store is 3,000 square feet as per the Liquor Store guidelines.
- Any proposed increase in size would be subject to review through a Development Permit process, with input from internal and external groups representing the interests of the DTES.

Question #2

- There are currently two Liquor Stores in the DTES
- 375 Water Street at 1,500 square feet
- 769 E Hastings Street at 800 square feet
- Potential increase is 3,700 square feet, but expansion at these locations could be challenging due to building constraints

Question #3

- Of the 2,746 calls for service below, 1399 generated an actual report written.
- Without reading all 1399 reports, we can't determine based on call-type if the incident was related to gender-based violence or sexual assault.
- For example, a disturbance may be an argument between a male and female but will not be written as a domestic incident in the GO.
- Gender-based violence or sexual assault may also be reported elsewhere but started in the GED.
- This too will not be captured in simply looking at calls for service.
- I don't think this analysis accurately captures gender-based violence incidents or sexual assault related to liquor in the GED.
