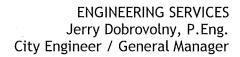

This memorandum provides an update on work underway to address the December 14, 2016 Council motion directing staff to review the Special Events Policy in consultation with the public, community groups, stakeholders, and partners.

The motion directed that the Special Event Policy update would include:

- Defined event categories with clear criteria for event types such as Destination Special events and Community Special Event.
- A strategy for Destination Special Events to proactively work with partners to encourage and support new and emerging destination events.
- Revisions to the Special Event Policy to support community-driven events.
- A general, strategic special event framework that provides recommendations on how to improve processes and service, funding models and promote partnerships.
- A timeline for change implementation and identification of opportunities.

Work on this policy update is underway and is being advanced through a cross-departmental working group including Engineering, Cultural Services, Planning, Real Estate and Facility Management, Vancouver Parks Board and Sport Hosting. Initial consultation is being undertaken, including a survey of event organizers in late September to provide input on issues, opportunities and priorities for the policy update.



An update to Council on the findings to date of the Special Event Policy Update is planned for November 2017.
