Re: **Request for Access to Records under the Freedom of Information and Protection of Privacy Act (the "Act")**

I am responding to your request of March 22, 2017 (which was then clarified on March 31, 2017) for:

GHG emissions of the Manitoba Works Yard broken down into:

1. Scope 1 emissions - Total amount of fuel: diesel/gas oil, motor gasoline (petrol), biodiesels, ethanol, propane used for vehicles and equipment that is stationed at the Manitoba Works Yard for 2015; and
2. Scope 2 emissions - Total amount of electricity heat, steam, and cooling (indirect) emitted from the Manitoba Works Yard for 2015.
