Of note, the new spill response base is tied directly to the TransMountain pipeline extension.

WCMRC Project Background:

- WCMRC's proposed spill response base is a component of the Trans Mountain Pipeline Expansion.
- Pending an investment decision by Kinder Morgan, and a permit from the Port, the project is set to begin construction in 2017 and be operational in 2018.
- Location: 2800 Commissioner Street, near New Brighton Park, on the site of the old Prince Rupert Fishing Cooperative.
- Facility: The new facility would primarily consist of new docks to moor vessels, as well as an office to accommodate response crews
- The base is intended to improve spill response time on the south coast.
- The dock proposes to house one of the new fireboats.
- The expansion includes 24/7 operational capabilities, however it is unclear the scope of these capabilities.

Issues:

- While response capacity enhancements are needed for all spills from all sources in the harbour, the enhanced response capacity does not, in the City of Vancouver's perspective, adequately mitigate the risk of the Trans Mountain Expansion Project or current tanker traffic, in particularly due to the fact that the technology and equipment to recovery diluted bitumen does not exist (as per US National Academy of Science report on Dilbit).
- The proposal is based on modelled spill scenarios and risk assessments that have not included a tanker spill of any size in the harbour.
- Given the current risk, we would encourage WCMRC to conduct a series of exercises and spill scenarios under a range of weather conditions to test the capability to protect shorelines around the inlet, and to contain and recovery diluted bitumen before in submerges.
- Enhanced response times are great, but we know that there are conditions under which response time is limited, for example

Background on CoV engagement with WCMRC:

- EM and Parks met in 2016 with WCMRC to discuss the option of installing anchor points for protective boom on the seawall around stanley park as the seawall is being upgraded; we are waiting for follow up on this.
- EM has been engaged in 2014 on discussions around response plans EAST of the 2nd Narrows, we are still waiting for a timeline for the development of plans along Vancouver's shorelines.
- EM and Comms have been engaged on the development of a website for public information in the event of an oil spill. This is a positive development.
- Staff have been to the WCMRC offices and warehouse on a number of occasions, we have also had WCMRC staff to our Emergency Operations Centre.
- Staff have worked closely with WCMRC responders during a number of spills (For what it's worth, while we fundamentally disagree on the TMP approval and the method of risk assessment to inform WCMRC's plans, we do work hard to retain a strong working relationship with WCMRC as the sole Transport Canada mandated spill response organization in BC. Generally, our staff relationships have been able to withstand the TMP turmoil.)

Questions:

• Will this include wildlife response capabilities?

- Are there risks associated with locating all of the harbour's spill response capabilities at a single dock? How will this be mitigated?
- Will the construction of the dock impact the timeline for the development of response plans and strategies for Burrard Inlet?
- What is the timeline to engage communities in the development of spill response plans in the harbour west of the 2nd narrows?
- How many staff will be onsite 24/7? Are 24/7 capabilities through contractors or WCMRC staff?
- What new response technologies or research investments are being made to recover submerged oil?
