- Overall it is accurate except this point that raised my concern:
- Sing Tao's coverage on Nov 29, residents said there will be "about 15 high risk criminals" moving in, and they worried about students and residents' safety.

Latest update/ sentiment

- Since City Hall passed the building permit on Monday, residents who opposed to the project have been blocking trucks from entering the site. They said they will continue to do so 24 hours a day. On Wed, a no. of senior managers including City Engineering's Jerry Dobrovolny and others from housing dept. went on site. They said, people will be ticketed with \$250 each time if they purposely interfere a City construction site.
- But protestors said, they'd rather be ticketed than retreat because it's City who first disrespect residents' voices, and the decision making process is completely lack of transparency. They have hired lawyer to sue City. Will explain this in press conference on Friday.
- According to AM1320's Phone-in show on Tuesday, people are very upset. Many said people must vote next year to ensure Gregor Robertson won't be elected again. He made a promise to listen at last election, and people have given him a chance, yet he still doesn't. Some asked why the Marpole community is being targeted.

- There is also a sense of fear that nobody knows when and where TMH will arrive at their neighborhood and they will be not have a say just like the Marpole residents did.
- Residents are planning to sue City for lack of consultation. They will meet and release details on Friday.

So don't blame any Chinese City councilors but come out to vote.

Interpretation/ Observation

The relationship between Marpole and City is at a very staggering point, and it is important to mend the relationship. Also, In AM1320 phone-in show, several people called in expressed a sense of fear of not knowing when/ where they would be next. I think that there is a serious lack of trust, besides the reasons stated above.

On the Marpole residents concerns on children safety, I think that it would be important to look at the story behind as well. For many Chinese/immigrant families, their main if not sole reason to come to Canada is for their children's education. While parents sacrifice many things for their children, these parents sacrificed a lot to come here ie. career, family unity, stability, sense of security. You can imagine how much they value their children's safety.

Secondly, the PAC of Churchill Secondary seems to be willing to compromise and asked last Friday if City can promise not to house tenants with service level 3, City replied that they cannot discriminate any tenants. Such gap or uncertainty is the most important point. The Mayor made some clarifications on AM1470's Phone-in Show on Saturday, that what City wants is a solution, not a problem. If City knows that it doesn't work, City wouldn't have allowed this idea to pass through. This is an assumption not spoken out till then, so I think it was good for reassurance. However, that also touches on the trust issue again.

Chinese language media and the residents who opposed have asked several times if City can guarantee no service level 3, there hasn't been definite answer. The Mayor said as there is no addiction services close by, it won't make such tenant happy if to house him/her there. As long as there is uncertainty, there is still room for speculation, and people tend to think that City has something to hide and the trust level goes down further, especially when they think City already puts the homeless on a higher priority than their children.

While the spectrum of homelessness is quite big, and can go from senior surfing coaches to people with severe addiction or mental illness, as there is a lack of trust, people would easily assume the worse. So when we don't validate the residents' concerns for their children's safety, but responded with disappointment in the stigma against homelessness, or a classic case of NIMBHY, it makes them more angry. A caller to a phone-in show did mention that they were very angry that City twisted their intensions on property tax values. That implies that they are heartless to the homeless, and they shouldn't have a say. The result of this is escalation of anger and erosion of trust.

I think that, instead, it would be good to acknowledge the residents that they also want to help the homeless in the area and that the project isn't asking them to chose between their children and the homeless. Also, I think that it would still be good to define clearly the kind of tenants from the service level 3 category as soon as it is available to alleviate any fear. It has been difficult to find data on the demographics of homeless in Marpole. It would be helpful to show that it is actually very different from the picture in downtown eastside.

- Yesterday morning when many parents arrived on site, a lot of City's engineers were already on site. They set up picket line right away to block more vehicles coming in.
- A parent Mr. Yeung said, upset that City took away his right to be consulted, and what City is doing is illegal. Residents should have a say. Parents all empathize with homeless people, and are willing to support them with the fund they raised through this petition. Their only request is to change the location, hope City is not trying to divert people's attention on this issue.
- Marpole Residents' Coalition spokesperson Mike Burdick: what City does this time is plain wrong, it has infuriated the Marpole community.
- Burdick: Many accused them as NIBMY but they don't reject the homeless, they just want City to find a more appropriate site in Marpole. Doesn't believe in City that there isn't other sites available.
 W59th & Heather is far from public transit, no supermarkets or grocery stores, no medical facilities, but only schools and residential area. It is not a convenient area for the homeless.
- NPA Cllr. De Genova said at City Hall, that Vision's decision on TMH is a closed door process and didn't listen to the community. It is not really public consultation.
- Two engineer's trucks that carried pipes arrive at around 2:30pm yesterday but blocked by the picket line. No confrontation occurred. The truck left at 2:50 as they are unable to enter. VPD dispatched a few officers on site, but didn't interfere as no illegal action took place.
- Some residents brought in biscuits for those on picket line to cheer them up.
- But a student Hannah Mitchell from Ideal Mini School said, she lived in DT but was never disturbed. They are actually very friendly so she doesn't oppose to City's place. Another student Michelle Lao said, City said everyone who moves in can take care of themselves

independently and believes that it won't bring harm to the community. Should give these people a chance.

Subject: Decision on Temporary Modular Housing in Marpole

Good Afternoon members of the Marpole community,

I want to thank you for your expression of interest and concern – both pro and con – in this project and let you know of my decision.

Context

To address immediate housing needs for homeless residents in Vancouver, the City of Vancouver, B.C. government and the Vancouver Affordable Housing Agency are placing temporary modular housing on underutilized sites across Vancouver. On October 26th, the City announced the first two buildings with 78 new homes to go on the Pearson-Dogwood site in Marpole at 7430 & 7460 Heather Street (650 West 57th Avenue). This is the first site of ten or more across the City that will hold temporary modular housing.

Temporary modular housing is compatible with the phased development plans for the Pearson-Dogwood site. A rezoning was approved by Council for the site in June 2017 to build a mixed-used community and temporary modular housing is located on portion of the site that is scheduled for a later phase of the development.

The City is taking action to respond to the urgent need for affordable housing, and as such City Council has delegated me, as the General Manager of Planning, the authority to approve temporary modular housing projects, with conditions attached.

As part my deliberation, I have personally met with the project sponsors, concerned Parent Advisory Council representatives and community leaders to hear their concerns. I've also spoken with the Vancouver School Board and I've read through the numerous letters and emails from the public, as well as the summary of comments from the four Open Houses conducted earlier this month.

I've taken this decision very seriously and taken into consideration everything I've heard from the above community members and stakeholders. I've also looked at the City's overall need to support and house our must vulnerable residents, especially in light of the increasing number of homeless residents on our streets. After taking a holistic assessment, I have decided to issue the Development Permit which includes an Operations Management Plan with the following conditions:

- BC Housing will amend the Operations Management Plan (OMP), as needed, to reflect periodic reports out from BC Housing to the City of Vancouver
- The project shall have a Community Advisory Committee (CAC) that includes both
 community members and Parent Advisory Council members, as well as others representing
 community interest. The CAC shall be established and convene a first meeting prior to the
 occupancy permit issuance in order for BC Housing, Community Builders (as the operator)
 and the City of Vancouver to update CAC members on project progress and
 implementation of the Operations Management Plan (OMP)
- This site will be tenanted in accordance with affordable/supportive housing tenanting best practices, taking into consideration the surrounding neighbourhood including the adjacent schools and other uses
- The City of Vancouver will work with the Vancouver School Board, BC Housing and Community Builders to convene a community conversation prior to the occupancy permit in order update the community on the progress of the project, enable strong lines of communication, hear any continuing concerns and suggestions, and foster a positive reception for new residents







We are counsel to Caring Citizens of Vancouver Society, a group representing residents of the Vancouver neighbourhood of Marpole. We have become aware of your application returnable December 4, 2017.

While it is not the Society's intention to take a position on this application, we write so that you are aware, and so that the court may be informed, that it is the Society's intention to bring a petition challenging the Director of Planning's approval of the conditional development permit in respect of temporary modular housing at the Pearson-Dogwood site as soon as possible.

The Society anticipates that its challenge will be to the legality of the development permit for temporary modular housing in a zone where such a use is not permitted by the zoning by-law. It is that Society's position that in purporting

to authorize the Director of Planning to relax the zoning by-laws to allow for temporary modular housing, the City is attempting to avoid its legal obligation to hold a public hearing to allow local residents, including members of the Society, to be heard on this important issue for their neighbourhood. Other issues may be raised. The Society will be asking the court to hear this petition application on an expedited basis.

Pending hearing of the forthcoming petition, the Society asks that the City put construction of temporary modular housing at the Pearson-Dogwood site on hold.

It is to be emphasized that the Society and its members are highly sensitive to the issue of homelessness in this City, and to the need to protect Vancouver's most vulnerable inhabitants. The situation at hand exists due to inaction on the part of the City of Vancouver and provincial and federal authorities over a period of many years. The urgency of the current homelessness situation in Vancouver does not relieve the City of the obligation to hear local residents on important matters, and does not remove those residents' right to be heard on matters which impact their neighbourhoods.

We would ask that this letter be drawn to the attention of the court tomorrow morning at the hearing of the City's application.

writing an email to you today to express my concern about the temporary modular home (TMH) that will be built on 57th and Heather.

Most likely, the City is going to build the site in Jan/Feb 2018 despite the fact that many residents in the area oppose to the idea. Honestly, I do not think the protesting currently done by residents in the area will work because if the City can skip the regular public hearings route to make it work, they will make it work. Therefore, instead of wasting time requesting the City to stop the site, I think it is time to think about what we can do to safeguard our kids while having the plan carried out as planned.

I trust that the City is going to screen the potential tenants on the site and hopefully these selected tenants do no harm to our kids. However, based on some of the reports, it is likely that at least 20% of them have previous criminal records. They could have drug problem, could have problematic behavior or they could be very nice people who happened to be homeless due to whatever reasons we do not know. We have no way to find out who they are (good or bad people) and if they truly post no harm to our kids.

To be conservative and to safeguard our kids, I suggest the followings:

- 1) Fence up the school playground: currently, many areas of the playgrounds have already been fenced up but there are still some parts where easily accessible by the public. I suggest that we should fence up the whole school playground to make sure that while the kids are playing at the playground, no external party can access to the playground except school staff or students. Off school hours, the playground gate should also be closed so that no external party can access to the playground -- this is to prevent the needle problem that might be used/disposed at night. The used needles can be very harmful to kids and impractical for the school staff to check potential needles every morning when kids are back to school. By fencing up the playground and locking the playground at night, I think this problem can be resolved so our kids have a safe place to play.
- 2) One door entry to the school building: currently, there are many entrances accessible to the school building. I suggest that the entrance should only be limited to one main entrance and all visitors should provide IDs and sign-in before entering the school building. This can reduce the potential theft problem which is beneficial both to the kids and to school staff. If necessary, we can install digital locks for other school entrances which would require a pass code to enter.
- 3) More staff during recess: I also suggest that we can put more staffing during recess time to make sure our kids are all playing safely at the designated areas. Parents can also volunteer to watch our kids during recess if available.

The cost should be borne by the City as the TMH is the plan initiated by the City.

Sorry, in order for the parents to build the confidence for this project, I think the City do need to do something so the TMH plan can be carried out in a win-win situation. Many parents around us are already thinking about alternatives such as sending their kids to other neighborhood school if the City nor the school is doing anything to safeguard our children. We have already closed down Laurier annex, we can not afford to close down another school due to low enrollment.

Subject: Kaslo St Temporary Modular Housing

Dear Mr Kelley and Housing Team,

I would like to provide my feedback after having attended one of the Information Sessions for the Kaslo St TMH.

- 1. There is no consultation. Regardless whether the neighbours support this or not, the TMH will move forward. CTV News on Dec 13 reported on this. Asking for people to provide feedback seems almost pointless. The % of Marpole residents who opposed the location of a TMH on Heather St & W 59th Ave has never been publicized. When only 20-30 out of a 2000 Churchill students attended a pro-TMH rally, however, the Mayor hyperbolized to make it sound as if all students supported the TMH. So, my sense was that the Kaslo St neighbours are resigned that the TMH will be forced into their neighbourhood. Instead of heavily protesting, people I spoke to encouraged each other to vote out the current council in the next election. 2. As you are aware, there were no sit-down discussions. Could we not have sat upstairs in the church to hear what everyone wanted to ask? This would've been more informative for the community.
- 4. When I asked Brenda Prosken from BC Housing (formerly of City of Vancouver) about the minimum 20% requirement, she asked me how did I know about this. Did I get the info from Marpole folks. Why was such a crucial piece of info withheld from people attending the info sessions? To Ms Prosken's credit, she acknowledged that when the Marguerite Ford apartments first opened, she had pushed for too high a % of homeless people, causing extensive conflicts and damage there. In the first 16 months of operation, there were 726 calls to police. She verbally promised that she would try to stick to the 20% amount for Service Level 3 at the Kaslo site. However, can we get this on a contract that 20% is the maximum not the minimum? Anything verbal is not binding. There are single-family homes immediately across the back lane from this TMH. Ms Prosken said the criminal background of tenants may involve petty crimes including break and enters. People living beside the TMH are quite vulnerable for crime. The only thing separating an intruder is a simple door or window. I am also concerned about tenants gathering across the street at the park. I do not wish to be intimidated and threatened as I walk to and from the SkyTrain station or tennis courts.
- 5. Janice Abbott of Atira was candid in telling me that she only learned on Monday that they had won the bid to be the service provider at the Kaslo site. She did not know anything about the site. She didn't have a budget so couldn't answer whether she had enough money to staff 1 or 2 people 24/7. She did not know what the tenant mix would be as they haven't interviewed anyone. How are neighbours supposed to provide feedback about this TMH if safety is their primary concern?
 6. There were 3 security guards, 1 uniformed police officer, and 1 undercover officer at the info session, which was a cramped church basement. I felt greatly offended that the undercover officer followed me, watched what I wrote on the feedback board, and asked me if I lived in the neighbourhood and for how long. He was not asking to make conversation. I was quietly walking around minding my own business. If there will be as many security guards and police officers working at the TMH instead, I'm sure Kaslo St & Marpole neighbours would object less.
- 7. I think it was wrong for the City to consult with Collingwood Neighbourhood House, the community gardeners, and Park Board but not notify the neighbours sooner (according to Vancouver Courier article). There were someone who didn't even know about the info sessions. Were notifications dropped through the mail slot or were they sent to owners? I think he is a renter.
- 8. To date, there is still no site-specific info on the City's website. I've been asking for documentation to be posted since last week. If Dec 22 is the last date for neighbours to submit feedback, they need more info. Please post at least the Operation Management Plan, tenanting mix info, and the siting of the building in both English and Chinese ASAP. Will there only be one entrance facing E. 29th? People congregating on the side and back alleys can be disruptive to neighbours.

I sincerely hope that for the next site that will be chosen, staff will genuinely involve the adjacent neighbours sooner rather than later. These are people who have to deal with tenants and issues 24/7. Their safety and property may be at risk. Their property values will also decrease compared to a similarly zoned lot further away from the TMH. I hope the City can extend some compassion to these neighbours by being willing to mitigate risks before construction even begins. As well, please be more organized, informative, and transparent during future info sessions.

Community Liaison Report Overview of Issues/Resolutions

Kaslo

- Several calls this week from Kaslo residents expressing concern around existing lighting around the Skytrain and TMH site. Their concern is that the area is already dimly lit and the dead end makes the location ideal for a place to do drugs or crime.
- Dec. 12 Engineering has been working collaboratively with TransLink on making service and safety improvements at the 29th Ave Station Bus Loop. Part of this work is to improve the existing 29th Avenue pedestrian crossing to a fully signalized pedestrian crossing at Atlin & 29th Avenue. As part of this new signal work, CoV crews will also be installing new LED street lighting which will improve safety at this intersection. Work for this intersection will commence in Q1 2018. TransLink has also installed additional lighting within the bus loop to improve pedestrian comfort and safety.
- Still Moon Arts Society has expressed interest in painting a mural or art installation on Kaslo TMH. They are looking for funding to complete this. CL replied that the best way for Still Moon Arts Society to submit a proposal would be to send a detailed email tohousing@vancouver.ca


Dear Mr. Kelley,

I want to thank you for your expression of interest and concern – both pro and con – in this project and let you know of my decision.

Context

To address immediate housing needs for homeless residents in Vancouver, the City of Vancouver, B.C. government and the Vancouver Affordable Housing Agency are placing temporary modular housing on underutilized sites across Vancouver. This comes as part of a \$66 million commitment from the Province towards 600 units of temporary modular housing in Vancouver.

On October 26th, the City announced the first two buildings with 78 new homes to go on the Pearson-Dogwood site in Marpole at 7430 & 7460 Heather Street (650 West 57th Avenue). This is the first site of ten or more across the City that will hold temporary modular housing.

Temporary modular housing is compatible with the phased development plans for the Pearson-Dogwood site. A rezoning was approved by Council for the site in June 2017 to build a mixed-used community and temporary modular housing is located on portion of the site that is scheduled for a later phase of the development.

The City is taking action to respond to the urgent need for affordable housing, and as such City Council has delegated me, as the General Manager of Planning, the authority to approve temporary modular housing projects, with conditions attached.

Decision

To suggest the City has consulted with the residents affected by the TMH is simply wrong. I live near the TMH proposed for 57th Ave and Heather Street. I certainly was not consulted nor did I receive any notice from the City about the consultation process.

According to an article in todays Globe and Mail, you councillors approved what can only be described as an antipublic (dare I say anti-democratic) bylaw: "In addition, a recent bylaw change removed the requirement for temporary modular housing – such as the project in Marpole – to go before a public hearing as long as the land does not require rezoning." It seems to me the bylaw change, which you will no doubt defend as efficient, is just another way for you to avoid accountability.

The article goes on to note the City says it held public meetings. It says 650 people attended. The City did not say that the vast majority of those who attended spoke against the TMH proposal. The City did not say it is ignoring the vast majority.

The decision to place the TMH at 57th and Heather appears to have first been a "backroom deal" for the development of the property in question and now the City is trying to justify the decision as having been reached after public consultation. The decision was certainly not based on an open, fully disclosed pre-decision process.

It is a decision I do not support. It is a decision I will be voting against.

It remained calm in the meeting room and we had a small sit-in protest outside the room in the open house area, but security staff handled it well.

Here is a great summary of this evenings meeting from Armin.

Just a few extra things to add:

Cllr Jang had a number of altercations with residents. At several points it seemed to get almost physical and our security had to intervene. It would be helpful to get his perspective on the meeting and how his interactions with the residents.

There was a request to have The Mayor and Gil Kelley at one of the meetings this week – in particular wed night. Not sure if this is because specific action planned?

Still 3 main areas of concern:

- A lot of stigma about homeless people, wanting guarentees about whether people would be screened out
 if they had criminal records.
- Questions/confusions about whether this is a "done-deal" confusion about how the Mayor said that we
 are moving ahead with this site and yet we are still going through a DP process. There were a number of
 people who said the process wasn't undemocratic because people weren't being heard.

There were at least three people inside the room whose tried to disrupt the meeting, right from the outset. Our facilitator Diana, reminded everyone about the rules for the meeting, and stated that if they didn't adhere to them then we would have to close the meeting. They settled for a few mins, but then when the media cameras entered the room, they started to shout again, plus people outside started banging on the windows.

Everyone was asked a number of times to calm down but it because impossible to hear in the room. There were people inside the room who were communicating with those outside and we had some concerns that they were going to open the fire doors and let everyone in – so we made the decision to end the meeting and the staff regrouped in the kitchen area before going home.

The protestors stayed in the room for about another 30 mins with the media before starting to dissipate.

An unfortunate end to our community information series but it became impossible to communicate in the room, plus we had safety concerns for both staff and residents.

Everyone was very calm and collected and our "staff evacuation" went off with no issues, especially the Security staff who were excellent. Once again, a great team effort.

Ensuring people have a place to call home

Vancouver is in a housing crisis and homeless residents have been hardest hit. Over 2,000 people across the City of Vancouver said they were homeless for the 2017 Homeless Count. People are living outside with nowhere to sleep, use the washroom, or get regular food and water. Men, women, seniors and youth are suffering both physically and mentally.

The City is taking bold action to address this immediate and urgent need with temporary modular housing, a quick-to-construct temporary building that will help homeless people off the street and into homes while more permanent housing is being built.

Temporary Modular Housing at West 59th and Heather Street

Two temporary modular buildings are planned for West 59th and Heather Street.

- Each building will be three storeys and have 39 single studios.
- 7 studios in each building will be wheelchair accessible.
- All units will be self-contained dwellings with private bathrooms and kitchens.

Our priorities for the buildings are people who are unsheltered or living in shelters, people who are 45 years and older, persons with disabilities and homeless people living in the local neighbourhood. Residents will be carefully selected by BC Housing, Community Builders and the City making sure this housing is the right fit for individuals. The temporary buildings will provide much-needed housing for up to 10 years while more permanent housing is built. Temporary Modular Housing is an important option in providing homeless residents with access to safe, secure homes.



Managing Housing Safely and Responsibly

 Applications for Temporary Modular Housing are processed through the BC Housing Supportive Housing Registry. To apply visit;

- Residents will be selected by staff from BC Housing, City of Vancouver outreach team and the housing Operator
- The two buildings planned for West 59th and Heather Street will be operated and managed by Community Builders Group
- All residents will have access to health and support services
