SUBJECT: Annual Report to Council - Advisory Committees

The purpose of this memorandum is to provide City Council with a comprehensive report of activities undertaken by Type A advisory committees in 2017. Type A advisory committees are those committees established by Council and are advisory to Council. As set out in the December 16, 2014 Council resolution, each committee is required to provide an annual report to Council which describes its annual accomplishments.

Annual Events for Advisory Committee Members

There were three advisory committee member events held in 2017, organized by City Clerk's Office, which facilitated discussion amongst committee members and liaisons and provided training opportunities for members and staff. These events were:

Advisory Committee Member Training - March 14, 2017

At this comprehensive training session, nearly 40 committee members received presentations from and asked questions of:

- City Clerk's Office on civic agency roles and responsibilities, meeting procedures and the Code of Conduct policy;
- Corporate Communications on media protocol, social media and the City's website; and
- Access to Information on privacy, confidentiality and information sharing.



All committee members were provided with updated Guidelines for Civic Agencies which explain committee/member roles and responsibilities, the Code of Conduct policy, meeting procedures and media protocol.

Advisory Committee Chairs' Meeting - July 10, 2017

This meeting provided an opportunity for discussion amongst advisory committee Chairs and Co-Chairs regarding 2017 planning. The session started with training by City Clerk's Office staff, followed by planning for the 2017 Council to Councils and a group activity to encourage awareness and cross-collaboration amongst committees. As a result of the discussion, several committees organized a multi-committee event on the subject of housing in the City.

Council of Councils - October 12, 2017

Each committee presented their accomplishments for 2017 and goals for 2018 to an audience of over 80 attendees at the downtown branch of the Vancouver Public Library. Committee posters were displayed around the room, which attendees had the opportunity to review during the networking breaks. Attendees also received a presentation from Park Board staff Josie Pearce and Ben Keane-O'Hara, Facilitators, Trans Inclusion Strategy, on trans inclusion initiatives at the City. The group also participated in an activity led by the presenters. Following the event staff published a year-end member survey completed by 66 members. The results will be used to inform updates to policies and procedures as appropriate.

Advisory Committee Annual Reports

Table 1 below provides an overview of each committee's mandate, work plan and poster presentation from the 2017 Council of Councils (as available). These documents are publicly available on the City's website under each committee's "Our Progress" tab. Links are provided in the table for ease of reference.

Type A advisory committees each have their own specific mandate (provided with each committee's report in Table 1) and also adopt common terms of reference as follows:

- provide input to City Council and city staff about issues of concern;
- consider any matters which may be referred to the committee by Council or staff;
- may take positions on policy initiatives from other levels of government within the mandate of the committee;
- work cooperatively with other agencies whose activities affect constituent communities, including initiating and developing relevant projects;
- act as a resource for staff doing public involvement process and/or civic events;
- exchange information with the constituent communities and the general public about relevant programs and issues of interest; and
- engage in outreach to disseminate information and encourage participation from constituent communities.
