Dear Mayor and Council,

In February 2015, Council approved a motion directing staff to work "towards enacting a healthy, safe and energy efficient outdoor lighting strategy in order to control harmful outdoor lighting, set standards for outdoor lighting and provide for the designation of dark-sky preserves".

The following memo is meant to provide a status update on the development of an Outdoor Lighting Strategy, in response to Council's motion, and to inform Mayor and Council that staff will be conducting public consultation on the strategy this spring.

Overview:

At a high level, the Outdoor Lighting Strategy aims to:



- Ensure safe urban environments;
- Protect human health;
- Create inviting and accessible spaces;
- Mitigate impacts on biodiversity;
- Improve energy efficiency and reduce wastage; and
- Promote light pollution education and awareness.

The draft Strategy including several key components:

LED retrofit of streetlights: Staff commissioned a business case last year to calculate the return on investment of a city-wide retrofit program to convert the 40,000 existing street lights to LED fixtures. The results were favourable, pointing to substantial operating budget savings resulting from reduced energy use and maintenance needs, as well as reductions to our corporate greenhouse gas emissions.

Lighting design guidelines: Guidelines are currently being developed to support better, more consistent outdoor lighting design for City capital projects (including street lighting, public spaces, and City-owned facilities) as well as development projects. The guidelines will ensure lighting levels, colour and light design (shielding, light spillage, etc.) are based on best available science and appropriate for particular settings (i.e., arterial and local streets, pedestrian pathways, ecologically sensitive areas, etc.).

Bylaw review and recommendations: Staff are exploring regulatory approaches to control light pollution from private property. The intent is to provide the City with a regulatory tool to ensure that private lighting doesn't compromise the environment (e.g., cause unnecessary sky glow) or quality of life for neighbours.

Dark sky preserves: A report will be produced that highlights the feasibility and actions needed to achieve an urban "dark-sky" designation offered by the Royal Astronomical Society of Canada. As the most likely location for such a designation is a large park, staff are working closely with Park Board staff on this report.

Stakeholder and public engagement

Staff recognise that residents and businesses rely on, and are affected by, outdoor lighting in many different ways. There have also been some concerns raised in other cities about the comfort and health impacts of LED lighting, which have led to LED retrofit programs being delayed or halted.

To ensure any concerns are addressed proactively, staff will be producing a consultation white paper that outlines the rationale and proposed approach for the Outdoor Lighting Strategy.

Staff will be conducting a thorough stakeholder and public engagement process. Groups that have been consulted or will be consulted shortly include:

Next steps
