Over the last year, the City has worked with residents and businesses to create a draft strategy for reducing the use of single–use items. The results of that consultation have been put into a draft strategy which proposes the priority actions including reduction plans for disposable cups and plastic/paper shopping bags, a ban on the distribution of polystyrene foam cups and containers, a requirement for food vendors to ask if customers would like a straw, a requirement for single-use items through a surcharge on business licenses or other mechanism.
