Re: Request for Access to Records under the Freedom of Information and Protection of Privacy Act (the "Act")

I am responding to your request of January 29, 2018 for:

- 1. The number of individuals the City sent to the care homes in Vancouver on Election Day and/or Advance Voting Day in 2014.
- 2. How many staff visited all the care homes and the total salary of the above staff have been including meal and/or car allowance in 2014.
- 3. List salary for the staff at City Hall who would have supervised or trained these mobile voting staff in 2014.

For part one of your request, Business and Election Services confirmed they had three mobile teams of three staff that visited the locations qualified for this special voting opportunity in 2014. Each team included a Presiding Election Official and two Election Officials.

For part two of your request, there were four staff who visited all the care homes and the total salary was \$13,292.70. Cars were rented by the Election Office and no car allowance was allocated to staff.
