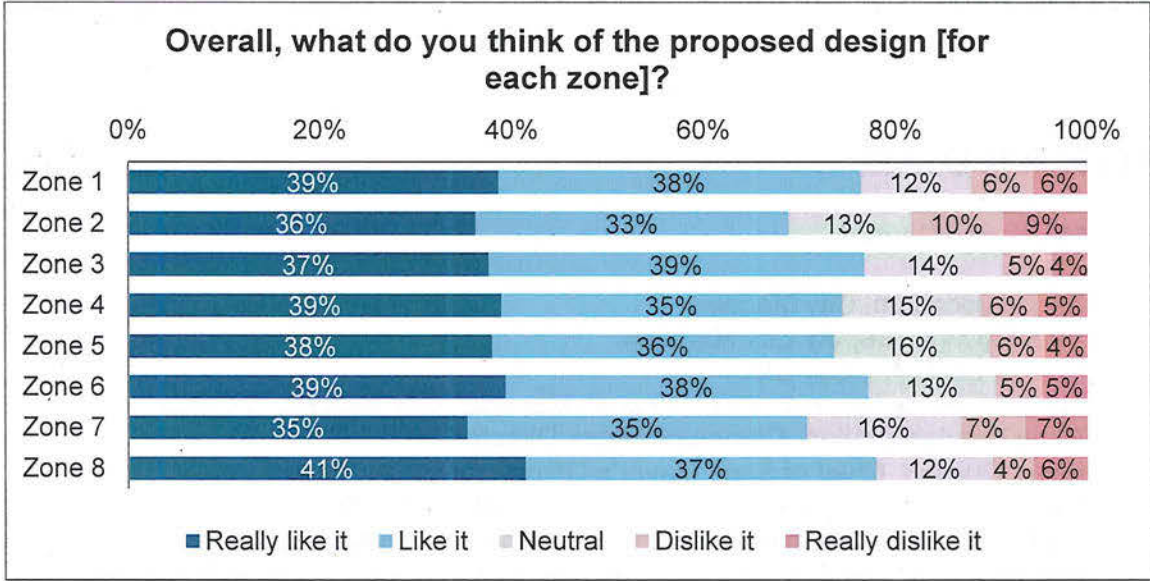
SUBJECT: Arbutus Greenway Project – Updated Consultation Summary Report

This memo provides an update to Mayor and Council regarding the Arbutus Greenway Council Report being presented to Council on July 11th, 2018.

BACKGROUND

The Council report, as well as the attached Consultation Summary, have errors in the feedback percentages which were recently discovered. Both the Council report and the Consultation Summary report have been updated to reflect the correct data. The data continues to reflect that there is overwhelming support for the design vision with 74% overall supporting the design; the previous version indicated that there was 75% support.

The following chart (included in the updated Council report) provides an overview of support for the proposed design for each character zone:



Note: Response percentages may not add up to 100% due to rounding.

DISCUSSION

The update to the Consultation Summary Report will be reflected on the Arbutus Greenway website, and noted within the revised Consultation Summary report.

The revised numbers continue to reflect a very high level of support for the designs and the revised numbers do not change any of the recommendations.
