The City typically replaces logos through attrition when infrastructure (like a garbage can) is being replaced, so there are no additional costs associated with this logo update.

To clarify there is no Greenest City target for greenest city in the world and there is no international award called Greenest City in the WorldThe City of Vancouver has a comprehensive environmental plan called the Greenest City Action Plan. This plan is made up of 10 goals and has 17 targets in support of those goals – the detailed plan can be found here. The City has already surpassed many of the 2020 targets and are on track to achieve more by 2020. However a few targets such as our GHG reduction target of 33% by 2020 will not be reached by 2020Even with significant population growth we are trending in the right direction and will eventually meet this target.

Despite not meeting our 2020 GHG climate target, Vancouver is regularly held up by international organizations such as the United Nations and C40 Climate Cities as a world leader in this field and we have the lowest GHG s per capita in North America and are in the top 5 of major cities internationallyWe are very proud of our community s progress in this regard.

We have set appropriate yet challenging environmental goals for Vancouver for the benefit of our businesses and residents and so Vancouver can be a beacon for other cities to follow. A good example of the benefit of this plan is the brand value research that indicated that Vancouver has one of the strongest brands among cities, our brand was valued at \$31US billion as of January 31, 2015 and we are uniquely associated with being clean, green and environmentally sustainable.
