For part six, the City has provided the processing stream of where the decision would have been made to change the status of the permit to “issued”. The system that records the dates of the decision does not accurately reflect who made the decision. The City is recommending that you make a new FOI request if you would like to receive this information which may result in a fee estimate.

Under section 52 of the Act you may ask the Information & Privacy Commissioner to review any matter related to the City’s response to your request. If you request a review, please provide the Commissioner’s office with: 1) the request number assigned to your request (#04-1000-20-2018-093); 2) a copy of this letter; 3) a copy of your original request for information sent to the City of Vancouver; and 4) detailed reasons or grounds on which you are seeking the review.
