The streets used to be lined with supporters of the Sun Run participants. Now the streets are empty of fans because of this loud, obnoxious music blasted at people for no purpose.

Good afternoon,

The Sun Run caused significant delays in traffic today, far beyond the posted closure times. For those of us on the North Shore, getting to or returning from Vancouver was a traffic nightmare. No one was running on Georgia Street at 11:00 a.m. but the street was still entirely closed. No one was running on Burrard Street at 1:00 p.m. at Georgia, but the street was still half closed. The only reasonable option to return to the North Shore at 1:00 p.m. today was to take a very long route via the Ironworkers Memorial Bridge which, by taxi, resulted in an exorbitant cost.

Perhaps the City should consider having the Sun Run relocated to a more suitable location, such as UBC and the endowment lands? If the City is not able to re-open major traffic routes to the schedule promised, the implications for everyone else who needs to commute within the core of the Lower Mainland, particularly from the North Shore where we are essentially held captive in any event by bridges which are inadequate for the population, is not acceptable. Many people must work on Sunday, and bridge and major access route closures to accommodate people at leisure, or simply indulging in recreation, is neither sensible nor fair.

Yes, I left you a voice mail message so you could hear to some extent what we hear. I know your voice mail recording won't even come close the decibels at which we hear that music at Bidwell and Beach directed at our residences everywhere in the vicinity. No one is immune to this noise from 7:30 am right through the entire Sun Run period to a little past 11:30 AM!!

Why is it that every year I complain – in all kinds of ways – and no one at Special Events seems to hear. Why is that? Why is it that Special Events can't use the simple suggestion I've made for years which is moving this music to Alexander Park facing the water? The musicians have their own power source but there is power at Alexander Park. Why would that be so difficult to give the residents in this area a break?

Ask your neighbour to put their speakers on as loud as they can and blast them at your home when you're wanting to just "chill" – so how it feels. You'll get an idea of what we have to put up with every single year. Why?

Now you want to spend \$250,000 of our tax dollars for a bike event! Are you kidding me...

We were recently told by the city that it was too expensive to have fresh water in Charleson Park anymore, something that park has had for years for dogs to both drink and cool off in, kids use it as well, not too mention it supports a ton of waterfowl and the entire garden system is planted around the water. As a taxpayer, it's not a lot of money and there are many, many people who use that park, the water being the main draw in the summer. Nor have you repaired the sidewalks, or even added sidewalks to one of our roads (Charleson), making them safe and secure for wheelchairs and pedestrians.

When my father was alive he was unable to visit me as he simply could not get around in his wheelchair because the roads and sidewalks were in such bad shape. And recently I drove down lower SW Marine Dr., which recently reopened after water main construction, and was interested to see that the water main construction had morphed into major bike route infrastructure, sorely needed, and long overdue I might add, on a road that services a university, though was shocked to see you has not included pedestrian or wheelchair infrastructure as there are no sidewalks. And I'm not even going to try to touch on the complete mishandling of the drug issue, not too mention the amount of money you say they are spending, including our extra .5% tax dollars, on the DTES without any results. What I see daily out of my office window at simply shocking,

So you can imagine my reaction when I see the City of Vancouver is throwing \$250,000 at a couple of bike events... An evening bike ride, on a busy September Saturday night, closing bridges and main roads, making it even more unsafe for pedestrians than usual and cutting off businesses, all designed to make us look cool. It's not a fundraiser, it's not an awareness event even. The Vision party says it's to change people's impression we are a no fun city. And my guess is that \$250.000 won't even begin to cover the extra police, security, or garbage pickup. The City of Vancouver decided this in one closed door council meeting. Local feedback (other than Hub, a bike coalition you fund) was nowhere to be seen, nor were we invited. Where was the NPA on this? Where were the local business associations, the police board even? Why did we not hear about it until it was announced in the media.

The City of Vancouver already sanctions a monthly bike ride right in the middle of a busy Friday rush hour that shuts downs streets, disrupts lives as they block roads to ferries and hospitals, and damages/vandalizes cars in their way. And each June during "Bike Month", this ride swells into the thousands. This "critical mass" demonstration is ongoing despite the millions of dollars of bike infrastructure long provided.

Vision and parks just helped, sanctioned (behind the scenes) and supported a pot group that threw 10 pounds of joints into a crowd with underage kids, left so many roaches and pot edibles on the ground it's not safe for dogs to use the dog park, caused residents to remain indoors with their windows closed tight and destroyed the local soccer field making it unusable for weeks, possibly months (we have yet to see the cost of that).

A couple of years ago Vison, whose politics are very much in opposition to the provincial Liberals, all but shot down a yoga session Christy Clark, somewhat misguidedly, wanted to do on the Burrard Street Bridge and charge them and their sponsors \$150,000 to shut down the bridge, while being concerned Vancouverites, who spend much of their daily lives stuck in gridlock, were apparently quite "miffed at the idea of shutting down one of Vancouver's busiest bridges on Father's Day", which falls on a much quieter Sunday morning, yet you are perfectly willing to miff a much larger crowd and cover the costs of a major bridge closure on a busy Saturday night for your pet project, and Gregor's personal legacy - bicycles!

Let me come right out and say this, I don't agree with the city spending this much on an event simply to show we are cool. We have lots of events, this Sunday's Sun Run for example (how much does the city give them?) And I sure don't agree with doing it on a busy Saturday night, closing a major bridge and main arteries through the city, disrupting businesses and people attending events, shows and concerts. For a city that didn't have enough funds to pay for decent snow removal or garbage pickup this past year; has raw sewage flowing straight into False Creek and is letting the parks fall into disrepair, it seems utterly irresponsible to spend it on this type of event. This government, Vision, and its mayor, Gregor Robertson, are simply out of control.

Subject: Granville Island not accessible during Sun Run

Hi Dave, do you know who the contact is for the City regarding Sun Run? The information on the flyer that was sent to us by Sun Run race director, Tim Hopkins, to distribute to staff and visitors was not accurate in terms of times, information and alternate routes. Also, when visitors contacted the city, via social media, the city was not aware of the alternate route to Granville Island. See tweet below. When our staff attempted to take the alternate route after regular routes were closed, the traffic officer directed them off the alternate route so it was impossible to drive onto the Island unless they

disobeyed the person directing traffic. There were no alternate routes available. This resulted in fewer visitors being able to access the Island until approximately 2pm.

We strongly recommend the route be changed next year so that our businesses and visitors are not negatively impacted. I believe that the City approves the Sun Run event application. Can you provide next steps in terms of getting the route changed?

Subject: 4-20 demonstration at sunset beach

Dear Mayor, Councillors, and Parks Board Commissioners,

I was outraged to learn through the media that the 4-20 protest was being moved, at the urging of my City Council, to Sunset Beach.

As a resident living directly across from this location - I can not believe that there was no public consultation on this decision. I have been alerted of every new development that has been proposed in my neighbourhood by a helpful and informative City staff - and yet, this event, I have received no notification of...

I am opposed to this location as it is directly adjacent to numerous residents, including myself. Adjacent to the Vancouver Aquatic Centre. And adjacent to the sea wall which acts as a universally public pedestrian pathway for all residents.

This event does not serve the local neighbourhood, and, unlike many events - such as the Sun Run, the BMO Marathon, the fireworks, and PRIDE, does not act to include or serve the members of this neighbourhood.

The Art Gallery location was one that did not impede on residents' lives.. as no residents were directly adjacent to this location. This location is inappropriate in that regard alone.

Further - as the City refuses to properly approve this event by providing licenses or special event approvals - it is infuriating that you would think that you could push this event on me and my neighbours without proper consultation. If you don't even deem this event worthy of providing proper city approvals, why should I accept this event in my neighbourhood?

I accept that I live in a location that is desirable to the City's population - and accept that the numerous events that are held here are part of living in this location; however, I do not accept that an event that is not even legally sanctioned by the City should be allowed to be held here.

Legally sanction it, complete proper public consultation, and we can talk.

Otherwise, move this event somewhere that does not directly impact adjacent residents.

Should this event move ahead at this location, I fully expect that the no-smoking by-law that applies to all parks will be enforced.

I can not even believe that I have to write this e-mail - it seems obvious that this location is inappropriate. And I am flabbergasted that my City Council would condone moving this event to my neighbourhood, without any consultation... and without actually being prepared to legally sanction and approve such an event.

At the minimum, I expect the City to provide us with information as to how this event will be monitored to ensure that it will not negatively impact the residents that live here year round.

I look forward to hearing from you in that regard.
