On behalf of the City of Vancouver ("Vancouver"), we now attach,

- (1) an electronically scanned copy of a fully signed and initialed un-modified Vancouver Host City Agreement (the "Un-Modified Host City Agreement"), and
- (2) an electronically scanned copy of a letter from our legal counsel to you which is being couriered to you with the "Replacement Bid Pages" as that term is used in the attached letter.

The Replacement Bid Pages will be delivered to you in trust and on the express conditions set out in the attached letter. The attached e-copy of the Un-Modified Host City Agreement ("E-UHCA") is now delivered to you in trust and on condition that you not deal in any way with the E-UHCA except in accordance with the following trust conditions (the "E-UHCA Conditions"):

- (1) That the E-UHCA may be printed, copied and packaged with the other bid documents required to submit the Bid, provided always that you retain complete personal control over all paper and electronic originals and copies and do not submit same to FIFA (or any other third party) without subjecting them to these E-UHCA Conditions except as and when (and then only on such conditions) as are articulated by us to you in writing.
- (2) That in the absence of our express written consent to include the E-UHCA in the Bid upon submittal to FIFA, you will remove and delete the E-UHCA from the Bid prior to submitting same to FIFA or, if expressly permitted by us (and consented to by you), submit same to FIFA or such other third party authorized by both of us on such terms and conditions as are set out by us in writing to you.
- (3) That if any of the above conditions are not acceptable that you contact us immediately to make arrangements for the deletion of this e-mail and all known copies of the E-UHCA and proof of such destruction.

We trust you will find the enclosed and above to be in order and look forward to working with you to move this matter forward towards a successful Bid submittal.

Q: Why was Vancouver not included in the final bid book as one of the 23 candidate host cities?

## Canada Soccer and United Bid Process

- Canada Soccer is very disappointed to not continue the legacy it created with the hosting of the FIFA Women's World Cup Canada 2015™ and the 2012 CONCACAF Olympic Qualifying Tournament in the city of Vancouver.
- In Canada, nine cities were approached in July 2017 by Canada Soccer with the relevant information on the United Bid for the 2026 FIFA World Cup™.
- Of the nine cities, seven expressed an interest to receive the Request for Information documentation which was submitted to the United Bid Committee on September 5, 2017. Of the original nine cities approached, Hamilton, ON and Winnipeg, MB did not continue in the process. In total, 44 cities in Canada, Mexico and the United States received the information to begin the process of being considered as a Candidate Host City in the Bid Book. Canadian cities at this stage included:
  - o Calgary, AB
  - o Edmonton, AB
  - o Montréal, QC
  - o Ottawa, ON
  - o Regina, SK
  - o Toronto, ON
  - o Vancouver, BC
- Six of the seven Canadian cities completed the Request for Information with Calgary, AB exiting the process. At this stage, there were a total of 41 cities involved in the process across the three countries.
- From the reduced list of six Canadian cities, only four Canadian Candidate Host Cities continued in the process and were announced with a total of 32 Candidate Host Cities on October 4, 2017. The four Canadian cities were Edmonton, AB; Montréal, QC; Toronto, ON; and Vancouver, BC.
- FIFA provided the bid regulations in mid-October 2017 and these were subsequently shared will all Candidate Host Cities on October 27. A webinar was held on November 2 to review the documents in advance of the Host City Workshop held in Houston, November 13-17, with all four Canadian cities in attendance.
- Over the past three months, weekly meetings have taken place to ensure the most relevant and updated information was shared for the United 2026 Bid to move forward within the expected timeline established by FIFA.
- A FIFA Legal meeting was hosted by Canada Soccer on behalf of the United Bid Committee on February 15 with all four Candidate Host Cities participating.
- All necessary FIFA agreements were required to be completed in advance of the bid book submission to FIFA by March 16, 2018.
- In total, 23 Candidate Host Cities have signed the necessary FIFA agreements and met the United Bid Committee deadlines with three Canadian cities included in the final Bid Book (Edmonton, Toronto and Montréal).
- FIFA will make the final selections of Host Cities in June 2020.

# Vancouver Process

• The Province of British Columbia did not provide the necessary signed FIFA agreements within the required timelines for inclusion within the Bid Book and as such the city of Vancouver will not be

- In Vancouver, City Council unanimously voted in favour of Vancouver being a Candidate Host City on January 30, 2018.
- As part of the submission to FIFA, a host city stadium agreement is required to be signed. The
  proposed venue of BC Place is owned by the Province of British Columbia and as such required their
  signature.
- In 2015, the industry output for the Province of British Columbia through the hosting of the FIFA Women's World Cup Canada 2015™ was \$118.8M with \$82.9M in the City of Vancouver with nine matches held at BC Place.
  - 99% of Vancouver hotel rooms were full during the competition.
- The legacy of the tournament also included two new FIFA 2-Star training sites at Empire Field.

Q: Can Vancouver still be considered as a Candidate Host City once the United Bid Book is submitted without them included?

- The United 2026 Bid Book has been submitted with three Canadian Candidate Host Cities and those three will continue in the process. Vancouver is no longer part of that process.
- Q: How will this removal impact the future of the sport in Canada?
  - Canada Soccer thanks all of the Canadian cities that have shown an interest in playing a role in the United Bid for the 2026 FIFA World Cup™.
  - We are grateful to the Government of Canada for their support of the competition and look forward to working with them and all levels of government to ensure that the United Bid is successful in securing the right to host the competition.
  - We are pleased that three Canadian cities have made it past the goal line and are officially Candidate Host Cities as part of the 23 cities in Canada, Mexico and the United States that are part of the United Bid.
- Q: What could have been done to prevent this from happening?
  - The expedited process required all Candidate Host Cities to meet the same timelines and provide the necessary documentation.
  - Of the 32 Candidate Host Cities announced in October 2017, 23 were able to meet the deadlines and provide the FIFA agreements to be included with the Bid Book including three other Canadian cities.

# City of Vancouver Statement:

The City is extremely disappointed that Vancouver's bid to be a FIFA 2026 World Cup Host City is currently not being considered as we believe hosting the biggest sporting event on earth would have offered significant economic benefits. Vancouver remains a city with an exceptional sports hosting history and we look forward to working with the Province and our Sport Hosting Vancouver team to identify future international sporting events that bring positive economic and cultural impact to Vancouver.

# Mayor Robertson Statement:

"I'm disappointed to hear that the bid to bring the 2026 World Cup to Vancouver will not be proceeding.

Major sporting events often have challenges around costs and managing financial risk; however, the City was all-in and hopeful that the federal and provincial governments would be able to arrive at a fair deal. While I'm disappointed by this outcome, I look forward to pursuing further opportunities to bring world-class soccer and other sporting events to Vancouver in the future."

Province of British Columbia Statement:

Lisa Beare, BC's Minister of Tourism, Arts and Culture, made a statement regarding the possibility of Vancouver's involvement as a potential host city on Wednesday:

"The prospect of hosting the FIFA World Cup is exciting for soccer fans, and has the potential to bring significant economic and cultural benefits to British Columbia. For the past several weeks, our government has been working diligently with the United Bid Committee – consisting of Canada, the United States and Mexico – to bring the 2026 Cup to Vancouver, as one of the committee's Canadian host cities.

"While we support the prospect of hosting the World Cup, we cannot agree to terms that would put British Columbians at risk of shouldering potentially huge and unpredictable costs.

"Throughout this process, we have been in regular contact with the bid committee and other levels of government to support this bid, while protecting taxpayers. Through these conversations and our submissions to the bid committee, we have made numerous attempts to clarify the risks and obligations faced by British Columbians.

"So far, the bid committee has rejected our requests to clarify how much British Columbians could be expected to contribute. And they have declined to negotiate with the province regarding the concerns we raised.

"Should the bid committee reconsider, our door remains open to bringing some of the 2026 World Cup games to Vancouver."

We will also reference that the inclusion of our four Candidate Host Cities from Canada will be done on Thursday, March 15.

# FACT SHEET Canada Soccer/United Bid Committee March 2018

Key Messages of the United 2026 Bid: Unity, Certainty, Opportunity.

- Our vision is simple: Together, we offer FIFA an unprecedented, *united* opportunity to stage the *new* 2026 FIFA World Cup™, with 48-teams and 80 matches, with a low risk operational *certainty* that is only exceeded by its *opportunity* to economically embellish and propel global football forward for years to come.
- There are three great nations in our bid: Canada, Mexico and the United States. Each of our nations has its own strengths and challenges no country is perfect, nor should it pretend to be; but together we are stronger. Our unity sends a positive message to the world when it is needed most. That's good for football everywhere.
- We are neighbors with shared borders, cultures and values and we've never been more united than for this bid.
- We firmly believe and trust that FIFA and the 211 Member Associations will judge us, and our competitor, on the quality of our bids, not on the politics of the moment.
- Our bid is historic because it's three nations coming together for the first time ever it's an
  unprecedented display of unity and a huge opportunity for global football to lead the world at a
  time when displays of unity are needed most.
- Canada, Mexico and the United States have hosted a total of 13 FIFA events (Men's, Women's, and Youth World Cups and the Confederations Cup), which is more than any other trio of geographically connected nations and set attendance records for five of those events.
- It has been 32 years and seven FIFA World Cups™ have occurred since the last one was held in the Concacaf region in 1994 when the United States hosted.

## United 2026: Canada

- Canada is the only G7 country in the world to have not hosted a FIFA World Cup.
- Canadian fans are regularly within the top ten of all FIFA member associations to attend the FIFA World Cup™ and were number one of non-participating member associations in 2014.
- Canada is a welcoming country with the highest proportion of foreign-born population of all G7 countries (20.6%). All three bidding nations have had immigration as a building block and this is our chance to say thank you to the world.
- Over a quarter of a million newcomers from around the world are welcomed to Canada annually representing close to 200 countries.
- Opportunity extends beyond matches with an eight year build up to the competition and a legacy that will include alignment of the Men's National Team Program, creation of base camps, and infrastructure improvements.
- There are four Canadian Candidate Host Cities:
  - o Vancouver, BC
  - o Edmonton, AB
  - o Toronto, ON
  - o Montréal, QC
- Canada is ready to partner with our friends in Mexico and the United States and has a history of success in raising the bar for youth and women's FIFA tournaments:
  - FIFA Women's World Cup Canada 2015™ (1.35M spectators/close to \$500M economic impact)
  - o FIFA U-20 Women's World Cup Canada 2014
  - o FIFA U-20 Men's World Cup Canada 2007
  - FIFA U-19 Women's World Championship Canada 2002 (47,000+ spectators at Final for largest attendance at a FIFA Youth Competition)
  - FIFA World U-16 Championship Canada 1987
  - Olympic Football Tournament Montréal 1976

For the past several weeks, our government has been working diligently with the United Bid Committee – consisting of Canada, the United States and Mexico – to bring the 2026 Cup to Vancouver, as one of the committee's Canadian host cities.

"While we support the prospect of hosting the World Cup, we cannot agree to terms that would put British Columbians at risk of shouldering potentially huge and unpredictable costs.

"Throughout this process, we have been in regular contact with the bid committee and other levels of government to support this bid, while protecting taxpayers. Through these conversations and our submissions to the bid committee, we have made numerous attempts to clarify the risks and obligations faced by British Columbians.

"So far, the bid committee has rejected our requests to clarify how much British Columbians could be expected to contribute. And they have declined to negotiate with the province regarding the concerns we raised.

"Should the bid committee reconsider, our door remains open to bringing some of the 2026 World Cup games to Vancouver."

Horgan: I don't know how we can predict that. We haven't really begun any cout proceedings that I'm aware of so I don't know if the costs are significant or not.

Reporter: On the FIFA bid, can you explain to us what's going on here? Has BC said that the province will not participate in a bid to have potential World Cup games in 2026 at BC Place?

Horgan: We haven't said that at all but we have been grappling with the proponents who want us to sign a blank cheque, a conditional agreement that could be changed by FIFA but not by us. I'd love to see soccer games at BC Place. I've said quite clearly to the proponents bring it on, let's bring soccer to Vancouver in 2026. But let's also ensure that the costs to taxpayers are not out of control. The federal government announced today they support the bid in principle but they didn't say anything about the cost of security, they didn't say anything about the indemnities that the province has to put in place, unlike other cities in Canada, because we own the stadium.



The Canadian government announced its support Tuesday for the North American bid for the 2026 World Cup, but it's unknown whether Vancouver will be a part of it.

"It's a great opportunity, as we know. But it also comes with potential risks, so we're looking at those risks and going to make a decision that's in the best interest of B.C. taxpayers," said Lisa Beare, minister of tourism, arts and culture.

The provincial government owns B.C. Place, the only site in Vancouver where potential World Cup games could be played.

The official deadline for the 2026 World Cup bid - jointly submitted by Canada, the United States and Mexico - is March 16, and Vancouver was short-listed as a host city last year, along with Edmonton, Toronto and Montreal.

FIFA will choose between the North American bid and Morocco this June. It's expected Canada would host 10 games, likely at two cities, if the bid was successful.

But B.C. Liberal MLA Jas Johal alleged in question period that an internal deadline to be part of the bid passed on Monday - something which Beare would neither confirm or deny.

"We're still in contact with the bid committee," she said.

"B.C. residents loves soccer, as do we at the province. This is of course something fans would be looking forward to, but we have to take a look at all the opportunities surrounding it and all the risks surrounding it."

A request for comment by Soccer Canada was not immediately returned. [zpz, tacz]



To the Vancouver – Host City Bid Advisory Group,

Over the past 8 months we have been working united with our Candidate Host City Bid partners from across Canada with the overall goal and objective to successfully get Canada across the goal line of being a part of the 2026 United Bid submission.

We successfully submitted all the necessary bid documents that contributed to the narrative and vision for hosting a World Cup in our city. In addition, as part of our submission we were required to submit 4 legal agreements that required support from all 3 levels of government. The expedited process challenged the review of these documents for all parties to agree to terms that they were comfortable with in moving forward. The Government of Canada provided their support in principle to the hosting of the FIFA World Cup in Canada, but was not able to confirm the specifics related to security and the potential cost sharing model for expenses occurred with essential federal services at this stage.

Unfortunately, that meant we were not able meet the requirement of signing our Vancouver bid agreements unmodified to be included in the 2026 United Bid book before the deadline.

As a City we are still encouraged to continue our dialogue with the United Bid Committee and Canada Soccer to be considered a training site should the 2026 United Bid be successful.

Thanks to everyone for your support and guidance through this process, it will not be lost. I'm encouraged with the learnings of this experience, and look forward to speaking with the Province of BC and our bid partners on identifying major international events that we can bid on together in the near future.
