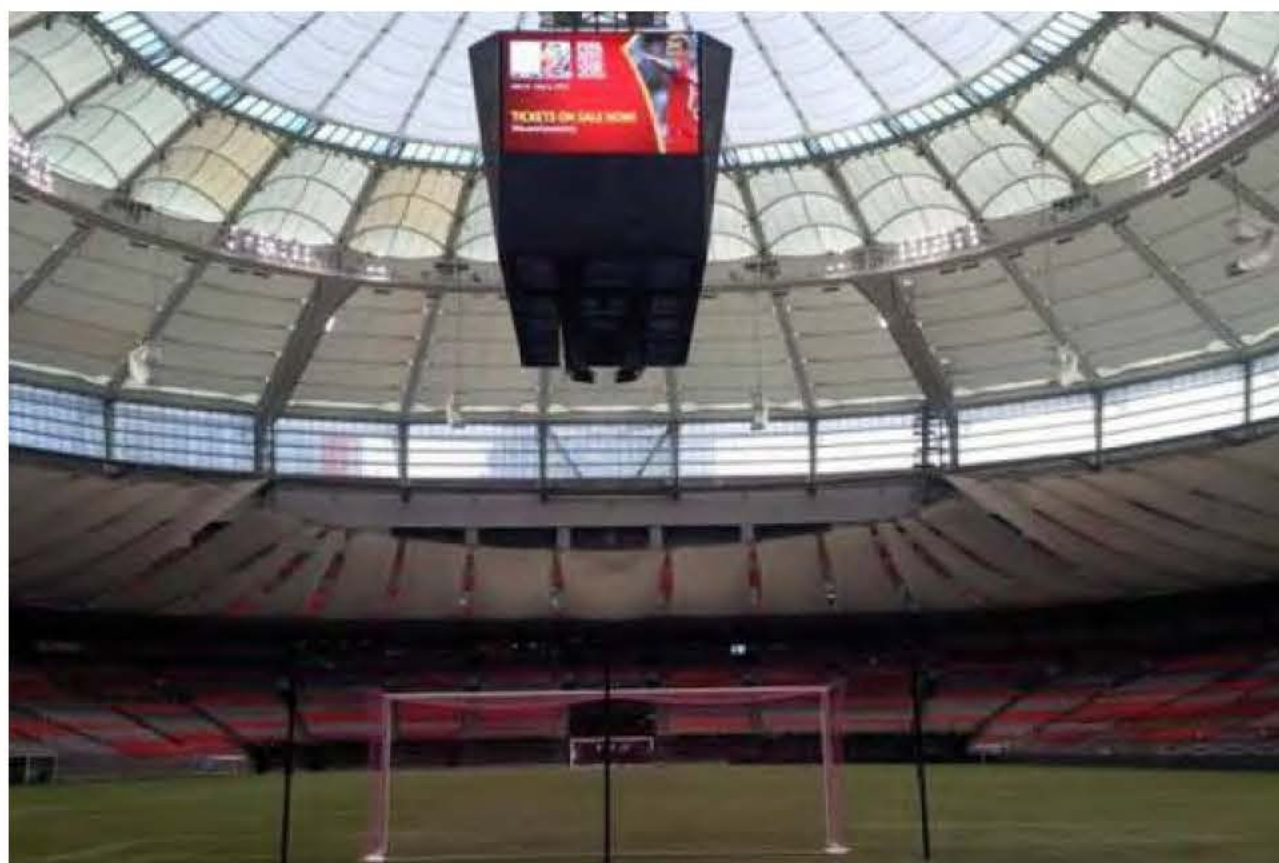

B.C. may pull Vancouver as a potential FIFA World Cup host city

The provincial government is considering pulling support for Vancouver as a potential host for games in the 2026 men's FIFA World Cup.

BC Place Stadium is one of the potential locations to host soccer games if the unified North America bid wins the right to host.

"B.C is taking a look at the opportunity. It is a great opportunity as we know. But it also comes with potential risks. We are going to make the decision that is in the best interest of taxpayers," said Tourism and Sport Minister Lisa Beare.

"We are still in contact with the bid committee."

But BC Liberal MLA Jas Johal said he has been told that B.C. has backed away entirely. What the government needs to sign on to is a stadium agreement for the provincially-operated BC Place.

"It's a tremendous opportunity for exposure, not just for British Columbia, but for dollars for our tour operators and hotels," said Johal.

"It's concerning because there have been many months, even years put into this." On Tuesday, the federal government committed \$5 million to support Canada's part of the unified bid. Canada, Mexico and the U.S. are up against Morocco to host the men's soccer showcase.

Their bid books go to FIFA at the end of the week with a decision to be made at the FIFA congress on June 13.

The potential costs for British Columbia include the use of BC Place, the conversion of the field to natural grass as well as potential policing and security costs.


The unified bid plan calls for 10 matches in each of Canada and Mexico. Another 60 games would be held in the U.S. in the new-expanded 48-team tournament format.

The tournament would have 80 games in total.

Beare would not say whether B.C. missed a deadline, or what the deadline is for Vancouver to be included in the official bid book. Edmonton, Montreal and Toronto are all expected to put themselves forward as potential host cities.

"This is, of course, something fans will be looking forward to, but we have to be looking at all the opportunities surrounding it and all the risks surrounding it,"

Subject: Confidential: United 2026 Announcement tomorrow

Good evening all,

Please keep the following information confidential until 6 AM PST tomorrow.

We have been made aware that Heritage Canada is holding a media conference tomorrow to announce the Federal Government's support of the United Bid to host the 2026 FIFA World Cup™.

The media conference tomorrow is scheduled for 9 am EST (6 am PST) at BMO Field in Toronto and will feature the Minister of Sport and Persons with a Disabilities, Kirsty Duncan, Peter Montopoli and Councillor Mark Grimes from the City of Toronto. The Government of Canada will be issuing a media release. Canada Soccer will amplify but not issue its own release.

As all four candidate Canadian Host Cities (Vancouver, Edmonton, Toronto and Montreal) are still working towards the ultimate goal of inclusion in the United Bid, no one candidate host city will be mentioned in isolation in any of tomorrow's messaging, but all will be referenced as a collective. It will also be announced tomorrow that the final list of candidate host cities included in the United bid to FIFA across all three countries will be announced on Thursday March 15th.

Our draft messaging for your information is outlined below:

- ☐ The City of Vancouver welcomes the Federal government's support of the United Bid to host FIFA 2026 World Cup matches and training camps in Canada.
- ☐ All four Canadian candidate Host Cities are continuing to collaborate and work together to win the bid for Canada, and do not currently see each other as 'competition', rather allies to meet the expedited process deadlines.
- ☐ The City is continuing to work with its bid partners and looks forward to Thursday's announcement by the United Bid Committee of the host cities that they will be including in the bid. We believe that Vancouver's sport hosting history is exceptional, having successfully hosted many international sporting events, most recently the HSBC Rugby World Sevens Series, and the 2015 FIFA Women's World Cup which generated industry output of \$82.9M in Vancouver.

With the deadline to submit the bid to FIFA fast approaching (March 16) we welcome the federal announcement. As candidate host cities, we are still working to clarify our terms and conditions but see this federal announcement as a positive step in the right direction.

We will not be taking media requests for interviews following tomorrow's announcement, but instead using the above statements as required. If you receive any direct inquiries – please forward them to Ellie Lambert (City of Vancouver, Communications Manager) – ellie.lambert@vancouver.ca

VICTORIA _ Premier John Horgan says he would like to see World Cup soccer games at B.C. Place in Vancouver, but not at any price.

The federal government gave its support to the North American bid for the 2026 World Cup on Tuesday.

It is promising up to \$5 million in immediate help should the unified bid win.

Canada, Mexico and the U.S. are up against Morocco to host the men's tournament, with a decision coming in June.

Toronto, Vancouver, Montreal and Edmonton have been identified as potential candidates for hosting games.

Horgan says he wants some guarantees on the cost for the province before signing an agreement.

"We have been grappling with the proponents who want us to sign a blank cheque, a conditional agreement that can be changed by FIFA (soccer's governing body) and not by us," said Horgan. "I'd love to see soccer games at B.C. Place. I've said to the proponents: 'Bring it on, let's bring soccer to Vancouver in 2026.' "

But Horgan said he also has a responsibility to protect taxpayers' money.

"Let's also ensure the costs to taxpayers are not out of control," he said. "I have a higher obligation than just being a soccer fan. I have a higher obligation than just wanting to see World Cup soccer in Vancouver."

The Liberals criticized the provincial government for not backing the bid. Legislature member Jas Johal says the government's "dithering" could mean B.C. loses an opportunity to help host the event.

Lynda Steele: Let's check in with Sophie Lui over at Global News.

A couple of things I want to talk to you about. First of all, can we talk about what's going on with the World Cup? There's all of a sudden of bunch of rumours floating around, everybody running around.

Sophie Lui: It's a good question. There was a bit of an odd scrum, a little media availability with the Tourism minister, Lisa Beare, in Victoria earlier today, where she was asked about BC's commitment to the World Cup bid. She kept saying it was an exciting opportunity but we have to weigh the risks involved. Reporters were asking her, well, isn't there a deadline? We were told there was a deadline of last night to throw your support behind the bid. She wouldn't answer that question. So it was a little odd.

Steele: Uh-oh!

Lui: It was very odd. So later on, a little more clarity from the Premier, John Horgan. He had a media availability. He said: we're not willing to sign a blank cheque over to FIFA; we love soccer, we'd love to see world-class soccer at BC Place, but we don't want to sign over a blank cheque; we've got to be responsible to the taxpayers too. So he says that they have until Friday to decide whether or not they want to be involved in this joint bid between Canada, the US and Mexico. We'll see what happens Friday, I guess.

But Jas Johal, the Liberal MLA, and former colleague at CKNW and at Global, has said that he's heard that it's pretty much a done deal that BC is not going to be a part of this.

Steele: Really?

Lui: And he was a crack reporter at one point. He's got some sources.

Steele: That would be devastating news on a lot of fronts -- first of all, soccer fans, because that's a huge event. But also, think about the potential economic impact, all the businesses, hotels, restaurants, you name it.

When is that event supposed to take place?

Lui: So 2026 is the World Cup that Canada, the US and Mexico are teaming up on for that bid. Canada made an announcement today. The federal government made an announcement today that it's putting in \$5m right now to support the bid. Obviously, if we win the bid and win the World Cup, then I'm sure we'll see more money. It's a good question: how much money will it cost taxpayers, and what is the economic benefit? We certainly saw a lot of economic benefit, and a lot of costs, when Vancouver and Whistler staged the 2010 Winter Games.

Steele: Absolutely.

Lui: But as has been pointed out to me today, the Olympics and the World Cup and the way our World Cup bid stands right now would be different things because Vancouver would be just one city in North America that would be potentially hosting games. Canada is supposed to get 10 games, Mexico is supposed to get 10 games, and the US is supposed to get 60. What games would we see in Vancouver?

Steele: What would that cost, though? We already have the infrastructure.

Lui: We do.

Steele: Presumably they play at BC Place. You're not building any big facility.

Lui: To put in proper grass, actual grass into BC Place, is one cost. I don't know how much that costs. If you weigh that against the economic benefit, I think you probably see a bigger benefit. But security is a cost. I suppose that would be something that we would have to consider. I don't know what that is. No one seems to know how much that would cost. But the Olympics were fun. Putting money aside, it was fun.

Steele: I missed the Olympics. It makes me so sad. I just barely missed the Olympics here. [xrz]

Reporter: [inaudible]

John Horgan: Again, I can't determine what citizens will do. Mr Wilson's charted a course, the issue's before the courts. All citizens have recourse to go to the courts and we'll just have to see how it plays out.

Reporter: [inaudible]

Horgan: I don't know how we can predict that. We haven't really begun any court proceedings that I'm aware of so I don't know if the costs are significant or not.

Reporter: On the FIFA bid, can you explain to us what's going on here? Has BC said that the province will not participate in a bid to have potential World Cup games in 2026 at BC Place?

Horgan: We haven't said that at all but we have been grappling with the proponents who want us to sign a blank cheque, a conditional agreement that could be changed by FIFA but not by us. I'd love to see soccer games at BC Place. I've said quite clearly to the proponents bring it on, let's bring soccer to Vancouver in 2026. But let's also ensure that the costs to taxpayers are not out of control. The federal government announced today they support the bid in principle but they didn't say anything about the cost of security, they didn't say anything about the indemnities that the province has to put in place, unlike other cities in Canada, because we own the stadium.

Reporter: [inaudible] what the deadline is? This bid is due on Friday. Vancouver would no doubt have to be in or out of that bid by Friday. So can you explain to us the deadline and what will ultimately [inaudible] that final decision?

Horgan: We've sent a draft submission to the proponents last week; didn't meet their expectations but I have a higher obligation than just being a soccer fan. I have a higher obligation than just wanting to see World Cup soccer in Vancouver. I have to make sure that taxpayers aren't on the hook for unknown costs at the whim of FIFA. I'm just not prepared to sign off on that and nor is the Minister of Finance. We're going to continue working with the proponent throughout the week but I think that they have to be responsible as well and understand that as much as we would love to see soccer coming to Vancouver, coming to BC, world class, not at any cost.

Reporter: [inaudible]

Horgan: Firstly, Carole James was very clear on budget day that we were going to aggressively tackle speculation in our real estate market. We have a 30-point plan, a bold plan, to bring on more supply, to tackle demand, and also ensure that there's security of residency for those that are renting in BC right now. So that's the plan. The budget had conservative revenue forecasts and very generous contingency funds and forecast allowances, so these are issues that can be managed over the course of the year and that's what budgets do all the time.

Reporter: [inaudible]

Horgan: I don't believe so. I think we have to go back to first principles, Rob, and the first principles were we had a runaway housing market and we needed to tamp down speculation in that marketplace. That's what we campaigned on, that's what the public asked us to do, and that's what we're doing. When it comes to the implementation of the tax we're doing exactly what we said we would do as well. Carole James said not yesterday, not last week, but on budget day that there were going to be implementation issues as we go forward. This is the first time something like this has been tested and we're listening to people, my constituents, we're listening to editorial writers, we're listening to opposition members.

We want to make sure that we get this right and I think we're being prudent and we're being responsible and with respect to revenue forecasts from any speculation tax they are conservative already, by design, and we have very generous other allowances that will make up for any shortfall as we move the tax to its final form this fall.

Reporter: [inaudible]

Horgan: I haven't read the bill yet. I'll take a look at it and we'll have a discussion with not just members of the House but our constituents. The House rises this week for a break. This is an ideal opportunity for people to go back and talk to their constituents. If there's an overwhelming desire to move the voting age down I'm more than happy to do that.

Reporter: [inaudible]

Horgan: I'm focusing on a whole range of other issues right now. We have a whole bunch of changes to the election act with respect to the system of selecting members. I think I'm going to focus on that right now as we put forward a question for the public to answer with respect to our voting system. That's my number one priority right now. The voting age is important to Andrew Weaver. He's brought forward a private member's bill. I'll take a look at it.

Reporter: [inaudible]

Horgan: Not at all. Part of the agreement was to look at that as a pilot project, but also part of our election campaign was to bring in a poverty reduction plan to BC, the only province in the country that doesn't have a poverty reduction plan. And this may well be a component part of that. Minister Simpson is working diligently. I have every confidence that he can make it work within the parameters of his budget, and the mandate letter that I've given him. He'll do that.

Reporter: (Inaudible)?

Horgan: You have to look at it before you do it. Again, governments assess the situation they find themselves in all the time, and that's what we're doing as well. We're taking a stock of where we are, what our capacity is, fiscally, what the demand is within the community, and then you implement programs. This is, again, what governments have been doing since we've been forming governments.

Reporter: (Inaudible)?

Horgan: I'm not sure, I can't confirm that, but certainly there was a request for an indemnity.

Reporter: (Inaudible)?

Horgan: Because I want to seek advice from the Attorney General on that. He would be the better person to ask that question.

Reporter: (Inaudible)?

Horgan: There's a new chair at BC Hydro, a well respected chair. He's taking stock of the executive, he's taking stock of the caliber of the board members, and we're going to be replacing board members as their terms expire.

Reporter: (Inaudible)?

Horgan: Chris O'Riley is acting in that position. He is a career employee at BC Hydro. He knows the system very, very, well. I have confidence in him. But, again, that's a board decision, and I'll await the decision from the board.

Reporter: (Inaudible)?

Horgan: Our intention, Vaughn, was to get speculation out of the marketplace, and we're doing everything we can to bring down costs for BCers. An affordability agenda was what we campaigned on and affordability is the focus of the 30 points that we've brought forward when it comes to housing. Minister James has been abundantly clear, I believe, on the day of the budget, and, as recently as today, that she's listening to BCers. We're hearing what they have to say and then we'll make changes as required and implement legislation in the fall, which was the plan from day one and continues to be the plan.

Reporter: (Inaudible)?

Horgan: I can say with absolute certainty that Carole James will make the final determination on that Minister of Finance. And I have every confidence that she will take what steps are necessary to make sure that we do what we campaigned on and that's to reduce speculation, implement a speculation tax to do so, and I have every confidence that it will be fair and just for BCers.

Reporter: (Inaudible)? No, I don't think it's at odds with that. I think it's part and parcel of the process that's been underway since the budget was tabled. We've been reaching out and talking to people. I spoke to the board of trade, I've spoken to other organizations, and I've heard what they've had to say about this issue, as has the Minister of Finance.

Reporter: (Inaudible) Alberta premier (inaudible) turn off the taps for oil to BC (inaudible)?

Horgan: I think that I'm going to focus on the issues that matter to BCers and are within my jurisdiction. I'm testing the jurisdiction of one of those issues right now through the courts, and Ms Notley can take care of business in AB to the extent that she believes that she has to take on BCers, that's her right. I would prefer to see people coming together. I'd prefer that our federation was a cooperative one, a consensus-driven operation, not a subservient federation.

Reporter: (Inaudible)?

Horgan: I believe that if we can get more people involved in politics that's a good thing. I spent a lot of time talking to high school students when I was a regular member of the Legislature when I was leader of the opposition, and as Premier. And I believe that young people are very, very, much focused on learning and understanding our political process. We want to see participation rates in every demographic go up.

The recent information tabled by the chief electoral officer demonstrates that there are areas that are declining in participation. But I do know, in my own family, and myself, if you start voting as soon as you can, you'll probably vote for life. If you put it off and put it off and put it off, you may not ever get into a voting group. So I'm going to look at Mr Weaver's proposal and we'll talk to the House leader and see if it fits.

Reporter: Back to the speculation tax. We know the legislation's in the fall. I'm sure everybody here is getting the same e-mails from people expressing concerns about their vacation properties. Is it fair when everybody basically is kept hanging waiting for an outcome here (inaudible) clarity sooner than the fall, in terms of which way this tax is going to go?

Horgan: I'm confident that the Minister of Finance wants to provide clarity as quickly as possible, but we also want to make sure that we're hearing from everyone. We're not just getting correspondence from people who don't like the tax, we're getting an overwhelming amount of correspondence from people who think it's a great idea. And I think that is important for you and for all of us to go back to first principles. We have an

affordability crisis largely in the Lower Mainland, but percolating through to other parts of the province as well. And that was the motivation here.

That was what people asked of us. Recent polling, and, again, I know we have to take all these things with a grain of salt, but you've seen these numbers. Housing is at 50%. The number one issue for people and has been consistently for months. It's not because we're talking about and you're talking about it, it's because everyone's talking about it. We've put forward a plan to address it. We're going to take advice from people both that are in favour and those that are opposed and we're going to have as comprehensive a plan as possible starting with legislation in the fall.

Reporter: (Inaudible) clarity on that issue of vacation properties before the end of the session?

Horgan: There's every chance of that, yeah. [sss, pjjh, mjag, jtst, tacz, fin, maz, env, empr]
