**RE: Request for Access to Records under the Freedom of Information and Protection of Privacy Act (the "Act")**

I am responding to your request of June 1, 2018 under the *Freedom of Information and Protection of Privacy Act* for:

1. **Any information on file which pertains to the Easement and Indemnity Agreement 220602M, including letters of correspondence, memos, legal documents or opinions, drawings, and Engineering documents or files related to the property at 1574 Kingsway, Vancouver (Easement and Indemnity Agreement is registered on title to Lot 1 and Lot 2, Plan 2170) Date Range: January 1st, 1945 to November 5th, 1947; and**
2. **Confirmation whether the City still requires this Easement and Indemnity Agreement or whether there is a process for releasing it from title. Date Range: January 1st, 1977 to December 31st, 1978.**

We received your clarification regarding the date range for this request; however, the search for responsive records has been completed and no responsive records have been located.


Land Survey confirmed there were no records in their department on this address or subject. Archives research staff confirmed that they do not have any architectural plans for this address, nor do they have related easement and indemnity agreement records from the Legal or Engineering Departments. Archives advised, however, that you would be able to conduct a general property and building history research (e.g. water service records, building permits, fire insurance maps).
