Hi Sandra,

An update on the status of the QET Plaza Naming and a follow up from the VCT board meeting where Ginger and Spencer made a presentation --

The Joint Naming Committee made up of Musqueam, Squamish and Tsleil-Waututh representatives will be designating two new names next week, one in each of the local Indigenous languages, as approved by their respective Nations. Following this, the City will move forward with the names identified by MST for QET Plaza. Indigenous language naming for the Vancouver Art Gallery north plaza has followed the same process.

Local Indigenous language names for both VAG north plaza and QET Plaza will be announced June 18 in a ceremony led by MST and that will informally kick off the week that culminates in National Indigenous Peoples Day. Event details and invitations forthcoming.

The City is developing communications materials including a short video to provide context, meaning and pronunciation of the Indigenous language names. We will make these materials widely available to everyone including VCT staff and board.

We can help communicate this to the VCT board as appropriate. Let me know if you have any questions.

Council Naming Committee Meeting 5

Thursday May 17th 2018

City Hall - Protocol Board Room

1. QET & VAG Name Discussion:

Larry Grant(LG): šx̣ẉlexən - the place that you're invited.

Khelsilem(K): There's a slight translation difference between Sḳwx̣ẉú7mesh and hən̓q̓əmin̓əm̓. In Sḳwx̣ẉú7mesh, it's verb for party, feast, dance, modern dance.

The different between the Sḳwx̣ẉú7mesh and hən̓q̓əmin̓əm̓ meaning is like the difference between the meaning of the word 'lingerie' in English and French. It means something lightly different in each language.

K: We often don't put a nominal S (š) on our place names. It would work without the S.

K: x̣ẉ in hən̓q̓əmin̓əm̓ means to move towards. In Sḳwx̣ẉú7mesh, it's an abbreviated form of (ne) x̣ẉ (thing are happening at a place all the time)

GG: Gathering means that there's an exchange happening. When we gather up, whoever's leading it will amass wealth and distribute it, it's an exchange of information, e.g. we're passing down a name. In the exchange there's a healing. Culture around the arts is healing.

GG: It's deeper than just inviting people to gather. You want them to come help you to fix you in a sense.

LG: It's the place we were invited to for the Walk for Reconciliation. We should tell the history for people who weren't there. This is where people were.

K: we need to figure out how to acknowledge both meanings. In Sḳwx̣ẉú7mesh it's a place of (party, feast, celebration) it's a verb in Squamish. Birthday party, when you add the s, it's a person who's invited to it, a guest to it. The nominal S lines up with hən̓q̓əmin̓əm̓, but the verb doesn't.

LG: no s to invite in hən̓q̓əmin̓əm̓, s the place of the invited people. Place where the invited ones are.

K: "invited to celebrate place" "place on is invited to celebrate"

LG: The other important message is that we are still part of the four host nations, being together, if there's a difference in our words, it's just how it is.

AR: this is an opportunity for learning, a big opportunity.

QET Plaza Names

- hən'qəmin'əm: xʷłəxən "a place one is invited"
- Skwxwú7mesh: Xwtl'ashn "invited to celebrate place" "A place on is invited to celebrate"

GG: QET Plaza signs should talk about how the reconciliation walk happened there, the apology. For people who are new to Vancouver, the significance of the reconciliation walk.

LG: There should be a blurb about the TRC that's why it's happening. What's going on here why are we doing it?

K: Signage must include "cultural genocide." Policy is cultural genocide.

LG: TRC focuses on Residential school, but it's more than that.

GG: Include pictures of the Walk for Reconciliation.

LG: The (2013) rainy day pictures speak to the willingness of people to come out. Signage should read: "This was the location of the historical Walk for Reconciliation".

AR: Roots of the walk was City of Vancouver's City of Reconciliation proclamation, which covers smallpox and others.

LG: We don't talk about it. We talk about massacres in other places around the world. Cultural genocide that was deliberately done, and allowed children to be killed. We hear stories about soldiers killing children in other places, but we don't talk about the thousands of kids who never saw the outside of the Residential school.

Rena Soutar (RS): We're dealing w a lot at parks. We're getting into bigger issues. We would like to see more talk about wider issues, e.g. potlatch ban, fisheries act. We're looking at some projects that start some dialogues, I'm hearing desire to explore these, and I want to mention that this isn't the only other opportunity. There will be more to come.

GG: re: messaging - what that means going forward for that space. This is a place where we're going to have celebrations, we're going to invite people in the future.

2. VAG Name Discussion

LG: I suggest we change łənəq to xʷłənəq. It eliminates using other English words after it [square]. It's all said in that word. It is the place where you potlatch.

Gabriel George (GG): You pronounce ʔ as a T with an l release on the tip of your tongue.

Spencer Lindsay (SL): How do you define xʷə́ənəq? Place of cultural gathering?

LG: All depends what we mean by culture, what does culture mean, you get up in the morning put clothes on get dressed cook breakfast, get on bicycle, sing a song on the way to work say a prayer, or boogie, it's culture, all of it is culture, it's not ceremonial culture.

LG: Re: putting "square" after the name. It's only because in euro-western culture that everything's put in a box.

K: To me, square relates to the centre of town. I wouldn't add English to an existing place name. e.g. I wouldn't call it I7iyálmexw Park, it would just be I7iyálmexw. But I think we should add Square to Tl'é enḵ because it's a new place name we're creating.

SL: I presented to the Block 51 Stewardship Advisory Committee and they wanted to know if there would be any restriction on the plaza given the new name.

LG: No. To put restrictions on a place, we would become part of the colonial system.

RS: We're working on NEFC park and trying to decolonizing the way designers see the space their designing. When we present the new design ideas, some people are saying that designing for FN is exclusionary.

K: Parks have a culture, they have guidelines, policy. Just so happens in our community we have them, but they're just different. If you were to book the longhouse, you'd have restrictions.

AR: How do we roll out an educational plan, but while not seeing it as a burden?

LG: Learning another way of getting along.

K: re: how interact w communal space - CP title holders like their property. Then we have park, longhouse, community centres, river. But we very much have adopted private property. Land and chieftainship are big conflicts.

RS: VAG was a space of colonial authority.

3. Communications Material Approval

SL: Who should approve Communication materials?

- Tsleil-Waututh: chief and council - email to council via Sarah Thomas
- Tracey Williams at Squamish. There will be a new language and cultural affairs dept, centralized.

- Musqueam: Jill Campbell, chief and council funnelled through protocol office.

4. Signage Workshop

LG: It's how we came together in 2010, MST, to move throughout space that were venues.

K: Tuesdays don't work for me

GG: June 15th works.

5. Announcement Event

K: if dance groups are busy, you could ask for singers 1 or 2. I might get some comments from my community, about not doing it as a traditional ceremony.

SL: we just need to allow media to come at 10, get their sound bite and file their story for the noon news, otherwise we're flexible.

K: Can we do a press conference beforehand? Call the witnesses right at the beginning.

GG: Do the press conference and then during the meal you do the witnesses.

6. Other Names

Andrea Reimer (AR): Heather Lands MST proposal was just at council. It's a bigger picture to what's possible when we come together. Why is it called Heather Lands? We potential re-naming for the future.

SL: We could potentially do a half day trip to NEFC, False Creek Flats and Habitat Island in the summer to discuss names.

7. Next Steps

SL: Are committee members taking holidays in the summer?

LG: I'm away Week of July 2023.

GG: August 6-10 I'm away.

SL: July 18-28.

Council Naming Committee Meeting 1

Tuesday March 6th 2018

City Hall - Protocol Board Room

Attendees: Larry Grant (Musqueam), Khelsilem Rivers (Squamish), Andrea Reimer, Rena Soutar (Park Board), Lara Honrado (Community Services), Spencer Lindsay (Public Engagement).

Regrets: Gabe George (Tsleil-Waututh), Savannah Seaton (Engineering).

What are we here to do?

Andrea Reimer (AR): We many come up with a lot of names, but there are lots of opportunities for naming and there will be somewhere for those names to land.

Key Considerations

Larry Grant (LG): Very few places named after human beings, that's a colonial thing. Much of the names are directional; towards sun, upriver, downriver, not East West North South, no colours. There are lots of misconceptions.

Traditional names are places where you get things, where things grow, places where people live, but not named after people.

LG: It is time for people to suck it up when it comes to words that are challenging to pronounce. People who went to residential school weren't taught English properly and were made fun of for that. If you can't pronounce a word, it's because you don't have an open mind and an open heart. People don't understand that an accent is a sociological fear of the loss of identity.

LG: Musqueam decided to use International Phonetic Alphabet so they can differentiate from other dialects.

KR: It would be great to honour Chief Dan George. Chief Dan George playhouse?

KR: There aren't any place names where the plazas are. The NEFC place name doesn't exist because the foreshore has changed so much.

KR: Coast Salish place names are all based on water sightlines. Describing markers. Inland, it's a marker you could see from a canoe. For example, we don't have names for Mt. Seymour, because it's not visible from the sea.

KR: If a place name is tied to ceremony, it's probably not a good idea to use it (e.g. lumberman's arch)

KR: Vanier Park, Jericho and New Brighton have place names I'd like to see returned to the land.

Getting to a Decision

LG: We have a short time. Even though we have a lot of our knowledge digitized, it's a challenge to find things. It will be a challenge to find relevant information with this short timeline

AR: We heard at council-to-council how profound it is to be erased in your own territory. I don't know if we can do art gallery within this timeline, but what can we do on others?

AR: How comfortable do you feel making these decisions? Do you have to go back to community?

KR: I think that our council would like to sign off on it. There is a precedent. There are council motions from the 1930s when major Matthews put place names into the archives. When it comes to cultural prerogatives, the council likes to be able to show that they're in support, so that future generations will know who facilitated these names.

I'd like to see a call out for name suggestions. It opens it up for the community.

AR: We could make that work (the community process) but the VAG north lawn would be harder.

KR: For the VAG North Lawn, we could send just sent to MST staff and council, do an internal process and then bring it back to council.

Rena Soutar: What I like about getting names submitted from community is that it helps with the fact that different families might have different names for the same place.

LG: The committee won't be able to come to a decision without council. If Squamish has a different name, we can use both names.

KR: For other parks and places. We can put all the names forward, we could put the ones that are similar in hən'qəmin'əm and Skwxwú7mesh together like Brockton point, and Jericho.

Welcome to Vancouver Signs

LG: Wording on signs differs depending on what direction you're coming from.

AR: We can have different language on different signs, the signs aren't mass produced.

KR: English should go on the bottom, alternated hən'qəmin'əm and Skwxwú7mesh on top. The translation of the wording on the Welcome to Vancouver Signs draft is: "This is the land of the Musqueam, Squamish, and Tsleil-waututh."

KR: Squamish is developing a talking dictionary. Our speakers can record the wording on the signs. I'm concerned about the visibility of the language, and the font size.

Summary

AR: It seems like we've been able to answer a lot of our initial questions.

- What types of names?
 - Decolonize how we name, don't name after people.
- Will names be shared?
 - If there are two names, use both names.
- Should we use hard to pronounce name?
 - People need to suck it up.
- Actions:
 - Rejig layout of Welcome Signs, have ready for march 21st
 - Commit to getting motion re: process. We could get you some text by mid next week: "hey we're looking for names on the plaza", then we're opening up for the wider community on April 1st. VAG: March 15th.
 - The QET and NEFC call out will start April 1st.
 - Think about it who will chair next meeting.

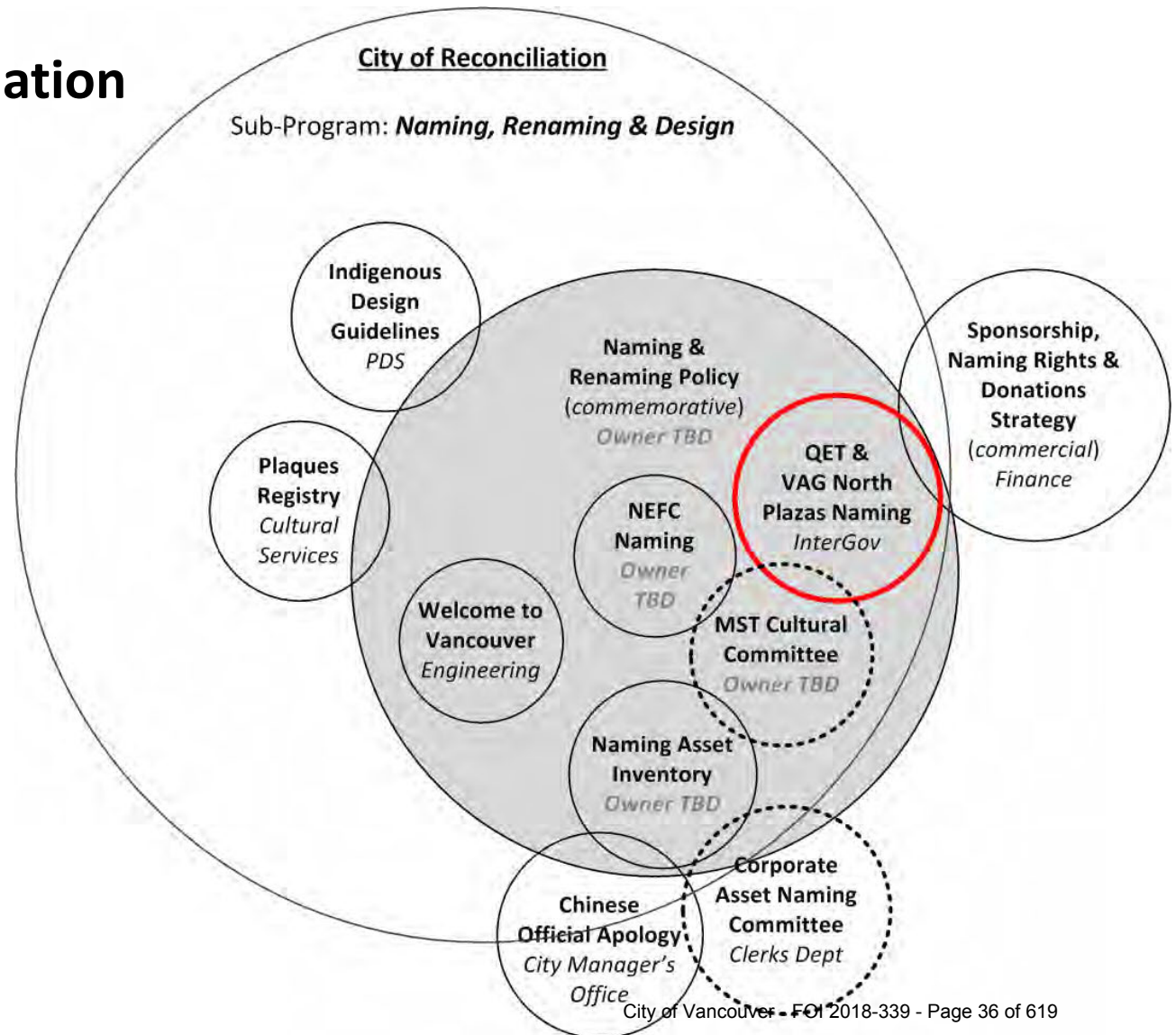

The Vancouver Civic Theatres Board, at its meeting on January 25, 2018, discussed a motion recently passed by the Urban Aboriginal People's Advisory Committee which recommended Vancouver City Council replace the word "Aboriginal" with "Indigenous" in all City documentation in recognition of the language used in the UN Declaration on the Rights of Indigenous Peoples.

Subsequently, at the suggestion of Councillor Ball, the Board agreed to invite Ginger Gosnell-Myers, Indigenous Relations Manager, to the February 22, 2018, meeting to provide an update. Ms. Gosnell-Myers attended along with her colleague Spencer Lindsay, Indigenous Engagement Specialist, and provided an update on the City's approach to the Truth and Reconciliation Commission Calls to Action.

Unfortunately, Ms. Gosnell-Myers is no longer with the City but Mr. Lindsay is and he could provide some of the information requested (i.e. correspondence, reports about the conception and development of the new names and focus groups).

In addition, the Board's Liaisons Councillor Ball and Sandra Gajic, Director of Vancouver Civic Theatres, could have background information.




Further to our discussion yesterday, regarding these two critical items:

1) CRPN: the status of the 17 APR Council report (... it's due with concurrences completed at the CMO for Monday 9 APR)

2) SNRDS: the status of the SoW for Opinion Research (...the Shopping Cart must be moved forward to Procurement, as opinion results are needed by end of month)

You indicated that you were going to be talking to Amanda.

Have you had a chance to do so? I've not yet received any update from Amanda regarding these items.

I suggest that it's time to advise the project Sponsors (Sonja Foley - CRPN, and Patrice - SNRDS) that the respective project schedules will be impacted.

As you know, at the second Walk for Reconciliation held on September 24th 2017 the City of Vancouver, Musqueam, Squamish and Tsleil-Waututh, agreed to work together on several things including determining an appropriate name for the Queen Elizabeth Theatre Plaza.

A Joint Naming Committee was formed to bring together representatives of Musqueam, Squamish, Tsleil-Waututh and City of Vancouver elected councils. On May 17th, the committee recommended the name *xʷálexən* in *hənq̓əmiṇəm* and *Xwtl'ashn* in *S w̓xwú mesh*. *xʷálexən* is the *hənq̓əmiṇəm* word for: a place one is invited to. *Xwtl'ashn* is the *S w̓xwú mesh* word for: a place one is invited to celebrate. The names reflect the significance of the Walks for Reconciliation that took place of 2013 and 2017 which both began at the Queen Elizabeth Theatre Plaza.

We, the members of the Joint Naming Committee hereby confirm our endorsement of this name and hope that your Council is able to endorse it as well.

Talked to the representatives of the Squamish Nation council (Debra Baker) and Tsleil-Waututh Council (Charlene Aleck) who were at the Sacred Fire Ceremony and they are fine with all three things we outlined below.

A few follow ups that need to happen from the discussions I had with them:

- Once the flags are ordered and we are sure that they will be here in time, we need to send an invite to the three Chief and Councils to the October 3rd meeting so those that chose to can witness the moment
- We will need a follow up letter to the Chiefs and Councils inviting them to send a designate to participate in two processes
 - o Process 1: How to appropriately commemorate the Walks for Reconciliation at the QE Plaza
 - o Process 2: How to ensure that the VAG north lawn, as the most prominent public gathering location in the city, appropriately recognizes the three nations through its name and public art. On this latter one, I am not sure if we need to have a separate process but I am guessing yes as it involves provincial land and is an entirely different subject matter from reconciliation and justice for residential school survivors which are conflated concepts in the Walks for Reconciliation

The fourth proposal I made to them is that in the future we would seek a process to develop ideas of this nature as opposed to the more paternal approach of independently developing ideas and then asking them if they want to participate. We all agreed that while this made reasonable sense in 2013 when we didn't know each other as well, at this point it would be more in the spirit of reconciliation to work together on working together.

Hope that all makes sense.
