Description of the internal MST naming process for Vancouver Arts Gallery north plaza

At the second Walk for Reconciliation held on September 24th 2017 the City of Vancouver, Musqueam, Squamish and Tsleil-Waututh, agreed to work together on several things including determining an appropriate name for the Vancouver Art Gallery north plaza. The north plaza is on land owned by the Provincial Government but is leased by the City. The Premier was consulted on and approved of the approach proposed to adopt an appropriate name.

A Joint Naming Committee was formed to bring together representatives of Musqueam, Squamish, Tsleil-Waututh and City of Vancouver elected councils. In February 2018, the Mayor's office sent a request to each community, requesting a representative on the community. The committee consists of Elder Larry Grant of Musqueam, Councillor Khelsilem of Squamish, Language and Culture Manager Gabriel George of Tsleil-waututh and Councillor Andrea Reimer of the City of Vancouver.

The first Joint Naming Committee meeting was convened on March 6th 2018. At this meeting the committee discussed its decision making process, criteria for names, and advised on strategies for engaging Musqueam, Squamish and Tsleil-Waututh members in the naming process. Following the first meeting, an email call-out was sent to each nation for distribution, to solicit naming ideas for the Vancouver Art Gallery north plaza.

On March 21st, the Council Naming Committee met for a second time. At the end of this meeting the committee recommended the name Tl'é enk in Skwxwú mesh and Åənəq in hənqəminəm. Tl'é enk / Åənəq is a word that means to have a cultural gathering: wedding, funeral, memorial, passing on name, coming of age ceremony, and honouring.

A letter on behalf of the committee was signed by all members and sent to the Chief and Council of each nation, along with a request for a Band Council Resolution endorsing the name.





Description of the internal MST naming process for Vancouver Arts Gallery north plaza

At the second Walk for Reconciliation held on September 24th 2017 the City of Vancouver, Musqueam, Squamish and Tsleil-Waututh, agreed to work together on a variety of commemorative naming opportunities including determining an appropriate name for the Vancouver Art Gallery north plaza. The north plaza is on land owned by the Provincial Government but is leased by the City.

A Joint Naming Committee was formed to bring together representatives of Musqueam, Squamish, Tsleil-Waututh and City of Vancouver elected councils. In February 2018, the Mayor's office sent a request to each community, requesting a representative on the committee. The committee consists of Elder Larry Grant of Musqueam, Councillor Khelsilem of Squamish, Language and Culture Manager Gabriel George of Tsleil-waututh and Councillor Andrea Reimer of the City of Vancouver.

The first Joint Naming Committee meeting was convened on March 6th 2018. At this meeting the committee discussed its decision making process, criteria for names, and advised on strategies for engaging Musqueam, Squamish and Tsleil-Waututh members in the naming process. Following the first meeting, an email call-out was sent to each nation for distribution, to solicit naming ideas for the Vancouver Art Gallery north plaza.

On March 21st, the Council Naming Committee met for a second time. At the end of this meeting the committee recommended the name

The letter was then sent to the Chief and Council of Musqueam Squamish and Tsleil-Waututh, along with a request for each council to formally endorse the proposed name. Each nation was asked to provide an endorsement through a Band Council Resolution or a letter of support.

Current Status: As of 4:30 pm on Monday April 9th, the intergovernmental contacts for each nation have verbally confirmed that they are in the process of acquiring the endorsement of their councils. We expect to have formal endorsements from each nation by end of day Tuesday April 10th.

Description of the internal MST naming process for Vancouver Arts Gallery north plaza

At the second Walk for Reconciliation held on September 24th 2017 the City of Vancouver, Musqueam, Squamish and Tsleil-Waututh, agreed to work together on a variety of commemorative naming opportunities including determining an appropriate name for the Vancouver Art Gallery north plaza. The north plaza is on land owned by the Provincial Government but is leased by the City.

A Joint Naming Committee was formed to bring together representatives of Musqueam, Squamish, Tsleil-Waututh and City of Vancouver elected councils. In February 2018, the Mayor's office sent a request to each community, requesting a representative on the committee. The committee consists of Elder Larry Grant of Musqueam, Councillor Khelsilem of Squamish, Language and Culture Manager Gabriel George of Tsleil-waututh and Councillor Andrea Reimer of the City of Vancouver.

The first Joint Naming Committee meeting was convened on March 6th 2018. At this meeting the committee discussed its decision making process, criteria for names, and advised on strategies for engaging Musqueam, Squamish and Tsleil-Waututh members in the naming process. Following the first meeting, an email call-out was sent to each nation for distribution, to solicit naming ideas for the Vancouver Art Gallery north plaza.

On March 21st, the Council Naming Committee met for a second time. At the end of this meeting the committee recommended the name

Following the March 21st Committee meeting, all members signed a letter confirming the proposed name. The letter was then sent to the Chief and Council of Musqueam Squamish and Tsleil-Waututh, along with a request for each council to formally endorse the proposed name. Each nation was asked to provide an endorsement through a Band Council Resolution or a letter of support.

Current Status: As of 4:30 pm on Monday April 9th, the intergovernmental contacts for each nation have verbally confirmed that they are in the process of acquiring the endorsement of their councils. We expect to have formal endorsements from each nation by end of day Tuesday April 10th.

At the second Walk for Reconciliation held on September 24th 2017 the City of Vancouver, Musqueam, Squamish and Tsleil-Waututh, agreed to work together on several things including determining an appropriate name for the Vancouver Art Gallery north plaza.

A Joint Naming Committee was formed to bring together representatives of Musqueam, Squamish, Tsleil-Waututh and City of Vancouver elected councils. The committee consists of Elder Larry Grant of Musqueam, Councillor Khelsilem of Squamish, Language and Culture Manager Gabriel George of Tsleil-Waututh and Councillor Andrea Reimer of the City of Vancouver.

On March 21st, the Joint MST-CoV Naming Committee recommended the name Tl'é7enk in Skwxwú7mesh and Åənəq in hənqəminəm. Tl'é7enk / Åənəq is a word that means to have a cultural gathering: wedding, funeral, memorial, passing on name, coming of age ceremony, and honouring.

Endorsement from TWN Council will allow the City of Vancouver Council to seek approval for the name from the landowner of the Vancouver Art Gallery north plaza, the Province of British Columbia.

Tsleil-Waututh Chief and Council will participate in a joint announcement on June 20th 2018.

THEREFORE IT BE RESOLVED:

The Tsleil-Waututh Nation Chief and Council, in mutual agreement with the Musqueam Indian Band, Squamish Nation and the City of Vancouver, endorse that the Vancouver Art Gallery north plaza be named Tl'é7enk / Åənəq based on the recommendation of the Joint MST-CoV Naming Committee.







Hi Amanda, Sonja,

This thread below is relevant to the 17 APR Council report (re. VAG North plaza naming).

Amanda, please note that this discussion may have an impact on the specifics of the 17 APR Council report resolution.

To date, we've been working with the assumption that the Province as the landowner has the right to name the plaza in perpetuity.

Therefore our intent was to pass along to the Province the MST decision for the plaza name, in the context of City Council's concurrence.

Danica is suggesting that the City collaborate with the Province, though short of "seeking approval".

In effect, per the DARCI scheme, in Danica's recommended approach the Province would be Consulted and the City the Decider.

Danica's proposal is a reversal of our current, in-flight approach.

Sonja, as the CRPN project Accountable, do you want to consider this change in approach?

If so, do you want to proceed with a discussion with the City Manager and / or the GM of REFM?

Considering the imminent deadlines for the 17 APR report, such discussion would need to proceed very soon.

It should be noted that the Province may reasonably expect to be the Decider.

Hi all,

A quick follow-up per: ACTION (AP): follow-up with lawyer Natalie CORIC

Natalie CORIC confirms that the plaza lease between the City and the Province is silent as to naming rights.

Although we might take the position that the City has the right to name the plaza – at least for the duration of the lease – Natalie suggested that the best approach is to collaborate with the Province.

Here are a few points supporting that advice:

- 1) The Mayor made public comments at the SEP 2017 Walk for Reconciliation which highlighted concurrence from Premier Horgan on the intent to name VAG North plaza, so precedence for consultation has been set
- 2) The CRPN project has already initiated dialogue with the Province
- 3) The City has an ongoing relationship with plaza stakeholders

My recommendation is that we continue on with the plan to treat the Province as the decision maker regarding an in-perpetuity name.

We can in future consider an option to have City Council unilaterally name the plaza (for the duration of the lease) if a concurrence approach is not timely or successful.

Hi All,

Here is an update on the status of the Welcome to Vancouver Signs discussion at the Joint MST/CoV Naming Committee.

At the third Joint Naming Committee meeting on April 10th the Musqueam, Squamish, and Tsleil-Waututh representatives recommended that a decision on the Welcome to Vancouver Signs be delayed for the short term for the following reasons:

- * There is sensitivity around having welcome signs in South Vancouver where only two of the three nations have territorial claims.
- * There is not enough room on current signs to add decals that will be big enough for people to see as they drive or walk by.
- * The representatives feel the Welcome to Vancouver Signs are too important to rush to a decision by National Indigenous Day (June 21st).

Our next committee meeting on May 8th where we can discuss way of moving this forward.
