



We don't hold our own City National Indigenous Day events as a rule because there are community events at Trout Lake, Oppenheimer, and Musqueam that Elected officials and staff attend. The Mayor has always had a role in these events, and the City is seen to be both in support of them and an active part of them. And not sure there is enough bandwidth or interest for organizing something larger than the announcement of the VAG and QET names on June 20<sup>th</sup>. On the 20<sup>th</sup>, I imagine it would be easy for people to commit to something small, like a photo opp and perhaps a brief reception for those involved. But most would also be stretched for time as is because their communities are all preparing for their events the next day. This must be included as a consideration.

The only timelines we have for Naming announcements on the 20<sup>th</sup> are with the two plazas. The Welcome to Vancouver Signs also has a timeline which may be associated with its own standalone unveiling. NEFC is not time sensitive, and an announcement of that name would also likely be its own occasion and not tied to when the two plazas are made known. Kevin is aware of this, but it is Rena Soutar who works with the NEFC Parks staff on the Indigenous engagement and Indigenous knowledge inclusion for the Park and is the point of contact within our current Naming Committee.

Amanda will send you some more information. We just chatted.

There are quite a few issues with sharing the First Nations name proposed for the plaza – some of that has to do with where they are at with the agreements with the Nations – still some back and forthing including which Indigenous language version would be shown first etc. If we share the First Nations name and that gets out publicly through loose lips, that could cause us a very large problem. That's why the name was not included originally (Sonja see below for email from Amanda to Paul that I had already forwarded to Andrew).

I had an inspiration – what if we shared the ENGLISH description (not translation, but the spirit for the space we are trying to capture) with Council and then let them know that we are working with the Nations to finalize what it would be in their languages etc.? Amanda flagged that there have been some inappropriate comments from Council in the past about "it needs to be pronounceable" and such which is just "not on" i.e. it needs to be clear that the NATIONS are choosing this name, not Council...so telling them the English description/name for the space could help us get around that?

INFO (AG): report from Civic Asset Naming Committee Workshop on 10 JAN: some members of CANC are of the understanding that CANC is developing renaming policy (vs. advising); AG notes that there may be confusion regarding *commemorative* vs *commercial* naming, and suggests that there would be benefit with internal education on the topic; CANC wants to proceed with a public engagement piece on renaming (see minutes

<u>http://vancouver.ca/docs/council/cian20171120min.pdf</u>); AG notes risk in an uncoordinated approach to public engagement on this topic (eg. getting public sentiment on renaming for commemorative purposes introduces opportunity for unproductive commentary)
