

It is barely 300M from Vantech High School, it is less than 300M away from the West Coast Resource Centre for Children. ^{8,22(1)} from this city owned building in the past when it was still the BC Cancer Society. This area is heavily used by youth and children from Vantech, the Pre-school at the Broadway Church, Wind and Tide (which is less than 300M), and Frog Hollow Community Centre (which is barely 300M).
