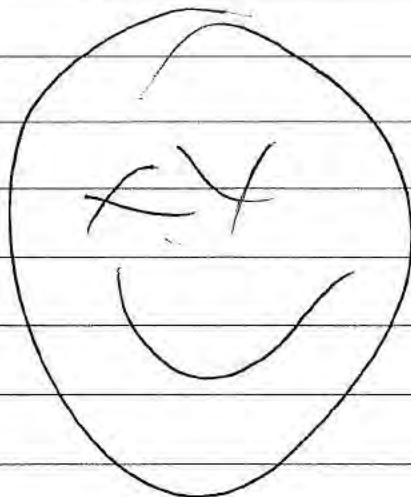





My first complaint about this store is it's location. It is barely 300M from Vantech High School, it is less than 300M away from the West Coast Resource Centre for Children. s.22(1) from this city owned building in the past when it was still the BC Cancer Society. This area is heavily used by youth and children from Vantech, the Pre-school at the Broadway Church, Wind and Tide (which is less than 300M), and Frog Hollow Community Centre (which is barely 300M). There is also the Satellite Daycare centre in the Government Liquor Control Branch and the Awana Children Day programs in the International Church at Rupert Street. This is not the neighbourhood to put this kind of business. What is even worse is there is another Medical Marijuana place called the Dispensary right across the street in the strip mall. This is a complete violation going on here!




