I'm writing this letter in response to the Development Application of Wealthshop Social Society at the address noted above I am taking the perspective of a young parent and medical professional <u>against</u> the conversion of the Barber Shop to a Medical Marijuana-Related use facility.

Too many marijuana shops in close proximity

I believe there is no need for an additional medical marijuana related facility in the proposed location. There are five marijuana shops within a 1.3km radius on Broadway between Alma and Macdonald. For those members of the community that have a legitimate need to be serviced by a medical marijuana facility, I believe the existing stores will be able satisfy the demand.

High visible exposure to young children, students and young adults

I understand that the <u>City's bylaws</u> state that a medical marijuana facility is not to be located within a within a 300m radius of a youth facility. However, it is important to be mindful that a 300m radius is a tight proximity. A few of the following institutions are located within close proximity of the proposed location, which I would consider to be "youth facilities."

- 140m Vancouver Public Library
- 220m Kaboodles Toy Store
- 800m Queen Mary Elementary
- 880m Trimble After School Care
- 900m West Point Grey Academy
- 900m Trimble Park
- 1km Our Lady of Perpetual Help Catholic School
- 1km Menno Simons Centre Residence
- 1.3km Jericho Hill Centre
- 1.7km Queen Elizabeth Elementary
- 1.7km Vancouver Lord Byng Fitness Centre
- 2.1km Lord Byng Secondary

The above mentioned are just a few examples.

This location is highly visible to children and students. This is as a result of the area being considered a tight-knit community, where many young families are raising their children. In addition, the proposed location falls along the busiest bus route to UBC where thousands of students travel through daily. The daily visibility and the marketing related to the marijuana facility would romanticize the use marijuana to minors.

Devaluation of the "social" community

A local family friendly business would be better suited for this location. Such a business tends to help build the community. Generally, the local shop owners encourage people of the community to participate in grassroots events and take ownership in helping grow the local economy. More marijuana related facilities in the area drive out local and private businesses that serve us directly, which negatively impacts the dynamic and value of the community.

Thank you for taking the time to read my letter and consider my comments. I hope the insight that I have provided will allow you to make an informed decision that keeps the community and many young families happy and healthy in a meaningful community.

Ms Stewart,

We had a leaflet through our door regarding this development application, with an invitation to send in our written comments.

We are very much opposed to this application to change the use of this building to a medical marijuana-related use. It is not a matter of simply this building, we are opposed to any medical marijuana retailing premises in our area for the following reasons:

- I am not convinced that all the medical marijuana retailing outlets that the city has unwisely allowed to spring
 up all over are selling solely to people who need marijuana for exclusively medical purposes; my suspicion is that
 much of the marijuana purchased is for recreational use.
- Nothing wrong with that, at all, but I don't like the hypocrisy of it. It should not be called "medical" marijuana. I
 also dislike the fact that I am forced to swallow the fiction that this is all for medical use.
- There is so much research out there now indicating that marijuana THC and other active chemical levels have
 increased exponentially due to genetic interventions from us, and furthermore that these active chemicals have
 a deleterious effect on developing (teenage) brains in particular. Given that this is the case, despite the fact that
 our province has embraced a more benign approach to the use of marijuana, it is unwise and foolhardy of city
 hall to issue quite as many marijuana retail licenses as it has.
- It sends the message, particularly to young people, that marijuana is a socially acceptable part of the retail
 experience. This is not the case, there are still questions and warnings from the research community out there
 about marijuana. The fact that the marijuana lobby have presented marijuana purely as a medical commodity, I
 find it surprising that the city and the province have not seen the sale of medical marijuana as something that
 should be sold at a pharmacy. Instead, it is sold by "medical" marijuana advocates. Again, in my view, this is
 foolhardy and a mistake on the part of our administrators.
- Furthermore, I heard recently a proposal (on the radio) that "medical" marijuana be sold at liquor stores. If that
 is indeed being proposed, it bears out my suspicions that marijuana is not a medical product, it is a recreational
 one. I would be far, far more confident were it being proposed that marijuana be sold at pharmacies, just as any
 other analgesic.

For these reasons we are opposed to this application and would not welcome such a retailer in our area.

Dear Ms. Stewart,

As the owner of property just **5.22(1)** from the proposed marijuana shop on West 10th Avenue I am strongly opposed to the application. Although I have every sympathy for people who truly need this drug for pain management or other medical purposes, I am highly sceptical that the majority of customers of pot shops are honestly suffering from ailments that require such remedies. In the great majority of cases I believe that such shops are merely a cynical way of ignoring the present laws restricting the use of mind-altering drugs. Until the present Canadian laws are changed it is weakening the whole legal system to allow people to choose which laws to obey and which to flout. To multiply outlets for (presently) illegal substances is encouraging an attitude of putting personal choice above the weight of laws which are enacted by publicly appointed authorities.

Furthermore, I have reservations about the advisability of anything that will promote the escapism inherent in drugs that alter mental states. Is there any part of the world, even any part of this city, that is less in need of escaping reality than West Point Grey? We are blessed with an environment that is the envy of most of the rest of mankind so why on earth would we promote or encourage befogging our minds with substances that reject this benefit? By establishing more marijuana outlets we are tacitly approving the rejection of what we are so fortunate to possess.

To approve the opening of a drug outlet such as this on the grounds that potential customers (or proprietors) want it is to miss the whole point of law. Legislation is enacted for the benefit of society at large, not to satisfy personal tastes. Considering that marijuana's physical and psychological effects are not solidly established, it would be to the benefit of all of us not to allow its wholesale use at present.

It has been brought to my attention that a "medical," marijuana store wants to open in my beloved retail area of Point Grey Village. As a retailer since 5.22(1) in this area, I have poured my heart, soul, money, and tireless efforts catering to Point Grey Village and making it shine. As such, I am strongly opposed to having a "medical," marijuana store open in the area. Everyone in the city knows what a total sham these stores are, for the most part, in that you can get medical marijuana for "feeling stressed or sad."

All of my fellow retailers and I have worked hard and pay extremely high property taxes to the city year after year. I don't believe that we should continue to go unheard in trying to preserve our retail community's integrity and high standards for honest business practices.

Thank you for receiving this email message asking for the Director of Planning to reconsider the final approval of the Development Application No DE 419872 Wealthshop Social Society at 4545 West 10th Ave.

1. Please make children and youth a priority in Vancouver and in our neighbourhood

According to UNICEF, the Globe and Mail and CBC, Canadian kids smoke the most marijuana in the Western World. In our immediate neighbourhood there are pre-schools, elementary schools, high schools and many services and after school activities for our children and youth as well as health practitioners who specialize in family centered health care. The voices of our children and youth are not registered in this application and so as a child and youth advocate I have to argue that it is not in our children's interests to have a shop selling marijuana in this neighbourhood.

2. Please consider the proximity of the shop to children's activities and services

A shop with a name like "Wealthshop Social Society" with unsuitable opening hours (10am to 10pm) is in fact **75 meters in proximity** to the Point Grey Vancouver Public Library Branch which as you know offers storytime for babies, toddlers, summer reading camp for elementary school children and a teen reading club.

After school activities are offered to children at Dojang Martial Arts located at 4458 West 10th which is 150 **meters** from the proposed marijuana shop.

A popular toystore, Kaboodles is located at 4449 West 10th, 170 meters from the marjuana store.

3. Please consider that there is no drug counseling service to provide accurate information to youth near the marijuana shop

The location is as close as possible to the university student market as the location of the marijuana store is close to the bus stop for the No. 99 bus into UBC campus.

There is however, no drug counseling service in the neighbourhood to provide information on the addictive nature of cannabis use.

4. Please consider that in communicating to the community about this development application that the neighbnourhood was not uniformly informed

The request for community input was not uniformly communicated. Some of my neighbours who live even closer to 4545 west 10th did not receive this notice.

Schools, pre-schools, churches and family centered services were not informed. How exactly are streets and businesses informed of this development application? How does the city decide where to distribute the notices?

Hi Phoebe:

I received a notification of the development application for a marijuana shop in my neighbourhood at 4545 West 10th Avenue. I am unclear why you have sent this to our home. I have never received notifications for any other business about to open in my neighbourhood. This is a first and your card doesn't convey why you are telling me about this particular shop opening. Do I really have a say in what businesses open up in my neighbourhood?

This applicant has their signage up on the store, and their website is up with the address (http://wealthshop.ca). It appears that this business is ready to open. So what is the point in notifying us about the application? It looks like it's a done deal.

I am not happy about having a marijuana shop in my neighbourhood. I am not happy about how the city has allowed over 100 marijuana shops to proliferate throughout Vancouver. The city is regulating an illegal business. The law is clear that the medical marijuana is legal with a prescription from a legal source. People are getting marijuana without a prescription from a medical doctor, by showing prescription bottles of other medications, and by describing their "symptoms" to a naturopath over Skype. It's clear that the majority of persons are buying marijuana from these shops for recreational purposes, not actual medical benefit.

And where is this pot coming from? From everything I have read, there isn't enough legal marijuana available to supply all the stores we have in Vancouver, so much of it is coming from criminal organizations and other questionable sources.

Other municipalities are saying no to the marijuana shops, and are not giving them business licenses or are having the police shut them down. Why is Vancouver legitimizing an illegal business? I am not happy about the City regulating marijuana shops unless they are selling legally sourced marijuana provided to persons with legitimate medical needs and prescriptions from medical doctors.

The West 10th Avenue shopping district is within lunch hour walking distance of two nearby schools: Queen Mary Elementary and Point Grey Academy. On any given school day, many students can be seen frequenting 10th Avenue's various fast food establishments and other retailers.

The extent of compliance by medical marijuana establishments to abide by minimum age requirements has yet to be established. With the proximity of an under 18 student population nearing 1,000, we do not need to run this experiment in the West 10th Avenue shopping district.

My preference is to allow the passage time to offer alternative retailing approaches that provide a high probability of compliance with minimum age requirements. For example:

- dispensing by pharmacists (there are a least 2 professional pharmacies on the street, and they could move into the medical marijuana arena);

- employees of the Liquor Control Board LCB) have proposed that the dispensing of medical marijuana be limited to LCB outlets and LCB-approved retailers (1 on West 10th). These locations are familiar with and have controls in place to ensure minimum age restrictions are complied with. In addition, provincial government audit programs are in place to ensure compliance.

For these reasons, I am opposed to this development permit application.

I am writing in response to your postcard to my household dated December 4, 2015. I wish to express my grave concerns about the prospect of a pot shop opening up in my neighbourhood at 4545 W 10th Avenue (DE419872).

The last thing our quiet family neighbourhood needs is a marijuana dispensary. By now it is well documented that many pot shops claiming to offer marijuana for medical use in our community in fact serve a large number of recreational users. Enforcement of regulations is remarkably lax. Everyone knows by now that the "medical" restriction is a sham. Opening a pot shop in the neighbourhood will invite a range of people here to party. It will also create hazards on our streets when people drive high after lighting up in and around the shop. This is simply inappropriate for our neighbourhood. West Point Grey isn't a place where people come to party. It is a calm residential area, not an entertainment district, and we want to keep it that way.

I am writing in response to the proposed marijuana outlet to be located at 4545 W 10th Avenue (DE419872).

First I would like to say that although I live ^{\$.22(1)} of this proposed development, I only heard about it through a neighbour who ^{\$.22(1)} to this site. Our home never received any notification from the city. If this process is truly meant to get feedback from the community I would suggest that notice should have been sent to residents in a much larger area. This retail strip is not a destination, it truly serves those who live in this community which I would argue stretches from at least West 4th to West 16th, and from Blanca to Alma Streets.

The commercial stretch of West 10th Avenue consists of quiet, family friendly shops and services. This includes both a toy store and a public library which attract a large number of children to the street. Students from Queen Mary Elementary and West Point Grey Academy regularly have lunch on 10th. Three other schools are also within easy walking distance (Jules Quesnel, Queen Elizabeth Elementary and Lord Byng High School).

Given the fact that so many children frequent the street, I question the suitability of a 'pot shop' opening in this location. There are at least 3 of these businesses already located long West Broadway within easy travel distance. As a result, denying this application would not unduly inconvenience any of its potential clientele.

In addition, the people making this application obviously know nothing about this neighbourhood. Their proposed hours are much longer than the rest of the retail businesses along this stretch. Most of the retailers in this area are closed in the evenings and on Sundays. This in and of itself shows the applicant has little regard for the nature of the neighbourhood where they wish to set up shop.

Finally, as a 'pass through' neighbourhood for people traveling to and from UBC there is also a risk that our community will become a destination for young recreational users from the University. Although these stores purportedly service only medical users, realistically that market is extremely small. These businesses can only survive by selling for recreational use.

It has come to my attention that there is a proposal currently before the City of Vancouver that could result in a medical marijuana dispensary opening up in West 10th at the above address. I am told that you are the person to whom I should address my concerns.

I write to protest this in the strongest possible terms. Although the proposed site is not within 300 metres of a school, a community center, or another medical marijuana dispensary, the area is a hub of children and families and it is my concern that vulnerable children and teenagers, will be beguiled by the marijuana culture that this proposal indirectly represents.

West 10th Ave. at Sasamat Street is a commercial hub, directing bus and vehicle traffic toward the University of British Columbia. It is a "people place" where children and families go to purchase food and other goods, access local services, and hang around with their friends.

A partial list of the shops and services that attract children is as follows: the Point Grey branch of the Vancouver Public Library is situated at 4480 W. 10th Ave. Kaboodle's toy store, a very popular children's store in the area for decades is across the street at 4449 W. 10th Ave. A Safeway store where many children shop with their parents and families, occupies much of the 4500 block on the north side. There are three dentists within two blocks, a family physician in the 4500 block, and a child psychologist, Dr. Jeffrey Carr, who practices (ironically) at Suite 206 of the same premises, 4545 W. 10th Ave. (It is sincerely hoped that Dr. Carr's practice will not be enhanced by the growth of illicit marijuana use that may result from the location of this dispensary in our community.) There is a church, West Point Grey Baptist Church, in the 4500 block West 11th, at the corner of 11th Ave. and Sasamat Street, which has a number of children's programs on Sunday and throughout the week. There is a Tim Horton's coffee shop at 4401 W. 10th Ave., a place where young people, usually of high school age, hang around.

The corner of 10th Ave. and Sasamat Street is a bustling commercial area. The B-line bus stops at that intersection before proceeding out to University of British Columbia. Do we really need a marijuana dispensary situated right at the bus stop where students get off and on the bus for UBC?

Many children, accompanied by parents and unaccompanied, cross that street to go to Queen Mary Elementary school, which is 8 blocks north, and one block east of that intersection, and West Point Grey Academy, which is four blocks north and three blocks east of that intersection. West Point Grey Academy has high school age students as well. High school children cross the other way on their way to Lord Byng Secondary School, located within walking distance at W. 14th Ave. and Crown Street.

Every summer, the City grants a permit for a parade for "Point Grey Days" on upper 10th Ave. commencing at the 4500 block, on or around July 1. This parade is a delight which features many children and community

service groups taking part in the parade. Every Halloween, as a result of the promotions of local merchants, young children in costume with their parents walk from store to store in the 4500, 4400, and 4300 blocks.

I appreciate that the subject of medical marijuana is a difficult one, that invokes a lot of emotions on either side of the question. However I suggest that the City's policy of not locating such clinics within 300 metres of schools and community centers is a statement that these establishments are not appropriately located near where children and families abound. As you can see from the above, children abound in the area of West 10th Ave. and Sasamat Street.

I urge you, in the strongest possible way, not to grant a license for a medical marijuana license for a clinic at 4545 W. 10th Ave. If I have mis-directed this message, I asked that you so advise me, so that I might redirect this message to the proper person. Thank you,

I was made aware of this proposal through a neighborhood friend as I have not received any notification of this through the city by any means.

As a resident of this community ^{5.22(1)} I strongly oppose this application. There exists already a multitude of marijuana dispensaries along West Broadway and West 4th which have much longer commercial strips than West 10th. As you can appreciate, the proposed location is in a very limited commercial area surrounded by a neighborhood dense with families with fewer rentals and a less transient population than Kitsilano. The proposed location is also very close to elementary schools and parks while being on the way to and from UBC - the concern being that this will become a destination for recreational users from the university, potentially affecting the quiet family oriented community that exists.

Although these dispensaries are suppose to be for medical purposes, it is obvious that the regulations by which these outlets operate are still neither clearly outlined nor enforced. Dear Ms. Stewart,

As a West Point Grey resident, I write to oppose the application for a development permit to convert the at 104-4545 West 10th Ave, currently licensed as a barber shop, to "medical marijuana-related use."

Let me begin by noting that I am personally in favour of legalizing marijuana. In the October federal election, I voted for a party that supports this position. The medical and sociological literature suggesting that legalization would deprive organized crime of a major income stream, and would allow for the regulation of quality and dosing and the more successful prevention of access by minors, is compelling. However, in the absence of legislation to regulate quality, dosing, and access, allowing the proliferation of pot shops/ smoke shops/ "dispensaries" meets none of the objectives stated by the serious (medical and scholarly, as distinct from pot activist) proponents of legalization.

At Vancouver's "dispensaries" the product dealt cannot be acquired from a licensed or regulated grower, for example, and, as a result, the supply streams are not tracked—a matter about which licensed medical growers have expressed concern: <u>http://www.cbc.ca/news/canada/british-columbia/vancouver-marijuana-dispensaries-selling-pot-illegally-say-licensed-growers-1.3051975</u>). Moreover, as recent press coverage (for example BCTV's investigation from early September, here: <u>http://bc.ctvnews.ca/easy-access-to-vancouver-pot-shops-ending-soon-city-councillor-1.2585676</u>) suggests, dispensaries have been shown to deal marijuana, in substantial quantities, to those lacking prescriptions. Some dispensaries have also been shown, in documented cases (such as this one reported by the CBC: <u>http://www.cbc.ca/news/canada/british-columbia/vancouver-marijuana-dispensaries-differ-on-rules-for-who-can-buy-pot-1.3059432</u>), to those lacking genuine proof—or perhaps any proof—of having reached the age of majority.

As a parent, I'm made uneasy by the idea that my elementary-school-aged child, who travels through the neighbourhood, including Point Grey Village, unaccompanied, on foot or on a bicycle or scooter, will encounter the people who are drawn to such a business: a business, after all, that sells a still-illegal product and one provided in a form elusive of quality control; in short, sellers and customers alike who are willing to flagrantly break the law in pursuit, respectively, of profits and intoxicants. I find the law prohibiting marijuana consumption silly; I hope it will be changed soon, as the government promised during its campaign. But, for the present, I am very uncomfortable with the proposed presence, in my neighbourhood, of a business that is premised on flagrant public lawbreaking. Moreover, customers of dispensaries often seem to try out the product before leaving the area, (I walk and cycle in Kitsilano, where there are, in some neighbourhoods, more than one of these businesses per block, and I often see smokers right outside, or smoking as they walk away, to cars or homes.) No one knows how much THC such a smoker is consuming in marijuana from an unregulated dispensary, supplied by an unlicensed grower. When the smoker drives away, as such smokers seem often to do, he or she is, in an intoxicated state, endangering children and others on the streets.

This set of circumstances seems especially likely to apply to the proposed "medical marijuana" business at 4545 West 10th. Let me explain:

• Very few West Point Grey businesses are open much beyond 7 p.m. Those that are include Safeway (open to midnight) and Liberty Wine Merchants (open to 10 p.m. Tuesday through Saturday), both in the 4500 block, Kaboodles Toy Store (open to 9 p.m. on Fridays only), in the 4400 block, Dentry's Irish Grill, in the 4400 block (open to 1 a.m.), and the Enigma Restaurant, in the 4300 block (open to 11 p.m.)

• Though Safeway and Liberty cater to people arriving by car, they share a large surface-level parking lot, meaning that street activity is kept to a minimum. Moreover, no intoxicants are consumed on or near the premises of either business, meaning that any drivers will arrive and leave the premises sober.

• Enigma is family-oriented and does an overwhelmingly neighbourhood trade. The four-car parking lot behind it is usually empty; there is always plenty of available street parking around it. Dentry's Irish Grill is more tavern-like, though also restaurant licensed. Though it keeps later hours, it too is patronized largely by neighbourhood residents—as the low numbers of cars arriving to and leaving from the street spaces that are the only available parking clearly demonstrates.

• It's difficult to imagine, in the West Point Grey neighbourhood, which is a mix of middle-aged and elderly residents (52% over 40, according to the city's 2006 figures) with young families, that residents of the immediate neighbourhood arriving on foot could, on their own, sustain a business dealing in illegal intoxicants, as the proposed dispensary would be. Nor, I suspect, does the applicant for this development permit imagine such a circumstance. Rather, the business plan must be to attract a UBC-oriented clientele, which would mean crowds and cars (including those driven by people who have consumed drugs) arriving at hours to which the neighbourhood--in which most businesses, especially those selling intoxicants, are patronized by neighbours on foot--is unused, and to which it is unsuited.

Please don't allow an illegal dispensary to open in Point Grey.

I am writing to express my strong objection to the subject development permit application to change of use from Barber Shop to Medical Marijuana Use located at 4545 West 10th Ave, Vancouver BC.

There are several reasons why I object to this application as follows:

Firstly, our family has lived in the Point Grey area ^{5.22(11}) and are frequent users of this commercial area, including Safeway, and Point Grey drycleaners. This busy commercial area is regularly frequented by families with young children, youth and teenagers from nearby schools (Queen Mary Elementary, Jules-Quesnel Elementary, Queen Elizabeth Elementary, West Point Grey Academy, Lord Byng Secondary, and our Lady of Pepetual Health). I know while raising ^{5.22(1)} we would frequently send them up to the grocery store on 10th on their own or with friends knowing that all of the businesses were safe, legal and selling regulated products. I truly believe that having a business that sells an unregulated substance in a commercial area that is frequented by so many families is an incompatible use.

Secondly, I strongly object to the fact this business has already installed an awning and store signage as if this application will be approved 'carte blanche'. It makes a farce of the whole development application process when a controversial business such as this chooses to locate in a well established family neighbourhood and sets up shop prior to getting approval. It is very presumptuous and I object to the City allowing them to do this.

Thirdly, I believe that this location may not fully meet the City's bylaw. At one time there was an alternative school/ and perhaps daycare located at West Point Grey United Church located at 8th and Tolmie, as well there are community and possibly daycare facilities located at West Point Grey Baptist Church and St Helens Anglican Church.

In summary, I strongly object to this development application as I do not think it is a compatible use for a family oriented neighbourhood.

I write to raise concerns about the marijuana dispensary proposed for #104-4545 West 10th Avenue. I'm sure that many objections will be raised to the very idea of a dispensary; I will admit that as the parent of a near-teen child in the neighbourhood, having no dispensary in the family-oriented shopping areas of Point Grey Village seems the best option, particularly given that **there are at least two already located within easy travel distance** at the far west end of both Broadway and 4th Ave. Those with genuine need of medical marijuana already have easy access, directly served by Translink.

Locating a dispensary on the last edge of Vancouver before the unincorporated area of UBC risks making this quiet residential neighbourhood a drive-though destination for recreational drug users (and do let's not pretend that there are enough genuine medical users to make the shop economically viable).

If the city is going to endorse marijuana, it should be sold by businesses with a clear sense of medical legitimacy and that will work to fit into the community. Thus my second concern is with **the proposed operators**. Jesse Rice-Jones appears to have no formal education or professional qualification in medicine, in alternative medicine, or in business. It would appear instead that he comes from a background as a mixed martial arts fighter and "motivational speaker," operating under a business license that incorporated apparently specifically to sell marijuana only in late August of 2015. I can find no business history (or even an online presence) for Wealthshop Social Society or its named operators. The unfortunate choice of corporate name makes rather clear the financial rather than healthcare-related motivations behind this application.

Until marijuana sales are formally legalized federally, marijuana sales will be stuck to some degree on the edges of the illegal drug trade; this circumstance makes it that much more necessary that those granted permits to sell marijuana have the actual training and professional qualification to provide a legitimate and important medical service to those with genuine medical need. My research into this application has revealed no evidence of Mr Rice-Jones or Wealthshop's having the professional associations or the significant amount of legitimate financial backing required to maintain the dispensary as a secure, professional medical space that will ensure the maintenance of the family-centered community around the proposed site, proximate to the community's grocery store, banks, and public library, as well as family-oriented small businesses, including a toy store only 100 meters away. I note also the children's playground at Trimble Park, the Montessori school at 4405 West 8th Ave, and West Point Grey Academy and Queen Mary School, all located within three walking blocks, and Our Lady of Perpetual Help just beyond that. Children from these latter three schools routinely walk through the safe streets of West Point Grey unaccompanied on their way home from school and during lunch breaks. All of the regulations attached to locating marijuana dispensaries away from schools may technically be met in this application by a few metres, but the spirit and childprotection goals are not: in this location, large numbers of children and adolescents will routinely be proximate to the site, often unsupervised, given that the proposed location is on the western edge of one of the most school-dense square kilometers in the city.

Again, I oppose the proposal on the basis of location, but I will note that the community might be more willing to accept a discreet, clearly medical site operated by an actual MD during appropriate medical office hours. No one in our community will do anything but protest a fluorescent-lit cannabis leaf announcing open pot sales, especially at the **proposed hours of 10am to 10pm seven days per week**. If any dispensary proposal is granted a permit, it seems important that it meet the standards of the community and the local business association. In the Point Grey Village, most businesses are not open Sundays except during the holiday season, and nearly all businesses—including the two pharmacies—operate on the standard schedule of 10am to 5 or 6pm. I would hope that any dispensary would be required under licensure to operate only during the normal retail business hours of the community.

I hope that the City of Vancouver will reject this application.

As you know, the City of Vancouver regulations specify that marijuana-related businesses should not operate within 300 meters of

schools, community centers, neighborhood houses, youth facilities that serve vulnerable youth or other marijuana-related businesses.

I would ask your staff to consider including Vancouver Public Library branches in the area exclusion list, because most VPL branches run many

programs for youth, similar to those run in our Community Centers and Neighborhood Houses. The VPL branches serve many vulnerable youth throughout our city.

1. The Vancouver Public Library branch at 4480 West 10th (**100m from the proposed establishment** - diagonally, just across the street) runs many programs for youth year-round including: Summer reading programs for youth, Family story times, Toddler Readings, a Teen Reading Group, and a Reading Buddy program. And if you walk into the library late any afternoon, you'll see it is also used by students doing homework or meeting with tutors - our youth informally using the facilities of the Library. These VPL programs support vulnerable youth in our neighborhood.

2. 2.2(1) and many girls in our neighborhood are members of Girl Guides of Canada. Girl Guides of Canada holds the following weekly meetings in West Point Grey United Church at 4595 West 8th Ave (195m from proposed establishment)

Community Center staff run several movie nights and picnic gatherings at Trimble Park as well. These summer programs are part of the community center programming, and hence the pot shop is too close to this community center programming at Trimble Park. These programs are VERY popular with families in the neighbourhood.

As a school located at 4125 West 8th Avenue, we, along with Our Lady of Perpetual Help School and Queen Mary Elementary School, are less than one kilometre from 4545 West 10th Avenue. We have 942 students in junior kindergarten to grade 12, and many students in higher grades (ages 15–18) are permitted to walk unsupervised to West 10th Avenue at lunch to frequent the restaurants in the immediate vicinity of 4545 West 10th Avenue. Students ages 8 years and older also walk in this area after school.

Children and youth are particularly vulnerable to alcohol and drug use. Although we appreciate that the seller intends to sell marijuana to those ages 19 years or older, we are concerned that our students may be exposed to marijuana purchased from the seller.

In an effort to keep our students and neighbouring children safe, we ask that this development application be denied in favour of a location not frequented by children of all ages during its operational hours.

The only concern is bringing in a new user for retail of medical marijuana, a feature with no experience of such a site anywhere in this general neighbourhood.

We trust proper safeguards are to be in place for daytime commerce.

To have this outlet open until 10;00pm every day of the week is to grant almost exclusive focus on an additional four hours open access after 6:00 pm normal closing hour for other retail outlets. It gives exclusive post-business 4 hours opening to marijuana in the block, and apart from food outlets, an otherwise calm commercial scene. There seems to be no reason this user should have an extra 4 hours daily since it sells product and is not a user site like coffee etc.

The change in parking to allow stop-in for several cars emphasizes the short term use of the store. This is not really consistent with present commercial funcitons, where street parking is all that is available.

With no experience of marijuana commerce, it is worrisome to contemplate this activity quite close to domestic land-use, and home privacy.

Forgive this ramble, but the prospect of this new user is anything but just another commercial outlet. It seems there should be a deeper non-domestic zone to give private homes physical protection from a product outlet that raises misgivings due at least to unfamiliarity..

I would like to provide my comments to the above application for a medical marijuana-related use business.

I do not support this application.

While I laud the City's leadership in providing regulatory oversight in the establishment of marijuana businesses in the absence of other levels of government to do so, I do not believe that this city needs more of these businesses. I understand that there are over 100 such businesses already so we know that they are lucrative for the operators. While I support the decriminalization of marijuana for personal use, the scientific evidence does not support marijuana use for medical reasons in the vast majority of people.

The federal government will eventually weigh in and legislate on the matter so I believe the City should not rush in to grant more licenses in the absence of a coordinated effort with federal lawmakers. More importantly, without the City having studied the impact of existing clinics on the surrounding neighborhoods, including with respect to crime and increased access of marijuana to youth, the City's licensing activity should be carefully controlled as one would expect of any regulator.

The CBC Fifth Estate highlighted what most of us already suspected about these clinics (ie. that anyone can walk in and buy marijuana after consulting for a few seconds with or without a "doctor") (see <u>http://www.cbc.ca/news/canada/medical-marijuana-easily-dispensed-in-vancouver-1.2938574</u>). I have a friend who is a practicing family physician who said more of her patients are coming in asking for a prescription. As she says, the empirical evidence does not support the use of marijuana for medical reasons. I doubt her experience is unique. So I do not believe it is our doctors who are driving demand for this product for "medical" reasons.

Because of my spouse's scientific research in the areas of mindfulness on brain health over the last ^{5.22(1)} I walked into the "Metta Lounge" on 4th Ave., only to discover that it was a marijuana store and had nothing to do with metta and mindfulness. I note that the application referenced above is by "Wealthshop Social Society." How will the business be clearly identified as a marijuana-selling business so that members of the public, let alone under-aged youth, have clear notice of the purpose of the business? Such businesses are confusing to the public except those that are clearly identified as pot-selling businesses, either from their name or other signage that should be mandated by the licensor.

In short, granting a business license for "medical marijuana related use" is misleading and disingenuous. The City is licensing the selling of pot - full stop.

I propose that the City halt the licensing of these businesses in general, and the "Wealthshop Social Society" in particular, until it has more information on the impact of these businesses on people's health and neighbourhoods, as well as the support of all levels of government that have jurisdiction over the matter.

The West Point Grey community is changing, as is the city, as is Canadian society, in ways that long-time residents don't always appreciate. I'm not against change itself, even though I don't often see the changes that I'd like: ones that reflect renewal without destroying a sense of continuity in which present and future generations can grow and thrive. And with the increasing clamour for the normalization and de-regulation of marijuana use, I feel I'm going against the current in saying that I would not want to see a Medical Marijuana facility on West 10th Avenue for the following reasons:

1 The scientific evidence for the benefits of medical use of marijuana in treating pain, nausea, loss of appetite, and/or symptoms of epilepsy, cancer, HIV and MS is very weak. Proclaimed results are most often based on small studies, often with few controls; the 'strongest' results are based on anecdotal evidence. (That said, the evidence for adverse side effects of MM is also based on limited research so far.) Even then, in most tests, phrases like "may be useful to some individuals" are a more accurate evaluation of results than "strongly indicates positive improvement ".

2 I am concerned about the difficult to prove/disprove links between MM facilities and money-laundering and/or profit opportunities for criminal individuals or organizations.

3 I question the need for the fast-growing number of MM facilities across the city. With several nearby on West 4th and Broadway, another one on West 10th adds nothing essential or useful to the community as a whole. We don't have a dense network of specific pharmacies throughout the city for cancer drugs, or arthritis, or respiratory ailments, or dementia; we don't need to expand the MM network we already have.

I am writing to you in response to your notification regarding the above-mentioned development application for the change of use from Barber Shop to Medical Marijuana-Related Use. As a resident of West 9th Avenue, immediately behind the proposed location, I have serious concerns about the City's ability to properly regulate what is currently an illegal business.

The Point Grey Village is a family-focused area and my assumption is that the proposed business owner(s) are keen to move into the neighbourhood in order to benefit from the numerous UBC students who shop at our local Safeway and more importantly use the 99 B-Line to get to school and there is a stop just steps away from the proposed location.

We have two elementary schools in the vicinity (Queen Mary – only 800 m away, Jules Quesnel and the WPGA Junior School), in addition we have two high schools (WPGA and Lord Byng) in the area. We are already aware of the Kitsilano High School student who was rushed to Children's after buying pot at a so-called medical marijuana dispensary on West 4th.

The dangers of pot to young people are well-documented. Neither the City nor the Vancouver Police appear to be addressing the risks posed to young people. Let alone the ability to detect people driving under the influence.

My questions and concerns are numerous:

- 1. Why are the business hours 12 hours per day, 7 days a week? This seems excessive. Their hours should be reflective of what is typical in the neighbourhood.
- 2. Background checks? Can we be assured that the operators have NO criminal ties or criminal record(s)? This has not always been the case in Vancouver.
- 3. Product selection baked goods etc...that are appealing to children. Will these be permitted?
- 4. ID checks in liquor stores the staff are well trained to ask for ID for anyone under the age of 25. Is the same standard being enforced? How is this policed?
- 5. Prescriptions do they actually have ON SITE medical professionals or is this a situation wherein "prescriptions" are provided over Skype/fax? If they don't, then it can hardly qualify as a proper medical prescription. I can't get my own Doctor to refill a prescription without an IN PERSON appointment.

Apparently your applicant has already updated their website using the West 10th address as their location. If the permit is still being reviewed, this seems to be a bit premature. Unless of course this process is just a formality and the decision has already been made.

It is difficult to express any opinion in relation to the proposal of the Wealthshop Social Society without knowing far more than I was able to ascertain on my computer. I do know that on August 21, 2015 a cluster of 5 organizations with the word Wealthshop in their title, including the Wealthshop Social Society, were incorporated on August 21, 2015 The others were the Wealthshop Companies Club, Counselling Society, Cultural Foundation, and Support Association. The tiles and the fact that they occupy sequential places in the Registry of Companies suggests that they are related organizations. Are each of the societies aimed at promoting Medical Marijuana Related Uses? We cannot afford the costs of searching the register .We cannot, as a result ascertain the true nature of these organizations , whether they all have the same or similar objectives , whether the prime movers are the same persons in each case, whether all or any of them are non-profitmaking or not.

Nor do we know what rules or regulations have been adopted federally. provincially, or on a local basis to regulate the number or location of sites related to medical marijuana operations. What rules, for example, have been adopted with respect to the distance of any such site from schools, playgrounds or places where children or young persons congregate? Is there any protection in the rules, if any, relating to to the distance from residential areas? Or residential areas in which children live? There are a number of schools, for example in the general area. Further the area immediately behind the locality of the proposed site is residential. Has any independent survey, or any survey at all, been made of the composition of the population within whatever distance is set?. What information been included in the application for the licence. ? What background information if any, was submitted by the applicants?

We are, presumably, being asked to comment upon a situation which deals only with marijuana prescribed by a medical practitioner ? Can it be prescribed by dentists and other health professionals? What are the "associated approval processes" to which you refer ?The location of a place dispensing medically approved marijuana obviously raises social concerns quite different from those relevant to determining whether a particular location should be used as a barber's shop or a newsagent's...Are there to be restrictions on who can be employed in the facility?

Are there any rules, federal, provincial or city, regulating the opening hours of such an establishment? or the ages of persons who may patronize it if it were to be licensed to operate in the area? What is the location of the nearest other medical marijuana use operation? Have the local police forces, city, regional and federal, been consulted about the locations of such facilities? Are those licensed to dispense marijuana prescriptions or to own or operate such facilities subject to criminal record checks or tender any other form of proof of good character? We are Point Grey homeowners and are writing to register our opposition to the proposed "Medical Marijuana" application for 4545 West 10th Avenue.

We put "medical marijuana" in quotes because the City of Vancouver is permitting something that is both unlawful and being grossly abused. Rather than enforcing the criminal laws against the sale of marijuana, the City has decided to try to licence the activity. Not only is this contrary to the law and ultra vires the City's powers, it is bad policy. This is not harm reduction, like what has been attempted with safe injection sites, this is the City trying to legalise marijuana with no clear let alone compelling reason. That is something only the Federal Government can do through amendments to our criminal and drug laws.

In addition to the legal and policy issues, if the City is intent on continuing down this path, then the application should be denied as not in keeping with the character and use of Point Grey. I just became aware that there is a proposal to the City of Vancouver to open up a medical marijuana dispensary at 4545 West 10th Avenue. I was informed that I should contact you to address my concerns.

I strongly protest this proposal, for the reasons depicted below. I understand that any proposed site for medical marijuana cannot be within 300 meters of a school or a community center, areas with many children activities. The above proposed site, although meetings this requirement, is very close to areas with many children activities.

Specifically, the West Point Grey Branch of the Vancouver Public Library, merely a stone throw away from this proposed site, is 5.22(1) to check out books or to attend the weekly store times led by a library staff. Perhaps due to the timing of my visit, whenever I visit the library branch, either during a week day or weekend, I always see a number of mothers with young children visiting the library doing pretty much what I am doing. While in the area visiting the library, I often take 5.22(1) located at 4545 West 10th Avenue, the same building complex as the proposed site.

Across the street from the proposed site is a Kim's Market, a fruit and produce store; right next to the proposed site is a Safeway store. Twice per month during the summer, after the Sunday morning service, many families attending the West Point Grey Baptist Church would stop by at either Kim's Market or Safeway (or both) to get some lunch and fruit and then head over to the nearby Trimble Park to have picnic lunch. The proposed site would be right in the middle and children and families must walk right by it.

Every summer, around July 1st, there is a "Point Grey Days" on 10th Avenue around the proposed site; a parade on that day attracts the participation of many children and families. The proposed site would be right in the middle of all these activities.

While I personally do not have a negative view or feeling about medical marijuana or the people using it, I do not want my own child, or children in my community, exposed to the scenes of people in and out of this

marijuana dispensary. The policy of not allowing such clinics located within 300 meters of schools and community centers testifies to the fact that a place like this should not be near where children and families abound.

We heard the development application for a Medical Marijuana-related shop at 4545 West 10th Avenue from some parents of 5.22(1) Also living close to West 10th Ave, we never received any notification from the city regarding this proposal, which is so important to us as we have elementary school aged children who frequent West 10th for many activities. We are writing to express our strong concern.

First of all, we believe it is not in our children's best interests to have a shop selling marijuana in this neighbourhood, where we have pre-schools, elementary schools, high schools and many venues for after school activities.

Please consider the proximity of the proposed shop to children's activities and services. The West Point Grey Branch of Vancouver Public Library where children frequently go to on their own, is less than 80 meters away from the proposed shop. The library offers story time for pre-schoolers, summer reading camps for elementary school students and a reading club for teens. It's a gathering place for many kids and youth in the neighbourhood. The eastbound bus stop is right in front of the library. The customers who come to buy marijuana in the future would have to wait in front of the library to take their busses home. Children in the neighbourhood also frequent the toy store Kaboodles at 4449 West 10th Ave, less than 180 meters from the proposed marijuana shop. With opening hours from 10 am to 10pm, the proposed store would force many children to be exposed to marijuana and its related problems.

Secondly, please consider the large number of young undergraduates in UBC who come from all over Canada and from around the world, and are also vulnerable to drug exposure. I don't understand why they should be tempted by this marijuana dispensary when they are already adjusting to so much newness in their lives and it is already such a challenge for them.

Please take all these things into consideration when looking at this proposal. My family and I are very much opposed to this dispensary proposal.

I am writing in opposition to the establishment of the proposed marijuana shop at 4545 West 10th Avenue. I am concerned about this proposal on several levels:

- 1. Very near to the proposed pot shop:
- a. There are a number of primary schools (Queen Mary, West Point Grey Academy and Our Lady of Perpetual Help). Children at a vulnerable age will be passing in front of the proposed pot shop.
- b. There is a playground at Trimble and West 8th where youth and children play.
- c. There is a public library almost across the street from the proposed marijuana shop where there are storytelling and reading programs for children.
- d. There is a toy shop named Kaboodles to the proposed pot shop where children go.
- e. The proposed pot shop will be closest to the primary school children of Jules Quesnel and the youth of Lord Byng high school.
- f. There are a few Marshal Arts too nearby where youth and children go for lessons.

West Point Grey is certainly not a very appropriate location.

2. The pot shop's operating hours of 10am to 10pm will create a very negative social environment in the area where I live.

In addition to the above arguments against the proposal I have some general remarks to make:

- 3. There are about 200 marijuana "dispensaries" operating under a grey area in Canada, mostly in the west. More of them are sprouting up since the Liberal government's election promise to legalize marijuana possession. I think our City should take the lead to wait until the federal government provides concrete details of the legislation.
- 4. Our City should take the lead to follow the <u>Cannabis Policy Framework</u> recommended by the <u>Centre for Addiction and Mental Health</u>. I do not see anywhere the City has taken any steps to subject the current development proposal to CAMH's recommendations.
- There should be a government monopoly on sale of marijuana. It should be tested in clinical trials, packaged in measurable doses, sold in pharmacies under medical prescription.

Thank you very much for considering the above points before making the final decision. I hope I am not too late to make this presentation.

 frequently monitoring these new businesses for any infractions.

I am writing to you in response to your notification regarding the above-mentioned development application for the change of use from Barber Shop to Medical Marijuana-Related Use. As a resident of West 9th Avenue, immediately behind the proposed location, I have serious concerns about the City's ability to properly regulate what is currently an illegal business.

The Point Grey Village is a family-focused area and my assumption is that the proposed business owner(s) are keen to move into the neighbourhood in order to benefit from the numerous UBC students who shop at our local Safeway and more importantly use the 99 B-Line to get to school and there is a stop just steps away from the proposed location.

We have two elementary schools in the vicinity (Queen Mary – only 800 m away, Jules Quesnel and the WPGA Junior School), in addition we have two high schools (WPGA and Lord Byng) in the area. We are already aware of the Kitsilano High School student who was rushed to Children's after buying pot at a so-called medical marijuana dispensary on West 4th.

The dangers of pot to young people are well-documented. Neither the City nor the Vancouver Police appear to be addressing the risks posed to young people. Let alone the ability to detect people driving under the influence.

My questions and concerns are numerous:

- 1. Why are the business hours 12 hours per day, 7 days a week? This seems excessive. Their hours should be reflective of what is typical in the neighbourhood.
- 2. Background checks? Can we be assured that the operators have NO criminal ties or criminal record(s)? This has not always been the case in Vancouver.
- 3. Product selection baked goods etc...that are appealing to children. Will these be permitted?
- 4. ID checks in liquor stores the staff are well trained to ask for ID for anyone under the age of 25. Is the same standard being enforced? How is this policed?

 Prescriptions – do they actually have ON SITE medical professionals or is this a situation wherein "prescriptions" are provided over Skype/fax? If they don't, then it can hardly qualify as a proper medical prescription. I can't get my own Doctor to refill a prescription without an IN PERSON appointment.

My objections are as follows:

1. This is a family friendly shopping precinct, with a Safeway, vet, and other small shops in the complex. Elementary and high school students often make their way to this complex during their lunch break and after school. A Marijuana facility would be entirely incompatible with the current uses and patronage of this complex.

The very existence of such a shop in their neighbourhood condones the use of pot for local children. My research tells me that Marijuana is far from a harmless drug, and I am certainly not in favour of it's being normalized and commodified for local children in my neighbourhood. The very name of the Applicant, "Wealthshop Social Society", suggests that the intended use of the pot they sell is more social and recreational than medicinal.

2.
