If the attached story is correct, please change the bylaws to not permit the developer to have the Development Cost Levies waived under these conditions. DCLs should not be eligible to be waived unless we are talking about truly affordable rents. The City's definition of what is an affordable rent (even for profit) is absurd and one of the primary reasons for the housing crisis we find ourselves in.

"According to the report, the proposed starting rates are lower than the maximum set by the city for developers of "for-profit affordable rental housing" in order for them to qualify for a waiver from paying development cost levy (DCL).

For this project, the developer is asking the city to waive DCLs of \$485,568.

If approved, the application would contribute 23 additional secured for-profit affordable rental housing units to the City's affordable housing goals as identified in the Housing Vancouver Strategy," Haid wrote.

Haid noted that pegging the starting rents "below the maximum rents outline for For-Profit Affordable Rental Housing in the DCL By-Law" provides "greater affordability compared to starting market rental rates".

With all due respect to the City planner, a few dollars under a sky-high rent can hardly be considered affordable. This just demonstrates how important it was to get corporation money out of the political process.

The planning department and Council need to set rent levels that are truly affordable and waive DCLs only at those reduced levels.

On behalf of the Expedia Group family of brands, including vacation rental leaders HomeAway and VRBO, I write to formally follow up on our conversation on March 6, 2018 and thank the City of Vancouver for its interest in Expedia's assistance in implementing its bylaws related to short-term rentals (STR). While Expedia opposes the bylaws in their current form, we are pleased to offer some systems that will help Vancouver's homeowners remain compliant with the city's regulations.

We were disappointed to see the City of Vancouver ban traditional vacation rentals, which have been part of the city's tourism and residential ecosystem for generations. For nearly three decades, Expedia Group platforms have allowed families to experience the comforts of home while enjoying an authentically "Vancouver" experience. Vacation rentals bring tourists out of the Downtown core and into Vancouver's vibrant neighborhoods. They make Vancouver an affordable option for traveling families: the typical traveler using HomeAway is a 50-year-old woman traveling with a family group of four or more—a family that would likely find comparable hotel accommodations unaffordable.

Vacation rentals support much more than the tourism and hospitality sector. Together, families can cook for each other, have a yard for their children, and welcome generations of loved ones under one roof.

In fact, more than half of HomeAway's vacation rental homeowners can cover three quarters of their mortgage by renting their home to travelers.



We look forward to working with the City of Vancouver to keep Vancouver's lodging economy and housing market moving forward together. With that in mind, Expedia is able to offer the following assistance to homeowners and property managers using our rental platforms in the City of Vancouver:

- As part of the process of creating a new listing on Expedia platforms, homeowners and property managers will be prompted to enter a short-term rental license number issued to them by the City of Vancouver through the city's registration process.
- If a homeowner or property manager does not have a short-term rental license number for the property being listed, they will be offered information on the City's bylaws and links to the city's STR registration page.
- Regardless of which option they choose, all users creating new listings will see a brief description of the City's requirements for STR advertisements.
- Users with existing listings will be notified through electronic communications of the City's requirements, and Expedia will work with the City to explore other ways of educating STR operators regarding the new bylaws.

We believe that these measures will be valuable to the Expedia/HomeAway owner community and City regulators alike. This good faith effort is part of what we hope to be a long-term conversation with the Council and city staff toward bylaws that ensure a high rate of compliance while maintaining a diverse and equitable lodging economy in the City of Vancouver.
