Hi everyone – thanks for your participation in the 312 Main Advisory Committee. To those of you I haven't met yet, nice to meet you virtually. Your committee hasn't met for a few months so I wanted to provide you with a brief update on recent activities at 312 Main:

- 1. The Province of BC will be hosting a media event at 312 Main this Friday (Oct 5 at 10am) to celebrate the completion of Phase 1 construction, and the \$3.9 M contribution previously received from the Ministry of Tourism, Arts and Culture. You should by now have received an invitation from Province for this event and we looking forward to seeing you there if you are able to attend.
- s.22(1)In the meantime, Kelly Chapman, who had been seconded to the project from Vancity to support operations for the past year, is the interim ED. Kelly brings a wealth of experience in operations and community based projects and we're glad to have her in the interim role. We'll be posting a the 312 Main leadership position soon. Please feel free to reach out to Kelly at the e-mail above if you have any questions.
- 3. As will be mentioned at the press conference on Friday, we're putting the final touches on the Phase 1 construction and moving into Phase 2 construction, which includes completion of the 3rd and 4th floors on the 312 Main side of the building. We expect Phase 2 to be completed in early January.

As 312 Main continues to evolve into a dynamic centre for social and economic innovation we are thankful for your work so far in getting us to this stage. We'll be revisiting the role of the advisory committee in the next couple of months as we move into this next phase of the building's development, and will be reaching out soon. In the meantime, I welcome any questions - please don't hesitate to connect.
