SUBJECT: 10th Avenue Health Precinct Street Improvements – Detailed Design RFP

The purpose of this memo is to inform Council that a Request for Proposals (RFP) is being posted to retain design consultants for the detailed design of the 10th Avenue Health Precinct Street Improvements Project – Phase II. The design consultant will be responsible for the detailed design of 10<sup>th</sup> Ave., from Cambie St. to Willow St., based on conceptual designs approved by Council on May 16, 2017 and endorsed by the Health Precinct Partners (Vancouver Coast Health (VCH), Vancouver General Hospital (VGH), and the Provincial Health Services Authority (PHSA) responsible for the BC Cancer Vancouver Centre and BC Cancer Research Centre (BCCRC)).

The first phase of the project (between Willow St. and Oak St.) has generally been well received. Staff have been closely monitoring results following completion of this first phase of 10<sup>th</sup> Ave. and are working with an Evaluation Committee to assess how the street is functioning. The learnings from this process will feed into the design for the second phase, as well as minor modifications to Phase I works. The Evaluation Committee is comprised of representatives from the Health Precinct Partners and other key stakeholders who had contributed to the design concept, including members of the former Persons with Disabilities Advisory Committee, Seniors' Advisory Committee, and Active Transportation Policy Council.

The detailed design period is expected to be from summer through fall, and construction would begin in early 2020. Staff will continue to work with Health Precinct Partners and other stakeholders on both detailed design and minimizing construction impacts on patients and institutions.
