Notre Dame Regional Secondary School applied for amendments on February 9, 2018 to revise their approved Development Permit (DP) issued in 2008. The original approval included the construction of a grass turf playing field, bleachers and a parking area. The amendments requested to modify the original approval in the following ways:

- Change the grass turf to artificial turf;
- Tree retention or replacement options for the Lombardy Poplars at the west side of the site.
- Reposition the location of the garbage and recycling storage area within the existing/approved parking area; and
- Remove the planned wheelchair ramp, and replace it with an accessible viewing platform.

The City requested Notre Dame to hold community consultation in order to gain official feedback from the neighbourhood on these changes, prior to the City making a final decision on the application. Notre Dame held an open house on April 3, 2019 whereby members of the public were able to speak directly to staff and provide written comments regarding the proposal. This neighbourhood feedback as well as staff's review of the application which took into consideration all applicable Regulations, Policies and Guidelines have been captured and presented to the Director of Planning for consideration. After deliberation the Director of



Planning has decided to elevate this application for review and consideration by the Development Permit Board. In moving this to a Development Permit Board decision it will allow members of the public to speak directly to the Development Permit Board prior to them making a decision. The Development Permit Board date is tentatively scheduled for June 10, 2019. The DP Board decision is final. Approval of development permits is delegated by Council to the Director of Planning (unless otherwise specified by Bylaws) who may refer cases to the D.P. Board.
