Please see the attached memo from Jerry Dobrovolny. A short summary of the memo is as follows:

SUBJECT: 12th Avenue Water Main Replacement: Guelph to Fraser – Full Road Closure

This memo is to inform Mayor and Council that a full road closure of East 12<sup>th</sup> Avenue from Kingsway to Fraser Street will be required this summer to facilitate an emergency water main replacement from Guelph to Fraser Street (Figure 1). Construction is expected to take place from July 2 to August 31, 2019.

Installed in 1906, the section of water main between Guelph and Fraser Street was recently discovered to be in critical condition after a series of leaks occurred over a period of four days this past spring. Waterworks crews conducted a visual inspection of the pipe and confirmed that the main has reached the end of its service life and is in need of urgent replacement (Figure 2).

To replace the main, Engineering staff in the Water Design Branch conducted a thorough review of several alignments, analyzing construction duration, cost, and public impact. The selected alignment ensures the retention of all trees along the corridor while also being the quickest and most cost effective option to construct.

All alignments reviewed required the same amount of work space to facilitate construction safely. Lane widths along this section of 12<sup>th</sup> Avenue are below standard at 2.4 metres, deviating from the typical 3.5 m, leaving very little room in the roadway for the excavated trench, heavy equipment, and materials. Given the nature of this corridor, Engineering staff in the Traffic and Data Management Branch have advised that the safest traffic management plan to facilitate construction is a full road closure from Kingsway to Fraser along 12<sup>th</sup> Avenue.

To limit the duration of the closure, crews will work extended hours to expedite the schedule, keeping the duration of the closure to the summer months.

Due to the emergent nature of this work it should be noted that it was not included in the City's Annual Summer Construction media event, and no information has been communicated to the public as of yet. Public notification letters will be distributed to the community in advance, with a broader announcement to inform the commuting public.
