- □ A Transportation-led Request for Proposals (RFP) for a Seawall capacity analysis and transportation options assessment for West End Waterfront Parks was issued on June 21, 2019.
- □ The RFP focuses on a transportation analysis and was developed and approved by Engineering staff in close collaboration with Park Board staff, all of whom have approved the relevant content.

As per the Park Board report issued on June 28, 2019, the purpose of this memo is to provide Council with an update regarding the key themes and scope of work for the West End Waterfront Masterplan. This project is being co-led by the City and the Vancouver Board of Parks and Recreation, and a report will be distributed to Park Board Commissioners for review and decision prior to the preparation of a Request for Proposals to be distributed to a shortlist of qualified consultants.

A **Request for Expressions of Interest (RFEOI)** for the broader masterplan was issued on Thursday, May 2, 2019, and closed on Tuesday, June 4, 2019, while a separate **Transportation Request for Proposals (RFP)** to conduct a multi-modal transportation analysis along the Seawall and in the area around Morton Park and English Bay Beach Park was issued by the City on June 21, 2019. The diagram on the second page summarizes the overall process and coordination of the Masterplan process.

## Background

The need for a West End Waterfront Masterplan originated in the West End Community Plan (approved 2013). Through the public engagement and development of this Community Plan, a number of key interrelated parks, open space, and transportation policy objectives were included in its Pubic Benefit Strategy (PBS). These included upgrading English Bay Beach and Sunset Beach Parks, improving the Seawall to reduce conflicts and enhance safety, and supporting the conversion of certain roadway spaces to public space. The implementation of

these policy objectives are supported through Community Amenity Contributions (CACs) received through redevelopment occurring in the West End.

To address the complexities and geographic overlap of Park Board and Engineering priorities, and to identify opportunities for an improved transportation system and public realm in implementing the West End Community Plan, the City's Engineering staff have worked with Park Board staff to combine the initial planning work into a single master plan for the West End Waterfront. This process will include the work of both Engineering and Park Board staff to produce a coordinated and efficient approach to planning and design, engagement, and implementation.

### **Study Area and Considerations**

The project study area overlaps a network of parks and road alignments that, in their entirety, make up a total of approximately 95 acres (38 ha). The key components are:

- English Bay Park
- Sunset Beach Park
- Morton Park
- Alexandra Park
- A number of roadways including Beach Avenue, Pacific Street and the foot of Davie Street

These components have been combined into one holistic study area to create a consolidated effort in improving the entire West End waterfront experience for residents and visitors alike. Key project considerations include:

- Park Identity and Functionality
- Neighbourhood Connectivity and Seawall Enhancement
- Coastal Shoreline Habitat Restoration/Ecological Integrity
- Climate Change and Resilience
- Enhancements and Upgrades to Park Services, Facilities and Infrastructure

### **Project Approach**

Given the complexities and geographic overlap of priorities in the West End Community Plan, the Park Board and the City of Vancouver's Engineering Services Department propose to combine the initial planning work on these projects into a single masterplan. This process will be co-led to allow for a consistent planning and design approach for the connected spaces along the waterfront, as well as a more efficient public engagement and implementation process. Staff will keep the Park Board and Council fully informed throughout the process.

Engagement and communication with the public, stakeholders, Park Board, City Council and staff will be critical to ensuring success in developing the masterplan. This project will be informed by robust and inclusive community engagement, tailored to the interests, needs and aspirations of park users, local residents and businesses, as well as Vancouver residents citywide. Stakeholder groups have already been identified for inclusion in this process and include: local residents, seniors, water-based recreation, accessibility advocates, community centres, environmental, transportation, and arts and culture groups, as well as neighbourhood businesses, among others.

#### Scope of Work and Next Steps

The delivery of the work is proposed to occur in the following key strategic phases:

- 1. PHASE 1 LISTEN & LEARN
- 2. PHASE 2 VISION DEVELOPMENT
- 3. PHASE 3 INITIAL CONCEPTS
- 4. PHASE 4 FINAL CONCEPTS AND MASTERPLAN
- 5. FUTURE PHASES

It is anticipated that the masterplan work will begin in December of 2019, will take approximately 20 months to complete, and will be ready to start preparations for Detailed Design for Phase 1 Improvements by spring of 2021.

Upon review and decision on the overall project approach by the Park Board, a Request for Proposals will be sent out to a shortlist of qualified consultants at the beginning of August 2019. It is anticipated that the procurement process will take approximately 2-3 months. An integrated Park Board and City staff team will embark on an evaluation process and report back at key milestones.
