PURPOSE

The purpose of this memo is to share information about a staff review of Council Hosted Annual Events and the development of a policy framework to guide future decisions with respect to these events. This memo also serves as a preliminary report back regarding the March 6, 2019 Council motion asking staff to provide a fulsome analysis of an appropriate annual celebration to recognize 'Vancouver's Birthday'.

BACKGROUND

In January 2007, City Council approved a list of designated National and International Events (Council Hosted Annual Events) to be officially recognized by the City, including:

- International Women's Day March 8
- International Day for the Elimination of Racial Discrimination March 21
- National Aboriginal Day June 21
- Pride Week July/August
- International Day of Disabled Persons December 3
- Lunar New Year January/February
- Diwali Festival of Lights October/November
- Christmas December





The first five events were selected to recognize the five dimensions of diversity, including gender, race, sexual orientation, Indigenous heritage, and disability and the last three events recognized the largest regions of origin of Vancouver's population at the time, including East-Asia, South-Asia, and Europe. Council designated each event with a \$2,000 budget for hosting receptions.

With Council's approval, External Relations and Protocol was mandated to coordinate the annual events with the support of a cross-departmental planning team. Events were recognized in a standard format during Council meetings to ensure equity and full Council participation and generally involved a Mayoral proclamation followed by a small reception in the 3rd floor foyer of City Hall during a Council break.

DISCUSSION

Over time, Council Hosted Annual Events were no longer marked during Council meetings as they were taking time away from Council's regular business and community members were unable to attend due to work schedules. Concurrently, the planning of these events became the sole responsibility of the External Relations & Protocol team as departmental mandates shifted to focus on core services. In addition, Council approved more events without additional budget or staff resourcing, including:

- Black History Month, Eid al-Adha, and World Refugee Day (2011)
- Italian Heritage Month (2018)
- Nowruz (2019)

As a result, the events with high community support and participation continued and increased in size, scope and complexity, while other events that did not have the same level of community support were either discontinued or not marked in any notable form.

To support the ongoing success and equitable recognition of the city's diverse community, City staff are:

- developing a policy framework to guide decision-making,
- evaluating and prioritizing the current events to affirm alignment with the proposed framework, and
- ensuring that resources are in place to support the events annually

It is expected that the draft framework will be presented to Council for consideration in Q2 2020.

To assist with the development of the framework, you are invited to complete a brief survey regarding your experience and participation in the annual events, and the priorities you feel are most important in the hosting of these events. As the official hosts, your feedback is critical for staff to build a policy that reflects Council's values and priorities. To complete the survey, please click on the link at the end of this memo.

As a final note, the drafting of the policy framework is happening concurrent to Council's request to conduct a fulsome analysis on an appropriate annual event to celebrate "Vancouver's Birthday'. Staff recommend that the analysis and recommendations regarding "Vancouver's Birthday" be considered once a new events policy framework has been approved by Council.
