





Hello Bill and Michael,

Thank you for meeting on-site to discuss the patio located at 1109 Hamilton for Elisa restaurant. I appreciate your willingness to work together to address the concerns and issues which I raised on behalf of the City. Perhaps most significant of which is the installation of a structure which encloses and privatizes this public space. The patio program is intended to support businesses and activate the public realm by providing a transitional use between the private business and public open space.

While we continue our process and discussions related to reviewing and modifying the recently installed structure, you asked if an interim approval could be granted. This would allow the Elisa restaurant to support its first year of operation which, as you pointed out, is often the most challenging period.

The City is willing to grant an interim large patio permit for the summer period (ending October 31, 2019) on the following conditions:

- That all necessary fees are paid and insurance documentation is provided.
- That you agree to continue to work with the City to address the issues related to the current structure.
- That you seek all necessary approvals for any modifications associated with the current and or updated design of the patio.
- That should these discussions fail to address the concerns of the City that the patio will be restored to the design which was reviewed and approved by the City as per the license agreement signed by Margaret Wittgens, Director, Public Space and Street Use, on Nov 13, 2018, or that the patio be removed and the Yaletown dock which has been modified by the installation of the current structure be restored to the original condition.
- Extension of the patio permit beyond October 31, 2019 will be granted upon resolution of these issues.
- Additional requirements and obligations may arise through our discussions and it is expected that these too will be addressed.

Regarding the process to date, I am hoping that your team can share the background information that was offered during our site meeting. There seemed to be some misunderstanding regarding process and approvals and I wanted to review the steps and the information provided to your team to see if there are improvements that can be made within our patio review and approval process.






Picture 1: Previously approved patio (Jun 18, 2018)

Elisa Steakhouse (YALETOWN),

I am the resident of a Yaletown building located approximately your recently-opened establishment. Upon my tenancy at this address, I have been affected by not only the visual impact of wood smoke billowing from your establishment, but also the extreme sensual consequences of living next-door to a toxic polluter. Some evenings I look from my balcony into a sea of wood smoke that conceals the view of the entire neighbourhood, the source of which originates from your restaurant (I have photos and videos with which to substantiate this claim).

When exposed to large quantities of wood-burning smoke, I have allergic reactions that need to be medicated. Since you opened business in the middle of a densely populated urban neighbourhood, I have had to take medication daily to subside my symptoms from the actions of your restaurant.

This evening (like many) I went on my balcony and the first thing that wafted into my condo was a steady, overwhelming stream of wood smoke from your restaurant in industrial quantities. It made my eyes water, and flowed into every crevice of my home. I am simply one of the hundreds of residents in the area who succumb to this daily exposure.

I have called Metro Vancouver multiple times (the local emissions regulator) to inquire as to the legalities of your emissions within the City of Vancouver, and was advised they are closely monitoring your actions. They suggested that it was possible for you to install "scrubbers" to minimize the impact of your wood-burning emissions. This has not been done. After this information (and multiple complaints) have been brought to you attention, why do you insist on poisoning your neighbours?

Your emissions have become so disruptive to the neighbourhood It is to the point I cannot have a single window open in my home (on the s.22(1), lest my belongings (especially my clothing), marinate in the acrid smell of your billowing wood smoke chimney. Your blatant disregard to the well-being of the community which you occupy (not to mention the environment) has left me at a loss for words.

There is a solution. You have chosen to ignore it. It is severely affecting your neighbours. Why?

I enjoy the scent of woodsmoke while camping, or while on the slopes of Whistler - because it is minimal and contained. Your restaurant however, is unleashing a cacophony of toxic discharge into the middle of Yaletown, and it leaves me wordless as to why you were granted a business license, and why you continue to choose ignorning suggestions from a municipal emissions specialist in how to minimize your impact.

Burning wood in this capacity carries a concerning carbon footprint. The fact you choose to ignore this significant issue is worrisome.

You are aware that installing scrubbers in your chimney will alleviate this invasive problem in an urban centre. Why do you continue to ignore the advice of regulatory professionals?

Jun 18, 2018 – Site was reviewed by patio program coordinator; previously approved patio was in place (see picture 1).




Picture 1: Previously approved patio (Jun 18, 2018)
