For part one of your request: all responsive records are attached.

*Please note, the figures are estimates made during the outdoor aquatics season by lifeguarding staff that record how many people they think are onsite at 12:00 pm, 3:00 pm and 7:30 pm which are then totaled for the day.


For part two of your request, there are zero drownings recorded for the period requested.
