## City files Notice of Expropriation for the Balmoral and Regent Hotels

On July 25, the City of Vancouver filed an expropriation notice for the Balmoral and Regent Hotels. The Balmoral was closed in June 2017, and the Regent was closed in June 2018, both due to decades of underinvestment and mismanagement by the building owners resulting in structural and life-safety concerns. Through these closures, more than 300 of the City's lowest income tenants needed to be relocated to safer housing.

Filing the expropriation notice is the first step in the expropriation process and is intended to result in the purchase and revitalization of the hotels under public ownership. Prior to filing, the City made an offer to the building owners to purchase both hotels, for a value based on independent appraisals, but the offer was not accepted by the building owners.

Bringing the Balmoral and Regent Hotels into public ownership will protect and provide an opportunity to potentially expand important low-income housing stock in the Downtown Eastside, and provide an opportunity to meet long-standing and larger goals around the replacement of Single Room Occupancy (SRO) hotels with self-contained social housing. The approved *Housing Vancouver Strategy* identified SRO revitalization as a key priority area to improve the living conditions of low-income Vancouverites. Expanding and improving housing for low-income residents also aligns with funding priorities recently identified by both the Provincial and Federal governments.

Vancouver City Council directed staff to explore partnership opportunities with the Provincial and Federal governments for a new revitalization plan and fund focused on private SROs, including the Balmoral and the Regent, and City staff have started those discussions. The City's SRO Revitalization Strategy includes a goal of replacing 50 per cent of the remaining private SROs (approximately 2,000 rooms) with new self-contained social and/or supportive housing over the next 10 years. This would provide urgent affordable, safe and permanent housing options for low-income tenants and those most at-risk of homelessness.







Greetings Jacquie,

As a follow up to Tuesday's monthly check-in call, below are details on the City's expropriation process for the Balmoral and Regent Hotels and opportunities for provincial government partnership. We promised to send you an overview of the request prior to Mayor Robertson sending a letter to the Minister. Our staff are in discussions with BC Housing about these requests as well.

### SRO Expropriation:

The City of Vancouver announced on July 30, 2018 that we will be pursuing expropriation of two properties on Hastings Street: the Balmoral and Regent Hotels. The potential expropriation presents an opportunity for renovation and/or redevelopment of the properties, <sup>s.13(1), s.17(1)</sup>

The Courts will determine if the City's offer is appropriate. s.13(1), s.17(1)

If the expropriation is successful, the City is prepared to provide the land toward renovation and/or redevelopment of these sites for affordable housing, in partnership with the Province, and as discussed in concept with staff at both the Ministry and BC Housing.
