This is just a quick follow up on what I learned as a result of the request from Ming Pao from Friday re. the Hong Kong protest that took place on Saturday at Broadway City Hall station.

Her question was regarding The permit for the protest issued by the City of Vancouver and, weren we aware that there was potential for 'conflict' at the protest.

(It was a pretty lively gathering which necessitated the closure of Broadway and Cambie for a short while. It was peaceful however, thank goodness. https://vancouversun.com/news/local-news/vancouver-police-to-keep-an-eye-on-competing-rallies-between-hong-kong-and-china-supporters)

The reporter equated the "political expression structure permit" that had been issued by Street Activities as a COV permit for the protest itself. A natural mistake. Street Activities finally confirmed this morning that the permit was for tables, booths etc., containing political info.

When I discussed with Geoff T. in Special Events he was unaware that permits of this kind were being issued and plans to follow up with Street Activities.

I just wanted you to be aware of this, as it likely won't be the last that this type of permit creates the perception that the City has in fact permitted the entire protest. Again, we don't permit protests – they are for the VPD to handle.
