Good afternoon Councillor,

In response to your question below, I can confirm that the business licence held by the BMO branch does not have any conditions beyond the general requirements of the *Licence Bylaw*. Under the *Licence Bylaw* all holders of City of Vancouver Business Licences are required to comply with all municipal, provincial and federal laws. If the Chief Licence Inspector were to receive information that BMO have breached a municipal, provincial or federal law in this situation then that information would be reviewed to determine if any action should be taken against the licence holder. At present the Chief Licence Inspector does not have evidence of such a breach.

The severity, breadth and frequency of the breach, along with community and City resource impacts, are considered for the Chief Licence Inspector to initiate proceedings to suspend or revoke the business licence.

I hope the foregoing information is helpful.
