Im coordinating an installation with MetroVancouver, that will be added on to my trip to Vancouver. Im proposed Friday February 21st or Friday February 28th for Metro Vancouver Installation.

Please find the attached spreadsheet revised by Matthew for the 22 sites in question.

Matthew has established next steps and identified a priority level for each of the issues from what could be determined from past notes and the most recent data files.

Could you please review the priorities levels in the document to make sure that they align with your vision? This will help inform the order in which the counters are visited.

Based on the analysis, we would envision a 5-day s.21(1) maintenance visit in January and a spare parts budget of s.21(1)
