



 - 3,000+ healthcare and social assistance


Businesses in Vancouver

What proportion of your regular rent payment did you manage to pay this month?




84% of renters state they paid 100% of their rent this month, a big increase (+14%) since April.

Only 3% say they did not pay any of their rent in May, a slight decrease (-1%) since April.


...but women, young people, and those with low-income need more help

What proportion of your regular mortgage payment did you manage to pay this month?




70% of homeowners state they paid 100% of their mortgage in May, a slight increase (+2%) since April.

12% say they did not pay any of their mortgage in May, a slight increase (+4%) since April.


Women, seniors, low-income earners, facing most mortgage challenges

More homeowners now say they will pay property taxes


What proportion of your property tax do you intend to pay to the City of Vancouver this year?




78% of homeowners intend to pay their full property tax, a big increase (+13%) from April.

...but revenue worries remain for the city

22% say they will pay none or only some of their property taxes, resulting in a potential estimated loss of \$121 million.






When added to COVID-19 revenue losses of between \$110 - \$189 million, the City of Vancouver could see a revenue shortfall of between \$231 - \$310 million.




On a personal basis, when will you feel comfortable enough to visit each of the following venues in Vancouver?



Women less comfortable without regular cleaning & distancing


On a personal basis, when will you feel comfortable enough to visit each of the following venues in Vancouver?



Takeaways for City of Vancouver

- 1. Work with businesses to implement re-opening plans quickly...
- 2. ...but ensure plans are women & senior friendly
- 3. Begin working on medium- and long-term plans to support women and seniors
- 4. Partner with senior government to build more rental housing, especially at the low end of market

Takeaways for Federal & Provincial government

- 1. Extend and expand relief programs with a renewed focus on women, seniors, and renters
- 2. Prioritize women's return to workforce
- 3. Support local governments with direct financial aid for operations
- 4. Provide more local economic and job data to local governments to inform recovery work (pilot underway)

Takeaways for businesses

- 1. Make customers, especially women, aware of your regular cleaning protocols and strong physical distancing measures
- 2. Expand "seniors-only" hours
- 3. Only a maximum of 40-70% of previous client base may be available without a vaccine
