As you may have heard previously, that the Canadian military has activated key locations for domestic deployment and the SP base is one of those locations.

I have been in contact with staff from the base and they have informed me that for the next month there will be an increase in staff, contractors and suppliers requiring access to the base. However increased military presence is expected for the foreseeable future.

In the event that a non-branded vehicle or a person in uniform requires access, the vehicle will be using a military placard located in the lower driver side dash to identify the vehicle.

An image of the placard will be provided later today. Military ID may also be presented, with the understanding of not rolling down their window or face to face contact.

The access will be 24/7 at this time it is unclear the volume and types of vehicles access. It should be noted that the base may in an event require access to Stanley Park Cause via the gated on ramp close to the Lions Gate Bridge.

I did outline to the base our intentions for the closure to non-stakeholders vehicles and that there is potential for the roadway to be shared with pedestrian and cyclists.

As you will see below, Rich Cornelissen has forwarded your message on the Vancouver - FOI 2020-420 - Page 1 of 2377

I am the Real Property Custodian for all DND property located within Mainland BC, As such I am also the Technical and Contracting Authority for all civilian contractors who perform maintenance and construction work on those same sites.

At this time DND has assumed the posture of not interfering with the conduct of business by Industry, insofar as work on our bases and installation is concerned, so long as that work is deemed necessary for the preservation of DND® infrastructure capability.

Accordingly, there are current projects, and regular maintenance activities, in progress on the grounds of Deadman's Island (HMCS DISCOVERY) that have been deemed as necessary by my office. In addition, we employ a Facilities Maintenance Contractor for the entire facility who, in turn, will occasionally contract out sub trades work for that site. The very same declaration of necessity applies to those contractors as well.

I am therefore notifying the Vancouver Parks Board with this email that DND will require continuing unfettered access to our facility through the Stanley Park Road network for all DND personnel, DND plated vehicles and for those personnel and vehicles belonging to our contractors and related sub-contractors.

In order to facilitate ease of passage through any roadblocks I am preparing a letter for use by all contractors that will be distributed to them through Defence Construction Canada, that I am hopeful will meet the needs of Vancouver Parks Board in determining the authority for any individual civilian contractors to bypass any access road blocks into Stanley Park.

I would be very appreciative of cooperation with DND by the Parks Board and any City of Vancouver employees in continuing to permit both military and civilian DND members as well as our contractors to bypass any road closures in order to access our facility by presentation to those in authority at the road blocks of either: a DND ID card; or a copy of the letter signed by myself.

I ask that you please also note the following and advise any City or Parks Board staff: due to COVID-19 and the protective posture that DND has adopted for our members, DND ID cards are now universally valid beyond their printed expiry date and will remain so until the expiration of the current pandemic emergency.

I wouldn't be surprised if all forms of travel are down in Stanley Park, (and maybe cycling on the loop versus the seawall is already up and therefore not counted?) but it will be interesting to know.

This is collecting my thoughts more than anything, but I think we're trying to do a few things whether it's in the Park or on Beach:

-Reduce potential for crowding by discouraging folks from making long distance trips (close parking lots, on street parking, reduce MV access)

-Provide more space for the 50-100k folks stuck at home who have these locations as their "neighbourhood parks" and are having a hard time finding a place to walk or cycle for mental and physical health at a distance -Do what we can to spread people out who do end up on the Seawall, since closing the Seawall would be City of Vancouver - FOI 2020-420 - Page 42 of 2377 counter-productive and contrary to provincial guidance (but whether we officially tell people to walk on the closed roadway or the bike path, they will, and it will help)

-Creating a nice wide place for people to ride laps of the park while maintaining space is very helpful too, but it's almost a side-effect of the others

A memorial service is scheduled for June 4th, 2020, at 1100 hours, at HMCS Discovery, in Stanley Park. Time frame including set up and tear down is from 7:30am to 2pm

Attendees at the Memorial

It is anticipated that approximately 70 family, close friends and come and come and come and come and the memory of the memory o

Discovery

- Vehicle parking for these attendees will be provided at HMCS Discovery

- The bulk of memorial attendees will arrive between 10:00am and 10:45am; however, people responsible for setting up and performing at the service will likely begin arriving as early as 7:30am (exact numbers to be determined)

Honor Guard

- The second and larger group of participants will be first responders (police, fire, ambulance, other) from other surrounding municipalities that will park on Park Drive immediately after the entrance to HMCS Discovery

- It is anticipated that there could be up to 200 vehicles in this category

- These participants will experience the memorial via live stream, and when the family motorcade exits HMCS Discovery, will stand outside their vehicles and salute Constable Da Silva^B family

Once the memorial is completed at approximately 12:30/12:45pm, the family motorcade will depart HMCS Discovery and be saluted by the Honor Guard as noted above. Once this step has been completed, all vehicles will exit Stanley Park using Pipeline Road (there will be no reception activities given the current COVID-19 environment).

As noted during our conversation, VPD will be providing escort and traffic management support, and all participants and vehicles associated with the memorial will be receiving an accreditation pass from the VPD to proceed through the current checkpoints.

Traffic and Stakeholder Considerations

- During the procession, VPD will hold traffic at Lower Avison Way and close Pipeline Road until the motorcade clears.





Stanley Park Road Closure Program | OUTLINE OF OPERATIONS

Purpose: To reduce the amount of people coming to the park and enable people to better physically distance along the seawall, by providing more space for cyclists and pedestrians

Closures: Road closures in Stanley Park include Stanley Park Drive, and all access roads and parking lots connected to it. The following roads will remain open to all traffic:

- The causeway (HWY 99)
- The Georgia street exit (northbound toward the roundabout)
- Park Lane
- West End Neighborhood streets
- South Lagoon Drive and a small segment of Stanley Park Drive near the Stanley Park Brewery will be open to local traffic only



Some exceptions will be made for Emergency Services, Government Agencies, Operations and Park tenants (and their contractors and delivery trucks). **Checkpoint Staff to ensure that <u>all drivers</u> entering the park:**


- 1. Put on hazard lights (or flashers)
- 2. Maintain a speed no greater than 15km per hour (max)
- 3. Yield to, and look out for, cyclists Stanley Park Drive is now dedicated for cyclists to enable social distancing
- 4. Stay to the left hand side of Stanley Park Drive
- 5. Obey all existing and temporary traffic symbols and signage

You may already be aware by now, but just thought I should circle back and report that upon further review on site with the Rangers (Sunday and Monday), we agreed that two features down the descent of Prospect Point, seemed adequate to slow cyclists down (instead of three as noted previously). Copied on the map below are the locations where they are ended up in the end, and they seem to be having an impact.

Here are some pictures of this, and here at these links are a couple of videos of Station 1 and Station 2. As you can see from Station 1, the Rangers added a "SLOW" sign and barrier in advance of the check point which seemed to work better. I recommend that we put that in for Station 2.



As mentioned, we can discuss further tomorrow and will review this with traffic engineering and the Active Transportation group at the City. We understand that this is currently occupying a total of four rangers (two per station). Measures to reduce this should be discussed as well.







CREEKSIDE

Are street vendors allowed ? Food carts at Spyglass place brought people together. Food carts at Giant Sparrows had lineups of people from 12-2.

Pathways were narrow at times but cyclists and pedestrians were fairly respectful of individuals space. Cooper's Park could use new caution tape on playground. Most was pulled down. Nobody playing there. Cooper's off leash dog park was busy. Most owners respecting distance.

Hinge park busy but groups were small and respected distance. Dog park by hinge was locked still.

Science world was busy but no large groups... Most people resting and passing through.

Playgrounds used as fitness areas. Most people brought their own equipment, But one had to be asked to stop

using the playground apparatus for fitness.

4 signs were knocked over and replaced.

Mostly positive feedback from the public. Not really any complaints.

STANLEY PARK

This is what a biker sees coming down the cardero bike path. They just go around the barrier. So the back entrance for cars to parks head office parking lot is still open... there should be signage there. Fence at Brockton Park/Oval has been knocked down, there were folks playing rugby inside. We asked them to leave and they seem to be, but it would be great to get the fence repaired/some signage Pretty good day. A couple of roller bladers on the sea wall saying they didnnt know they were supposed to be up on the road. People were asking if they were allowed to park along Park Lane. If they arennt we should put up signs. Most people were happy to see us out and about.

SUNSET BEACH

Redirected 20 cyclists between the aquatic centre and burrard bridge; apparently cyclists are going around the signs at the roundabout after Granville bridge towards English bay. Needs barriers. They keep coming it doesnipt stop.

We spent some energy today repurposing and moving some signage to divert bikes from the Hornby entrance to the sea wall and back up to Beach Avenue. This was a main entry point for cyclists to get on the sea wall. More signage needs to be posted to detour bikes at that point. It might be worth having a couple of us posted there. There are also other entry points for bikes that require some signage (by VAC, Cardero and Beach Ave...etc.) Had a few complaints regarding people taking up too much space on the seawall/sidewalk ie- not walking single file when around others, walking 4 people across the seawall path, etc.

Opening up the seawall bike path for public to walk has really helped.

ENGLISH BAY / SUNSET:

People were happy today. Friendly and Very appreciative of us being here.

Super happy with bikes being on the road. People loved jeremy and Jens rope sign¥u10084 ?

Still confusion about dollar bladers. Roller bladers were still on sea wall in the morning - people were complaining they were going too fast and felt unsafe.

We/people feel it would be beneficial if there were signs or arrows on the ground to state a direction - or seperate walkers and joggers (walkers on the pedestrian path and joggers on the bike path).

People would like to see more Bingle file? with walkers.

Some of the signs still say 1-2 meter.

Until there is better signage there needs to be champions between burrard street bridge and hornby st to redirect the cyclist.

Park ranger stopped us to clarify exactly what our role is as champions?

People are complaining that the bikers are toooooo fast on the road. They are faster than the car speed limit.

Granville and king horn (under Granville bridge. Beach ave detour ends. And they all want to come down on to the sea wall. Going south. Direction is to have they still be on the street correct?





Thanks for the note and good points/learnings to consider. I probably should have clarified that these would be for only a small segment of Park Drive in a high traffic area (where separation of uses is very important) – so perhaps just between the roundabout and Avison way (for example). And this would only be for the summer months (and weeding would be much less a requirement because people can live with weeds for a short period of time).

Alternatively, these could be used as the barriers between car zones and non-car zones (i.e. where cars are forced to turn left before Brockton Point) to filter bikes through which would provide more space for maintenance. We are just looking for ways to improve the "public realm" a bit to make this a bit more comfortable and inviting wherever possible. The main driver at this point will be the cost. We are always open to other ideas though. Have you guys seen Toronto's temporary greenway? I think we should re-evaluate on Tuesday with Engineering and VPD. I believe 15km/hr was the right number to start with while people adjust, while we observe and while we get more measures in place. Moving forward, the main question is – are we planning on enforcing this? If so, then 15 km/hr might actually be too slow, because they will be ticketing everyone. For reference, when we were filming you in the video today, I was driving approx 17 to 20 km/hr and you guys were hardly peddling and tailing right behind us.

In my ideal world, if we are planning on enforcing speed limits (clocking them at the station gates down Prospect point hill, ticketing, etc) we should set the limit of 20km/hr for bikes as well as 20 km/hr for all drivers as well (this is a key concern of mine, as I've seen a few vehicles from stakeholders that are driving way too fast, including one that tail gated me and then blew past me up Pipeline road – I will definitely work with Tim to send a notice to all stakeholders notice reminding them of the rules of the road). Then you could just cover all the signs (easiest way from a regulatory perspective) is to cover all 30km/hr signs with garbage bags and put signs along the road edge.
