

Stanley Park will be closed to all vehicle traffic at the following entry points (will provide map):

- Stanley Park Dr @ Georgia St N exit (recommend to allow vehicles into the round-about with barricades at Stanley Park Dr., Pipeline Road & N Lagoon Dr.) Confirm with operations/commercial operations on whether we should keep Pipeline road open to "local" traffic only (PB operations, stakeholders, etc). In follow up to our workshop discussion on Thursday morning, please find attached notes that summarize the options as discussed, Park Board senior leadership team preferred option and feedback, as well as a summary of the issues that we identified last week that will need further exploration, and next steps. I will continue to chase down some more answers, and well start work on an updated traffic management plan that takes all of these issues into account.

Please also find the presentation that I gave to SLT for reference, which has been saved on your server in the West End Waterfront MP project folder (this is the only folder on your server that I have access to 25am, please feel free to move this as needed). Please note that I have included the rough order of magnitude cost for each option but deleted the cost breakdown from this copy for confidentiality reasons, but please let me know if you need any info on that. Please share this and the attached summary up to your managers as you see fit.

I will set up another meeting for us to touch base again and go through some more details as we develop an updated traffic management plan. On another but higher level note, I was also hoping to have a broader dialogue (perhaps with Managers and Directors between our two departments) to confirm how the decisions we make for this temporary road reallocation through the summer, will impact, positively or negatively on the potential of a Dar-free Stanley park in the future (which is the work being done for our Transportation Study as part of the Comprehensive Plan). Our Stanley Park team has some concern about making sure we are strategically doing the right thing and how that might impact attitudes and behaviors in the future. As you have significant experience in this realm shifting attitudes from car focused to cycling prioritized policies, I thought you might be willing to share your thoughts and insights on this. I was thinking just one hour and will have prepared some specific questions. Would you guys be on board with this?

Yes, please, let's keep the conversation going. I haven't had a chance to process all of this, but see references to you needing to advance things tomorrow. So many of my earlier questions are still swirling, but some thoughts and requests:

- Allowing folks to escape to the seawall bike path is unfortunately a necessary part of a laned approach, my ride this afternoon included two times within a minute where someone just stopped cold in front of me and their companions blocked basically the whole curb lane
- But we also can fall back to everyone who would normally have been riding on the seawall is on the seawall, anyone who would normally want to be in mixed traffic can be on the drive. Several problems: the whole point of this was to space people out on the seawall, while the seawall bike path is notoriously packed in the summer (quite possibly would be more packed in this summer) and also very narrow in portions we by passing after folks entering the park have a long stretch of the entire roadway. In other words, we more people than usual to ride, but then trying to squeeze them all back into the narrow stretch.



Thanks for sharing your presentation. On top of the questions and concerns raised by Brian below and more so toward your higher-level note, I think we do need to give this some strategic thought in terms of implications for longer-term aspirations.

Im imagine a laned approach will compel more folks to want to be back cycling on the Seawall. Beyond the shorter-term implications of this reducing the physical separation opportunities both on the Seawall and the laned facility, in the longer term we may have a situation where we have both a laned-facility and a seawall facility. On the surface, this would seem desirable, but I do wonder if that positions the longer-term effectively car-free vision to be more challenging to achieve, given the perception that cyclists will already have their share of space, whereas in the past the lack of space may have been one of the most physically tangible reasons (among other benefits) to reduce vehicles in the park. All of this to say, there are likely ways to mitigate this and additional options to investigate.

Do we have a clearer understanding of the timelines for Stanley Park interim? It sounds like we may have limited opportunity to unpack the above, and will have to work with what happens on the ground in our longer-term conversations. More immediately, are you thinking the 1 hour session would include (managers/directors)?. I think this would be good if it's kept at a higher-level and has specific questions. Did you want us to input into that first?

As Sam also noted, it would be great to continue this discussion as part of WEWP as well.

Yes, please, let's keep the conversation going. I haven't had a chance to process all of this, but see references to you needing to advance things tomorrow. So many of my earlier questions are still swirling, but some thoughts and requests:







HOURLY AVERAGES (BY COUNTER LOCATION)






#### CYCLISTS IN STANLEY PARK

Hi Mandy,

I just forwarded you the email from Brian. We should have a conversation about your time/interest to work on this. Are around today for a quick chat?

Regarding your concerns with the seawall reopening, I understand where you de coming from for sure. Would you be able to schedule a chat with Amy, Alan and I to discuss this? With their experience and work on the cycling plan, they should be a part of the conversation. Priorities have not been fully articulated but should be for the next SLT update (just got a note from Dave asking if we can give them an update next week). The priorities that were noted by SLT, is that we create a balanced approach, supporting physical distancing, but allowing people with mobility needs access key points around the park.

The shuttle idea is a weird one thanks to COVID (West Coast confirmed they would have to limit capacity, which would have a big impact on operations and they think there is a reputational risk there if people are left waiting for the next bus (30-40 mins) as a result, etc. They are all currently waiting for guidelines coming from Transport Canada for the rules on this so maybe that will change things. Anyways, we should add this on our topic of discussion with Amy, Alan and us – if you wanted, to help take this piece on, I would be in support of that! Another thing I'm curious about is – would it be possible to implement a golf cart, or electric scooter, or anything else mobile and interesting, in the park to give people access around the park? I was thinking of one of the bike rental shops or another vendor that might be interested in setting up a temporary use... any ideas on what we can do for next steps?

Good afternoon David, I sent a copy of this email to Mark Tweedie, but have been told since that you are the point person for situations such as these.

Park Board is looking to implement a full closure to Stanley Park, effective Wednesday April 8 2020. Road closures will consist of temporary barricades as well as locked closures with steel gates. In many cases, access will be permitted to Buses, local tenants and service vehicles the combination of temporary barriers and staff at 2 checkpoints. We recognize this will impact and impede your ability to access certain areas of the Park in the event of an emergency.

Attached is a map of our (tentative) closures which we intend to implement by Wednesday morning. We are approaching a finalized version and once it is complete I will send you a copy. In the meantime it would be helpful if you could let us know if any of these areas would impact your operations negatively, especially areas where steel gates are being locked.

To summarize, closed roads will be at the following locations:

- Stanley Park Drive at Pipeline Road roundabout (Barricaded checkpoint day, Locked gate at night) East Entry on to Stanley Park Drive closed/restricted
- Pipeline Road at Stanley Park Service Yard Staff Parking Entry (Barricade. Staff present as a checkpoint during day only) ( A NB road closure to vehicular traffic on Pipeline Road. The SB lane will remain open.
- North Lagoon Drive at Stanley Park Drive (Barricade) (1) Closure of the left turn bay. Restricted to right turns only at Park exit
- 2000 Blk of Beach Avenue at Stanley Park Lane (Barricade) (2) A NB road closure to all vehicular traffic. All vehicles will be detoured NB onto Park Lane
- Park Drive at N Lagoon Dr ( Closed to all SB traffic (Locked Gate). Restricted to left turns only onto N Lagoon.
- Stanley Park Drive at Lagoon Drive (Locked Gate) ⑧ Closed to any SB or NB traffic
- SB access to Stanley Park via Causeway Exit (Locked Gate) Full closure to vehicular traffic.
- NB access to Stanley Park via Causeway Exit (Locked Gate) Full closure to vehicular traffic.
- NB access to Lions Gate Bridge via Stanley Park Exit
   Will remain open for Emergency Vehicle access





However, what they DO have in stock is a barrier CRB. They are shorter so we would need more of them and a bit more expensive at about \$260/barrier. The good thing is that they have about 1500 in stock and have forms to make more. He said they could likely install what we need in about 3-4weeks.

Here the summary of the costs:

Total cost for June Bept with rental of barriers is about \$3M If we purchased the concrete barriers, it would save us \$650K costing about \$2.3M If we are considering keeping this laned approach in the long term, then we should buy them.

I ended up costing the water barriers for the grey lines (where we say concrete) and the non-specific barriers (black lines) are the concrete barriers. We could use only concrete barriers for the entire thing but it might be good to differentiate for certain areas but we could paint the concrete barriers or add something to them instead to save more costs. Regardless, Im sure it will even out as the concrete barriers probably need reflective strips or additional signs on them that aren included in the \$210 cost that can be captured in the water barrier cost.

The installation of the logs is outstanding - \$20K is guess until we hear from ops hopefully tomorrow morning. I can pdf /jpg this in the morning for you as well.



Hi everyone,

In follow up to our workshop discussion on Thursday morning, please find attached notes that summarize the options as discussed, Park Board's senior leadership team's preferred option and feedback, as well as a summary of the issues that we identified last week that will need further exploration, and next steps. I will continue to chase down some more answers, and we'll start work on an updated traffic management plan that takes all of these issues into account.

Please also find the presentation that I gave to SLT for reference, which has been saved on your server in the West End Waterfront MP project folder (this is the only folder on your server that I have access to – Sam, please feel free to move this as needed). Please note that I have included the rough order of magnitude cost for each option but deleted the cost breakdown from this copy for confidentiality reasons, but please let me know if you need any info on that. Please share this and the attached summary up to your managers as you see fit.

I will set up another meeting for us to touch base again and go through some more details as we develop an updated traffic management plan. On another but higher level note, I was also hoping to have a broader dialogue (perhaps with Managers and Directors between our two departments) to confirm how the decisions we make for this temporary road reallocation through the summer, will impact, positively or negatively on the potential of a "car-free" Stanley park in the future (which is the work being done for our Transportation Study as part of the Comprehensive Plan). Our Stanley Park team has some concern about making sure we are strategically doing the right thing and how that might impact attitudes and behaviors in the future. As you have significant experience in this realm shifting attitudes from car focused to cycling prioritized policies, I thought you might be willing to share your thoughts and insights on this. I was thinking just one hour and will have prepared some specific questions. Would you guys be on board with this?

#### General Comments/Discussion

- Overall SLT in support of moving to a "laned approach", noting that the initial "car-free" change in April was able to be made due to COVID pandemic and the related needs for response and physical distancing. However keeping Stanley Park car-free for the summer:
  - It is too extreme of a change. Those needing access by vehicle, which include a variety of users, have sound concerns and this enables them to be heard
  - There are concerns about creating a polarizing stance and discussion that might negatively impact future discussions and planning of Stanley Park's transportation network and car-free potential

- Equity concerns were raised around any ideas related to restricting vehicles and checking for reservations or tickets (essentially forcing people to "pay to use" the park is not aligned with PB values and public interests) plus it adds work for the Rangers at the check points impacting staff time
- Phase 1 (which is leaving things the way they are but allowing the reduced number of patrons expected for the Vancouver Aquarium) to access via Pipeline Road and park in the Train parking lot, can start today until Phase 2. The end of Phase 1/beginning of Phase 2 will need to be timed to align with:
  - Stakeholders opening first: Further engagement needed with the Aquarium, prospect Point and teahouse to create system for monitoring visitation and operational access for the first two weeks of their opening (last two weeks of phase 1)
  - Operations: procuring and purchasing traffic management equipment to make the "laned" option work, will need at least 3-4 weeks
- GM requested further information on cycling lane width, which we have now confirmed will be 3.5 metres wide, but with concrete barriers would leave just over 3.0m for one way cycling traffic

#### Further Considerations (not discussed at SLT)

Some additional challenges and issues needing solutions were not able to be discussed at SLT, due to time (*that are relevant to Phase 2 Option A*) have been summarized below. Additionally, the presentation and SLT feedback was shared with the COV Transportation Planning team at the City on May 21st, and together the following key issues were identified along with recommended directions which need further exploration (to be done soon as possible):

1	Aquarium Traffic: Overall support for closing the eastern side of the Park to "local access only" except access to the Vancouver Aquarium (assuming it increases over the summer)	The road loop to the Aquarium from the roundabout should also be "laned" (see map below)

- 3. Quickly draft up routing and mapping of options above and send or present to SLT for approval
- 4. Continue pursuing the idea with service providers on the possibility of a fair paid electric shuttle service
- 5. Continue drafting Traffic Management Plan for both Phase 1 (Aquarium Access) and Phase 2 (Laned Approach) with solutions selected and mapped out
- 6. Develop operations plans and further refine order of magnitude costing
- 7. Plan for ongoing working group meetings with transportation planning and all PB departments



#### Stanley Park Road Closure Program | OUTLINE OF OPERATIONS

**Purpose:** To reduce the amount of people coming to the park and enable people to better physically distance along the seawall, by providing more space for cyclists and pedestrians

**Closures:** Road closures in Stanley Park include Stanley Park Drive, and all access roads and parking lots connected to it. The following roads will remain open to all traffic:

- The causeway (HWY 99)
- The Georgia street exit (northbound toward the roundabout)
- Park Lane
- West End Neighborhood streets
- South Lagoon Drive and a small segment of Stanley Park Drive near the Stanley Park Brewery will be open to local traffic only



Some exceptions will be made for Emergency Services, Government Agencies, Operations and Park tenants (and their contractors and delivery trucks). **Checkpoint Staff to ensure that <u>all drivers</u> entering the park:** 

- 1. Put on hazard lights (or flashers)
- 2. Maintain a speed no greater than 15km per hour (max)
- 3. Yield to, and look out for, cyclists Stanley Park Drive is now dedicated for cyclists to enable social distancing
- 4. Stay to the left hand side of Stanley Park Drive
- 5. Obey all existing and temporary traffic symbols and signage

The following vehicle access will be permitted to drive in Stanley Park. Stakeholders will be permitted using a pass system based on the Zone they are entering, to limit vehicle traffic through the park as much as possible (enabling people to get in and get out).

This should give us a good idea of where we plan to setup our barriers to entry. All the closures are derived from the information Emily provided on the map. The only additions and subtractions are as follows:

- I did not include was the physical barrier at Dead Man<sup>®</sup> Island. I may have misinterpreted the conversation but it sounds like the idea of two way traffic is being eliminated so I assumed this why this blockade was stationed in this spot.
- I added two barriers at Lagoon Drive that would give motorists guidance out of the Park, as well as prevent WB motorists from entering the Park

I think this is a good working draft that will give us an idea where signage will be needed. It's similar to what I would send to our Traffic Plan Review Dept.



Please review our TMP for the closure of Stanley Park. Traffic Management will affect the following access points:

- Stanley Park Drive at Pipeline Road roundabout → East Entry on to Stanley Park Drive: Road closure to vehicular traffic. Access to local traffic will be maintained (Service vehicles and local tenants only).
- Pipeline Road at Stanley Park Service Yard Staff Parking Entry→A NB road closure to vehicular traffic on Pipeline Road. The SB lane will remain open. Access to local traffic will be maintained (service vehicles and local tenants only). All bus stops and bus routes will be maintained. Any vehicles needing re-routing will use Staff Parking lot to turn around.
- SB access to Stanley Park via Causeway Exit → Full closure to vehicular traffic.
- NB access to Stanley Park via Causeway Exit → Full closure to vehicular traffic.
- NB access to Lions Gate Bridge via Stanley Park Exit→ Full closure to vehicular traffic.
- North Lagoon Drive at Stanley Park Drive → Closure of the left turn bay. Restricted to right turns only at Park exit. Access to local traffic will be maintained (Service vehicles and local tenants only).
- 2000 Blk of Beach Avenue at Stanley Park Lane → A NB road closure to all vehicular traffic. All vehicles will be detoured NB onto Park Lane
- Park Lane at Lagoon Drive → Closed to all WB left turns. Restricted to right turns only.
- **800 Block of Lagoon Drive** → Road closed at Lagoon Drive and Barclay to all WB vehicular traffic. WB traffic restricted to left turns only at Barclay.

Digital reader boards indicating "Stanley Park Closed to Vehicle Traffic" will be placed at the following locations:

- 1800 Block of West Georgia St
- SB on Stanley Park Causeway immediately following the Lions Gate Bridge.
- 1800 Block of Beach Ave

Additional Signage indicating the closure of Stanley Park to vehicle traffic will be posted at the following locations:



#### Stanley Park Road Closure Program | OUTLINE OF OPERATIONS

**Purpose:** To reduce the amount of people coming to the park and enable people to better physically distance along the seawall, by providing more space for cyclists and pedestrians

**Closures:** Road closures in Stanley Park include Stanley Park Drive, and all access roads and parking lots connected to it. The following roads will remain open to all traffic:

- The causeway (HWY 99)
- The Georgia street exit (northbound toward the roundabout)
- Park Lane
- West End Neighborhood streets
- South Lagoon Drive and a small segment of Park Lane near the Stanley Park Brewery will be open to local traffic only



Some exceptions will be made for Emergency Services, Government Agencies, Operations and Park tenants (and their contractors and delivery trucks). **Checkpoint Staff to ensure that <u>all drivers</u> entering the park:** 

- 1. Maintain a speed of 15km per hour (max)
- 2. Put on hazard lights (or flashers)
- 3. Yield to and look out for cyclists Stanley Park Drive is now dedicated for cyclists and pedestrians to enable social distancing
- 4. Stay to the left hand side of Stanley Park Drive to pass
- 5. Obey all existing and temporary traffic symbols and signage



April 9th to May 3rd, 2020






