Re: Request for Access to Records under the Freedom of Information and Protection of Privacy Act (the "Act")

I am responding to your request of August 17, 2020 for:

Records as follows:

- 1) All records relating to the inspection, repair, and maintenance of cracks, potholes or other defects to the section of the road along Penticton Street between Grant Street and Graveley Street (the "Roadway").
- 2) Any complaints regarding cracks, potholes or other defects to the Roadway.
- 3) Road inspection and maintenance or repair policies and procedures.
- 4) Any contracts with companies that provide inspection or maintenance services for the Roadway.

Date range: January 1, 2015 to August 17, 2020.

All responsive records are attached. Some information in the records has been severed, (blacked out), under s.22(1) of the Act. You can read or download this section here: http://www.bclaws.ca/EPLibraries/bclaws new/document/ID/freeside/96165 00.

In response to point three of your request, design specifications for City infrastructure can be found on the City's website. Road infrastructure specifications are specifically found at https://vancouver.ca/streets-transportation/street-design-construction-resources.aspx.

Regarding point four, Engineering staff have informed us that there are no companies that perform those services on behalf of the Street Operations Branch.

Under section 52 of the Act you may ask the Information & Privacy Commissioner to review any matter related to the City's response to your request. The Act allows you 30 business days from the date you receive this notice to request a review by writing to: Office of the Information & Privacy Commissioner, info@oipc.bc.ca or by phoning 250-387-5629.

If you request a review, please provide the Commissioner's office with: 1) the request number assigned to your request (#04-1000-20-2020-449); 2) a copy of this letter; 3) a copy of your original request for information sent to the City of Vancouver; and 4) detailed reasons or grounds on which you are seeking the review.

Request Details

1. Describe details (who, what, where, when, why):

Citizen advised that there are a lot of low lying intersections within the City. She stated that when it rains a flash flood always occurs in the intersection of her neighbourhood. She says that it is a very problematic area. She stated that she spends a lot of time to manually unplug the debris from the trees in the neighbourhood. She stated that she'd like to see the City take more preventative action prior to the rainy season. She suggested that sucker trucks are taken to the low lying intersections within the City and catch basins in these areas are unplugged before the rainy season. She also mentioned that she believes there may be an opportunity to also educate citizens and residents on maintenance of the catch basins. She noted that she has been told that some people in her neighbourhood sweep their leaves into the streets, which is one of the reasons why the catch basins get plugged and the intersection floods. She'd like to see some sort of leaflet or pamphlet with information to residents in the neighbourhood advising them of how they can help prevent floods during rainy season.
